A BILL

To provide for a land exchange involving the Cape Cod National Seashore and to extend the authority for the Cape Cod National Seashore Advisory Commission.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. CAPE COD NATIONAL SEASHORE.**

2 (a) **LAND EXCHANGE AND BOUNDARY ADJUST-**
3 **MENT.**—Section 2 of Public Law 87–126 (16 U.S.C.
4 459b–1) is amended—

5 (1) by redesignating subsection (d) as sub-
6 section (e); and

7 (2) by inserting after subsection (e) the follow-
8 ing new subsection:

9 “(d) The Secretary may convey to the town of
10 Provincetown, Massachusetts, a parcel of real property
11 consisting of approximately 7.62 acres of Federal land
12 within such area in exchange for approximately 11.157
13 acres of land outside of such area, as depicted on the map
14 entitled ‘Cape Cod National Seashore Boundary Revision
15 Map’, dated May, 1997, and numbered 609/80,801, to
16 allow for the establishment of a municipal facility to serve
17 the town. Upon completion of the exchange, the Secretary
18 shall modify the boundaries of the seashore to reflect the
19 land exchange.”.

20 (b) **REAUTHORIZATION OF ADVISORY COMMISSION.**—
21 Section 8(a) of such Act (16 U.S.C. 459b–7(a)) is amend-
22 ed by striking the second sentence and inserting the fol-
23 lowing new sentences: “The Commission shall terminate
24 September 26, 2008. Based upon a recommendation from
25 the Commission and a determination by the Secretary of
26 a continued need for the Commission, the Secretary may

1 delay the termination date for periods of up to 10 years.
2 The Secretary shall provide written notice to Congress of
3 any delay in the termination date, and publish such notice
4 in the Federal Register, not later than 180 days before
5 the date on which the Commission would otherwise termi-
6 nate.”.

7 **SECTION 1. CAPE COD NATIONAL SEASHORE.**

8 (a) *LAND EXCHANGE AND BOUNDARY ADJUSTMENT.*—
9 Section 2 of Public Law 87–126 (16 U.S.C. 459b–1) is
10 amended—

11 (1) by redesignating subsection (d) as subsection
12 (e); and

13 (2) by inserting after subsection (c) the following
14 new subsection:

15 “(d) The Secretary may convey to the town of
16 Provincetown, Massachusetts, a parcel of real property con-
17 sisting of approximately 7.62 acres of Federal land within
18 such area in exchange for approximately 11.157 acres of
19 land outside of such area, as depicted on the map entitled
20 ‘Cape Cod National Seashore Boundary Revision Map’,
21 dated May, 1997, and numbered 609/80,801, to allow for
22 the establishment of a municipal facility to serve the town
23 that is restricted to solid waste transfer and recycling facili-
24 ties and for other municipal activities that are compatible
25 with National Park Service laws and regulations. Upon

1 *completion of the exchange, the Secretary shall modify the*
2 *boundary of the Cape Cod National Seashore to include the*
3 *land that has been added.”.*

4 **(b) REAUTHORIZATION OF ADVISORY COMMISSION.—**
5 *Section 8(a) of such Act (16 U.S.C. 459b–7(a)) is amended*
6 *by striking the second sentence and inserting the following*
7 *new sentence: “The Commission shall terminate September*
8 *26, 2008.”.*
