**AN ACT**

To provide for a land exchange involving the Cape Cod National Seashore and to extend the authority for the Cape Cod National Seashore Advisory Commission.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CAPE COD NATIONAL SEASHORE.**

4 (a) LAND EXCHANGE AND BOUNDARY ADJUST-  
5 MENT.—Section 2 of Public Law 87–126 (16 U.S.C.  
6 459b–1) is amended—

7 (1) by redesignating subsection (d) as sub-  
8 section (e); and

1           (2) by inserting after subsection (c) the follow-  
2           ing new subsection:

3           “(d) The Secretary may convey to the town of  
4 Provincetown, Massachusetts, a parcel of real property  
5 consisting of approximately 7.62 acres of Federal land  
6 within such area in exchange for approximately 11.157  
7 acres of land outside of such area, as depicted on the map  
8 entitled ‘Cape Cod National Seashore Boundary Revision  
9 Map’, dated May, 1997, and numbered 609/80,801, to  
10 allow for the establishment of a municipal facility to serve  
11 the town that is restricted to solid waste transfer and recy-  
12 cling facilities and for other municipal activities that are  
13 compatible with National Park Service laws and regula-  
14 tions. Upon completion of the exchange, the Secretary  
15 shall modify the boundary of the Cape Cod National Sea-  
16 shore to include the land that has been added.”.

17           (b) REAUTHORIZATION OF ADVISORY COMMISSION.—  
18 Section 8(a) of such Act (16 U.S.C. 459b–7(a)) is amend-  
19 ed by striking the second sentence and inserting the fol-  
20 lowing new sentence: “The Commission shall terminate  
21 September 26, 2008.”.
