6 **SEC. 101. PRIORITIES AND MANAGEMENT PRINCIPLES FOR**
7 **FEDERALLY SUPPORTED AND CONDUCTED**
8 **AGRICULTURAL RESEARCH, EDUCATION, AND**
9 **EXTENSION.**

10 *(a) PRIORITY SETTING PROCESS.—Section 1402 of the*
11 *National Agricultural Research, Extension, and Teaching*
12 *Policy Act of 1977 (7 U.S.C. 3101) is amended—*

13 *(1) by inserting “(a) PURPOSES.—” before “The*
14 *purposes”; and*

15 *(2) by adding at the end the following new sub-*
16 *section:*

17 *“(b) PRIORITY SETTING PROCESS.—Consistent with*
18 *subsection (a), the Secretary shall establish priorities for ag-*
19 *ricultural research, extension, and education activities con-*
20 *ducted or funded by the Department. In establishing such*
21 *priorities, the Secretary shall solicit and consider input and*
22 *recommendations from the Advisory Board and persons who*
23 *conduct or use agricultural research, extension, or edu-*
24 *cation.”.*

1 (b) *MANAGEMENT PRINCIPLES*.—Such section is fur-
2 ther amended by adding after subsection (b), as added by
3 subsection (a)(2), the following new subsection:

4 “(c) *MANAGEMENT PRINCIPLES*.—To the maximum
5 extent practicable, the Secretary shall ensure that agricul-
6 tural research, education, and extension activities con-
7 ducted or funded by the Department are accomplished in
8 a manner that—

9 “(1) integrates agricultural research, education,
10 and extension functions to better link research to tech-
11 nology transfer and information dissemination activi-
12 ties;

13 “(2) encourages multi-State and multi-institu-
14 tional programs to address relevant issues of common
15 concern and to better leverage scarce resources; and

16 “(3) achieves agricultural research, education,
17 and extension objectives through multi-institutional
18 and multifunctional approaches and by conducting
19 research at facilities and institutions best equipped to
20 achieve those objectives.”.

21 (c) *CLERICAL AMENDMENT*.—The heading of such sec-
22 tion is amended by inserting “, **PRIORITIES, AND MAN-**
23 **AGEMENT PRINCIPLES**” after “**PURPOSES**”.

1 **SEC. 102. PRINCIPAL DEFINITIONS REGARDING AGRICUL-**
2 **TURAL RESEARCH, EDUCATION, AND EXTEN-**
3 **SION.**

4 (a) *FOOD AND AGRICULTURAL SCIENCES.*—Paragraph
5 (8) of section 1404 of the National Agricultural Research,
6 Extension, and Teaching Policy Act of 1977 (7 U.S.C.
7 3103) is amended to read as follows:

8 “(8) *FOOD AND AGRICULTURAL SCIENCES.*—The
9 term ‘food and agricultural sciences’ means basic, ap-
10 plied, and developmental research, extension, and
11 teaching activities in food and fiber, agricultural, re-
12 newable natural resources, forestry, and physical and
13 social sciences, including (but not limited to) activi-
14 ties relating to the following:

15 “(A) *Animal health, production, and well-*
16 *being.*

17 “(B) *Plant health and production.*

18 “(C) *Animal and plant germ plasm collec-*
19 *tion and preservation.*

20 “(D) *Aquaculture.*

21 “(E) *Food safety.*

22 “(F) *Soil and water conservation and im-*
23 *provement.*

24 “(G) *Forestry, horticulture, and range man-*
25 *agement.*

26 “(H) *Nutritional sciences and promotion.*

1 “(I) *Farm enhancement, including finan-*
2 *cial management, input efficiency, and profit-*
3 *ability.*

4 “(J) *Home economics.*

5 “(K) *Rural human ecology.*

6 “(L) *Youth development and agricultural*
7 *education, including 4–H.*

8 “(M) *Expansion of domestic and inter-*
9 *national markets for agricultural commodities*
10 *and products, including agricultural trade bar-*
11 *rier identification and comprehension.*

12 “(N) *Information management and tech-*
13 *nology transfer related to agriculture.*

14 “(O) *Biotechnology related to agriculture.*”.

15 (b) *REFERENCES TO TEACHING OR EDUCATION.—*
16 *Paragraph (14) of such section is amended by striking “the*
17 *term ‘teaching’ means” and inserting “TEACHING AND EDU-*
18 *CATION.—The terms ‘teaching’ and ‘education’ mean”.*

19 (c) *APPLICATION OF DEFINITIONS TO AGRICULTURAL*
20 *RESEARCH, EXTENSION, AND EDUCATION.—Such section is*
21 *further amended by striking the section heading and all*
22 *that follows through the matter preceding paragraph (1)*
23 *and inserting the following:*

1 **“SEC. 1404. PRINCIPAL DEFINITIONS REGARDING AGRICUL-**
2 **TURAL RESEARCH, EDUCATION, AND EXTEN-**
3 **SION.**

4 *“When used in this title or any other law relating to*
5 *any research, extension, or education activities of the De-*
6 *partment of Agriculture regarding the food and agricultural*
7 *sciences (unless the context requires otherwise):”.*

8 *(d) IN-KIND SUPPORT.—Such section is further*
9 *amended by adding at the end the following new paragraph:*

10 *“(18) IN-KIND SUPPORT.—The term ‘in-kind*
11 *support’, with regard to a requirement that the recip-*
12 *ient of funds provided by the Secretary match all or*
13 *some portion of the amount of the funds, means con-*
14 *tributions such as office space, equipment, and staff*
15 *support.”.*

16 *(e) CONFORMING AMENDMENTS.—Such section is fur-*
17 *ther amended—*

18 *(1) by striking “the term” in paragraphs (1),*
19 *(2), (3), (5), (6), (7), (10) through (13), and (15),*
20 *(16), and (17) and inserting “The term”;*

21 *(2) in paragraph (4), by striking “the terms”*
22 *and inserting “The terms”;*

23 *(3) in paragraph (9), by striking “the term” the*
24 *first place it appears and inserting “The term”;*

1 (4) *by striking the semicolon at the end of para-*
2 *graphs (1) through (7) and (9) through (15) and in-*
3 *serting a period; and*

4 (5) *in paragraph (16)(F), by striking “; and”*
5 *and inserting a period.*

6 **SEC. 103. CONSULTATION WITH NATIONAL AGRICULTURAL**
7 **RESEARCH, EXTENSION, EDUCATION, AND EC-**
8 **ONOMICS ADVISORY BOARD.**

9 *Subsection (d) of section 1408 of the National Agricul-*
10 *tural Research, Extension, and Teaching Policy Act of 1977*
11 *(7 U.S.C. 3123) is amended to read as follows:*

12 “(d) **CONSULTATION.**—

13 “(1) **AS AFFECTING ADVISORY BOARD.**—*In car-*
14 *rying out this section, the Advisory Board shall solicit*
15 *opinions and recommendations from persons who will*
16 *benefit from and use federally funded agricultural re-*
17 *search, extension, education, and economics.*

18 “(2) **AS AFFECTING SECRETARY.**—*To comply*
19 *with a provision of this title or any other law that*
20 *requires the Secretary to consult or cooperate with the*
21 *Advisory Board or that authorizes the Advisory*
22 *Board to submit recommendations to the Secretary,*
23 *the Secretary shall—*

24 “(A) *solicit the written opinions and rec-*
25 *ommendations of the Advisory Board; and*

1 “(B) provide a written response to the Advi-
 2 sory Board regarding the manner and extent to
 3 which the Secretary will implement rec-
 4 ommendations submitted by the Advisory
 5 Board.”.

6 **SEC. 104. RELEVANCE AND MERIT OF FEDERALLY FUNDED**
 7 **AGRICULTURAL RESEARCH, EXTENSION, AND**
 8 **EDUCATION.**

9 (a) *REVIEW OF RELEVANCE AND MERIT.*—Subtitle K
 10 of the National Agricultural Research, Extension, and
 11 Teaching Policy Act of 1977 is amended by inserting before
 12 section 1463 (7 U.S.C. 3311) the following new section:

13 **“SEC. 1461. RELEVANCE AND MERIT OF FEDERALLY FUND-**
 14 **ED AGRICULTURAL RESEARCH, EXTENSION,**
 15 **AND EDUCATION.**

16 “(a) *REVIEW OF COOPERATIVE STATE RESEARCH,*
 17 *EDUCATION, AND EXTENSION SERVICE.*—

18 “(1) *PEER REVIEW OF RESEARCH GRANTS.*—The
 19 Secretary shall establish procedures that provide for
 20 scientific peer review of each agricultural research
 21 grant administered, on a competitive basis, by the Co-
 22 operative State Research, Education, and Extension
 23 Service of the Department.

24 “(2) *MERIT REVIEW OF EXTENSION AND EDU-*
 25 *CATION.*—The Secretary shall establish procedures

1 *that provide for merit review of each agricultural ex-*
2 *ension or education grant administered, on a com-*
3 *petitive basis, by the Cooperative State Research,*
4 *Education, and Extension Service. The Secretary*
5 *shall consult with the Advisory Board in establishing*
6 *such merit review procedures.*

7 *“(b) REQUESTS FOR PROPOSALS: REQUEST AND CON-*
8 *SIDERATION OF INPUT.—When formulating a request for*
9 *proposals involving an agricultural research, extension, or*
10 *education activity to be funded by the Secretary on a com-*
11 *petitive basis, the Secretary shall solicit and consider input*
12 *from the Advisory Board and users of agricultural research,*
13 *extension, and education regarding the request for proposals*
14 *for the preceding year. If an agricultural research, exten-*
15 *sion, or education activity has not been the subject of a pre-*
16 *vious request for proposals, the Secretary shall solicit and*
17 *consider input from the Advisory Board and users of agri-*
18 *cultural research, extension, and education before publica-*
19 *tion of the first request for proposals regarding the activity.*

20 *“(c) SCIENTIFIC PEER REVIEW OF AGRICULTURAL*
21 *RESEARCH.—*

22 *“(1) PEER REVIEW PROCEDURES.—The Sec-*
23 *retary shall establish procedures that ensure scientific*
24 *peer review of all research activities conducted by the*
25 *Department of Agriculture.*

1 “(2) *REVIEW PANEL REQUIRED.*—As part of the
2 *procedures established under paragraph (1), a review*
3 *panel shall verify, at least once every three years, that*
4 *each research activity of the Department and research*
5 *conducted under each research program of the Depart-*
6 *ment have scientific merit and relevance. If the re-*
7 *search activity or program to be reviewed is included*
8 *in the research, educational, and economics mission*
9 *area of the Department, the review panel shall con-*
10 *sider—*

11 “(A) *the scientific merit and relevance of*
12 *the activity or research in light of the priorities*
13 *established pursuant to section 1402(b) ; and*

14 “(B) *the national or multi-State signifi-*
15 *cance of the activity or research.*

16 “(3) *COMPOSITION OF REVIEW PANEL.*—A review
17 *panel shall be composed of individuals with scientific*
18 *expertise, a majority of whom are not employees of*
19 *the agency whose research is being reviewed. To the*
20 *extent possible, the Secretary shall use scientists from*
21 *colleges and universities to serve on the review panels.*

22 “(4) *SUBMISSION OF RESULTS.*—The results of
23 *the panel reviews shall be submitted to the Advisory*
24 *Board.*

1 “(5) *APPLICABILITY OF OTHER LAWS.*—*The Fed-*
2 *eral Advisory Committee Act (5 U.S.C. App.) and*
3 *title XVIII of this Act (7 U.S.C. 2281 et seq.) shall*
4 *not apply to a review panel.*

5 “(d) *MERIT REVIEW OF COLLEGE AND UNIVERSITY*
6 *RESEARCH AND EXTENSION ACTIVITIES.*—

7 “(1) *LAND-GRANT INSTITUTIONS.*—*Effective be-*
8 *ginning October 1, 1998, to be eligible to obtain agri-*
9 *cultural research or extension funds from the Sec-*
10 *retary for an activity, a land-grant college or univer-*
11 *sity shall—*

12 “(A) *establish a process for merit review of*
13 *the activity; and*

14 “(B) *review the activity in accordance with*
15 *the process.*

16 “(2) *1994 INSTITUTIONS.*—*Effective beginning*
17 *October 1, 1998, to obtain agricultural extension*
18 *funds from the Secretary for an activity, each 1994*
19 *Institution (as defined in section 532 of the Equity*
20 *in Educational Land-Grant Status Act of 1994 (Pub-*
21 *lic Law 103–382; 7 U.S.C. 301 note)) shall—*

22 “(A) *establish a process for merit review of*
23 *the activity; and*

24 “(B) *review the activity in accordance with*
25 *the process.”.*

1 (b) *REPEAL OF PROVISIONS FOR WITHHOLDING*
2 *FUNDS.*—

3 (1) *SMITH-LEVER ACT.*—Section 6 of the *Smith-*
4 *Lever Act* (7 U.S.C. 346) is repealed.

5 (2) *HATCH ACT OF 1887.*—Section 7 of the *Hatch*
6 *Act of 1887* (7 U.S.C. 361g) is amended by striking
7 *the last paragraph.*

8 (3) *NATIONAL AGRICULTURAL RESEARCH, EX-*
9 *TENSION, AND TEACHING POLICY ACT OF 1977.*—The
10 *National Agricultural Research, Extension, and*
11 *Teaching Policy Act of 1977* is amended—

12 (A) in section 1444 (7 U.S.C. 3221)—

13 (i) by striking subsection (f); and

14 (ii) by redesignating subsection (g) as
15 subsection (f);

16 (B) in section 1445(g) (7 U.S.C. 3222(g)),
17 by striking paragraph (3); and

18 (C) by striking section 1468 (7 U.S.C.
19 3314).

20 **SEC. 105. EXPANSION OF AUTHORITY TO ENTER INTO COST-**
21 **REIMBURSABLE AGREEMENTS.**

22 Section 1473A of the *National Agricultural Research,*
23 *Extension, and Teaching Policy Act of 1977* (7 U.S.C.
24 3319a) is amended in the first sentence by inserting “or
25 *other colleges and universities*” after “institutions”.

1 **SEC. 106. EVALUATION AND ASSESSMENT OF AGRICUL-**
2 **TURAL RESEARCH, EXTENSION, AND EDU-**
3 **CATION PROGRAMS.**

4 (a) *EVALUATION.*—*The Secretary shall conduct a per-*
5 *formance evaluation to determine whether agricultural re-*
6 *search, extension, and education programs conducted or*
7 *funded by the Department of Agriculture result in public*
8 *benefits that have national or multi-State significance.*

9 (b) *GUIDELINES FOR PERFORMANCE MEASURE-*
10 *MENT.*—*The Secretary shall develop practical guidelines for*
11 *measuring the performance of agricultural research, exten-*
12 *sion and education programs evaluated under subsection*
13 *(a).*

14 **TITLE II—REFORM OF EXISTING**

17 **Subtitle A—Smith-Lever Act and**
18 **Hatch Act of 1887**

19 **SEC. 201. ADOPTION OF SHORT TITLES FOR SMITH-LEVER**
20 **ACT AND HATCH ACT OF 1887.**

21 (a) *SMITH-LEVER ACT.*—*The Act of May 8, 1914*
22 *(commonly known as the Smith-Lever Act; 7 U.S.C. 341*
23 *et seq.), is amended by adding at the end the following new*
24 *section:*

25 **“SEC. 11. SHORT TITLE.**

26 **“This Act may be cited as the ‘Smith-Lever Act’.”**

1 (b) *HATCH ACT OF 1887.*—*The Act of March 2, 1887*
2 *(commonly known as the Hatch Act of 1887; 7 U.S.C. 361a*
3 *et seq.), is amended by adding at the end the following new*
4 *section:*

5 **“SEC. 10. SHORT TITLE.**

6 *“This Act may be cited as the ‘Hatch Act of 1887’.”.*

7 (c) *COORDINATION WITH OTHER AMENDMENTS.*—*For*
8 *purposes of executing amendments made by provisions of*
9 *this Act (other than this section), this section shall be treat-*
10 *ed as having been enacted immediately before the other pro-*
11 *visions of this Act.*

12 **SEC. 202. CONSISTENT MATCHING FUNDS REQUIREMENTS**
13 **UNDER HATCH ACT OF 1887 AND SMITH-**
14 **LEVER ACT.**

15 (a) *HATCH ACT OF 1887.*—*Subsection (d) of section*
16 *3 of the Hatch Act of 1887 (7 U.S.C. 361c) is amended*
17 *to read as follows:*

18 “(d) *MATCHING FUNDS.*—

19 “(1) *REQUIREMENT.*—*Except as provided in*
20 *paragraph (4), no allotment shall be made to a State*
21 *under subsections (b) and (c), and no payments of*
22 *such allotment shall be made to a State, in excess of*
23 *the amount which the State makes available out of*
24 *non-Federal funds for agricultural research and for*

23 *trieval, dissemination and analysis of agricul-*
24 *tural weather and climate information;*

25 “(D) *enhance the quality and availability*
26 *of weather and climate information needed by*

1 *the private sector for value-added products and*
2 *agriculturists for decisionmaking; and*

3 “(E) sponsor joint programs to train pri-
4 *vate sector meteorologists and agriculturists*
5 *about the optimum use of agricultural weather*
6 *and climate data;*

7 “(2) obtain standardized weather observation
8 *data collected in near real time through regional and*
9 *State agricultural weather information systems;*

10 “(3) coordinate the activities of the Chief Mete-
11 *orologist of the Department of Agriculture and weath-*
12 *er and climate research activities of the Department*
13 *of Agriculture with other Federal agencies and the*
14 *private sector;*

15 “(4) make grants to plan and administer State
16 *and regional agricultural weather information sys-*
17 *tems, including research in atmospheric sciences and*
18 *climatology;*

19 “(5) encourage private sector participation in
20 *the System through cooperation with the private sec-*
21 *tor, including cooperation in the generation of weath-*
22 *er and climate data useful for site-specific agricul-*
23 *tural weather forecasting; and*

24 “(6) make competitive grants to carry out re-
25 *search in all aspects of atmospheric sciences and cli-*

1 *matology regarding the collection, retention, and dis-*
 2 *semination of agricultural weather and climate obser-*
 3 *vations and information, with priority given to pro-*
 4 *posals that emphasize—*

5 *“(A) techniques and processes that relate*

6 *to—*

7 *“(i) weather- or climate-induced agri-*
 8 *cultural losses; and*

9 *“(ii) improvement of information on*
 10 *weather and climate extremes (such as*
 11 *drought, floods, freeze, and storms) well in*
 12 *advance of their occurrence;*

13 *“(B) the improvement of site-specific weath-*
 14 *er data collection and forecasting;*

15 *“(C) the impact of weather on economic and*
 16 *environmental costs in agricultural production;*

18 *“(D) the preservation and management of*

20 **“SEC. 1639. FUNDING AND ADMINISTRATION.**

3 “(2) *ADMINISTRATIVE COSTS.*—*The Secretary of*

25 *et seq.) shall not apply to a panel or board created for the*

1 *purpose of reviewing applications or proposals submitted*
2 *for grants under section 1638.*

3 **“SEC. 1640. AUTHORIZATION OF APPROPRIATIONS.**

4 *“There is authorized to be appropriated to carry out*
5 *this subtitle \$15,000,000 for each of the fiscal years 1998*
6 *through 2002.”.*

7 **SEC. 232. AGRICULTURAL GENOME INITIATIVE.**

8 *(a) ESTABLISHMENT AND PURPOSE OF INITIATIVE.—*
9 *Section 1671 of the Food, Agriculture, Conservation, and*
10 *Trade Act of 1990 (7 U.S.C. 5924) is amended by striking*

14 *“(a) PROGRAM REQUIRED.—The Secretary of Agri-*
15 *culture shall conduct a research initiative for the purpose*
16 *of—*

17 *“(1) supporting basic and applied research and*
18 *technology development in the area of genome struc-*
19 *ture and function in support of agriculturally impor-*
20 *tant species, with a particular focus on research*
21 *projects that will yield scientifically important results*
22 *that will enhance the usefulness of many agricultur-*
23 *ally important species;*

1 “(2) *studying and mapping agriculturally sig-*
2 *nificant genes to achieve sustainable and secure agri-*
3 *cultural production;*

4 “(3) *ensuring that current gaps in existing agri-*
5 *cultural genetics knowledge are filled;*

6 “(4) *identifying and developing a functional un-*
7 *derstanding of genes responsible for economically im-*
8 *portant traits in agriculturally important species, in-*
9 *cluding emerging plant and animal diseases causing*
10 *economic hardship;*

11 “(5) *ensuring the future genetic improvement of*
12 *agriculturally important species;*

13 “(6) *supporting the preservation of diverse*
14 *germplasm; and*

15 “(7) *ensuring the preservation of biodiversity to*
16 *maintain access to genes that may be of importance*
17 *in the future.”.*

18 **(b) COMPETITIVE GRANTS.**—*Subsection (b) of such sec-*
19 *tion is amended by striking “subsection (c)” and inserting*

9 *Facilities Research Grant Act (7 U.S.C. 450i) is amend-*

11 (1) *by striking “the cost” and inserting “the cost*

6 *(a) FINDINGS.—Section 2 of the Forest and Rangeland*
7 *Renewable Resources Research Act of 1978 (16 U.S.C. 1641)*
8 *is amended by striking “SEC. 2.” and subsection (a) and*
9 *inserting the following:*

10 **“SEC. 2. FINDINGS AND PURPOSE.**

11 *“(a) FINDINGS.—Congress finds the following:*

12 *“(1) Forests and rangelands, and the resources of*
13 *forests and rangelands, are of strategic economic and*
14 *ecological importance to the United States, and the*
15 *Federal Government has an important and substan-*
16 *tial role in ensuring the continued health, productiv-*
17 *ity, and sustainability of the Nation’s forests and*
18 *rangelands.*

19 *“(2) Over 75 percent of the productive commer-*
20 *cial forest land in the United States is in private*
21 *ownership, with some 60 percent owned by small non-*
22 *industrial private owners. These 10,000,000 non-*
23 *industrial private owners are critical to providing*
24 *both commodity and noncommodity values to the citi-*
25 *zens of the United States.*

1 “(3) *The National Forest System manages only*
2 *17 percent of the Nation’s commercial timberlands,*
3 *with over half of the standing softwoods inventory lo-*
4 *cated on those lands. Dramatic changes in Federal*
5 *agency policy during the early 1990’s have signifi-*
6 *cantly curtailed the management of this vast timber*
7 *resource, causing abrupt shifts in the supply of timber*
8 *from public to private ownership. As a result of these*
9 *shifts in supply, some 60 percent of total wood pro-*
10 *duction in the United States is now coming from pri-*
11 *vate forest lands in the southern United States.*

12 “(4) *At the same time that pressures are build-*
13 *ing for the removal of even more land from commer-*
14 *cial production, the Federal Government is signifi-*
15 *cantly reducing its commitment to productivity-relat-*
16 *ed research regarding forests and rangelands, which is*
17 *critically needed by the private sector for the sus-*
18 *tained management of remaining available timber*
19 *and forage resources for the benefit of all species.*

20 “(5) *Uncertainty over the availability of the*
21 *United States timber supply, increasing regulatory*
22 *burdens, and the lack of Federal Government support*
23 *for research is causing domestic wood and paper pro-*
24 *ducers to move outside the United States to find reli-*
25 *able sources of wood supplies, which in turns results*

1 *in a worsening of the United States trade balance, the*
2 *loss of employment and infrastructure investments,*
3 *and an increased risk of infestations of exotic pests*
4 *and diseases from imported wood products.*

5 *“(6) Wood and paper producers in the United*
6 *States are being challenged not only by shifts in Gov-*
7 *ernment policy, but also by international competition*
8 *from tropical countries where growth rates of trees far*
9 *exceed those in the United States. Wood production*
10 *per acre will need to quadruple from 1996 levels for*
11 *the United States forestry sector to remain inter-*
12 *nationally competitive on an ever decreasing forest*
13 *land base.*

14 *“(7) Better and more frequent forest*
15 *inventorying and analysis is necessary to identify*
16 *productivity-related forestry research needs and to*
17 *provide forest managers with the current data nec-*
18 *essary to make timely and effective management deci-*
19 *sions.”.*

20 *(b) HIGH PRIORITY FORESTRY RESEARCH AND EDU-*
21 *CATION.—Subsection (d) of section 3 of the Forest and*
22 *Rangeland Renewable Resources Research Act of 1978 (16*
23 *U.S.C. 1642) is amended to read as follows:*

24 *“(d) HIGH PRIORITY FORESTRY AND RANGELANDS*
25 *RESEARCH AND EDUCATION.—The Secretary may conduct,*

1 *support, and cooperate in forestry and rangelands research*
2 *and education that is of the highest priority to the United*
3 *States and to users of public and private forest lands and*
4 *rangelands in the United States. Such research and edu-*
5 *cation priorities include the following:*

6 “(1) *The biology of forest organisms and range-*
7 *land organisms.*”

8 “(2) *Functional characteristics and cost-effective*
9 *management of forest and rangeland ecosystems.*”

10 “(3) *Interactions between humans and forests*
11 *and rangelands.*”

12 “(4) *Wood and forage as a raw material.*”

13 “(5) *International trade, competition, and co-*
14 *operation.*”.

15 (c) *FOREST INVENTORY AND ANALYSIS.*—Section 3 of
16 *the Forest and Rangeland Renewable Resources Research*
17 *Act of 1978 (16 U.S.C. 1642) is amended by adding at the*
18 *end the following new subsection:*

19 “(e) *FOREST INVENTORY AND ANALYSIS.*—

20 “(1) *PROGRAM REQUIRED.*—*In compliance with*
21 *existing statutory authority, the Secretary shall estab-*
22 *lish a program to inventory and analyze, in a timely*
23 *manner, public and private forests and their resources*
24 *in the United States.*”

1 “(2) *ANNUAL STATE INVENTORY.*—Not later than
2 the end of each full fiscal year beginning after the
3 date of the enactment of this subsection, the Secretary
4 shall prepare for each State, in cooperation with the
5 State forester for the State, an inventory of forests
6 and their resources in the State. For purposes of pre-
7 paring the inventory for a State, the Secretary shall
8 measure annually 20 percent of all sample plots that
9 are included in the inventory program for that State.
10 Upon completion of the inventory for a year, the Sec-
11 retary shall make available to the public a compila-
12 tion of all data collected for that year from measure-
13 ments of sample plots as well as any analysis made
14 of such samples.

15 “(3) *FIVE-YEAR REPORTS.*—At intervals not
16 greater than every five full fiscal years after the date
17 of the enactment of this subsection, the Secretary shall
18 prepare, publish, and make available to the public a
19 report, prepared in cooperation with State foresters,
20 that—

21 “(A) contains a description of each State
22 inventory of forests and their resources, incor-
23 porating all sample plot measurements con-
24 ducted during the five years covered by the re-
25 port;

1 “(B) displays and analyzes on a nationwide
2 basis the results of the annual reports required
3 by paragraph (2); and

4 “(C) contains an analysis of forest health
5 conditions and trends over the previous two dec-
6 ades, with an emphasis on such conditions and
7 trends during the period subsequent to the imme-
8 diately preceding report under this paragraph.

9 “(4) NATIONAL STANDARDS AND DEFINITIONS.—
10 To ensure uniform and consistent data collection for
11 all public and private forest ownerships and each
12 State, the Secretary shall develop, in consultation
13 with State foresters and Federal land management
14 agencies not under the jurisdiction of the Secretary,
15 and publish national standards and definitions to be
16 applied in inventorying and analyzing forests and
17 their resources under this subsection. The standards
18 shall include a core set of variables to be measured on
19 all sample plots under paragraph (2) and a standard
20 set of tables to be included in the reports under para-
21 graph (3).

22 “(5) PROTECTION FOR PRIVATE PROPERTY
23 RIGHTS.—The Secretary shall obtain written author-
24 ization from property owners prior to collecting data

1 *from sample plots located on private property pursu-*
2 *ant to paragraphs (2) and (3).*

3 “(6) *STRATEGIC PLAN.*—*Not later than 180 days*
4 *after the date of the enactment of this subsection, the*
5 *Secretary shall prepare and submit to Congress a*
6 *strategic plan to implement and carry out this sub-*
7 *section, including the annual updates required by*
8 *paragraph (2) and the reports required by paragraph*
9 *(3), that shall describe in detail—*

10 “(A) *the financial resources required to im-*
11 *plement and carry out this subsection, including*
12 *the identification of any resources required in*
13 *excess of the amounts provided for forest*
14 *inventorying and analysis in recent appropria-*
15 *tions Acts;*

16 “(B) *the personnel necessary to implement*
17 *and carry out this subsection, including any per-*
18 *sonnel in addition to personnel currently per-*
19 *forming inventorying and analysis functions;*

20 “(C) *the organization and procedures nec-*
21 *essary to implement and carry out this sub-*
22 *section, including proposed coordination with*
23 *Federal land management agencies and State*
24 *foresters;*

1 (2) *by adding at the end the following new sub-*
2 *sections:*

3 “(b) *EMPHASIS ON CERTAIN HIGH PRIORITY FOR-*
4 *ESTRY RESEARCH.—The Secretary may use up to five per-*
5 *cent of the amounts made available for research under sec-*
6 *tion 3 to make competitive grants regarding forestry re-*
7 *search in the high priority research areas identified in sec-*
8 *tion 3(d).*

9 “(c) *EMPHASIS ON CERTAIN HIGH PRIORITY RANGE-*
10 *LANDS RESEARCH.—The Secretary may use up to five per-*
11 *cent of the amounts made available for research under sec-*
12 *tion 3 to make competitive grants regarding rangelands re-*
13 *search in the high priority research areas identified in sec-*
14 *tion 3(d).*

15 “(d) *PRIORITIES.—In making grants under sub-*
16 *sections (b) and (c), the Secretary shall give priority to re-*
17 *search proposals in which—*

18 “(1) *the proposed research will be collaborative*
19 *research organized through a center of scientific excel-*
20 *lence;*

21 “(2) *the applicant agrees to provide matching*
22 *funds (in the form of direct funding or in-kind sup-*
23 *port) in an amount equal to not less than 50 percent*
24 *of the grant amount; and*

1 “(3) the proposed research will be conducted as
2 part of an existing private and public partnership or
3 cooperative research effort and involves several inter-
4 ested research partners.”.

3 **SEC. 304. GENERAL AUTHORIZATION FOR AGRICULTURAL**
4 **RESEARCH PROGRAMS.**

5 Section 1463 of the National Agricultural Research,
6 Extension, and Teaching Policy Act of 1977 (7 U.S.C.
7 3311) is amended in subsections (a) and (b) by striking
8 “1997” each place it appears and inserting “2002”.

9 **SEC. 305. GENERAL AUTHORIZATION FOR EXTENSION EDU-**
10 **CATION.**

11 Section 1464 of the National Agricultural Research,
12 Extension, and Teaching Policy Act of 1977 (7 U.S.C.
13 3312) is amended by striking “1997” and inserting “2002”.

14 **SEC. 306. GRANTS AND FELLOWSHIPS FOR FOOD AND AGRI-**
15 **CULTURAL SCIENCES EDUCATION.**

16 Section 1417(j) of the National Agricultural Research,
17 Extension, and Teaching Policy Act of 1977 (7 U.S.C.

1 **SEC. 307. GRANTS FOR RESEARCH ON THE PRODUCTION**
2 **AND MARKETING OF ALCOHOLS AND INDUS-**

5 **UCTS.**

6 *Section 1419(d) of the National Agricultural Research,*
7 *Extension, and Teaching Policy Act of 1977 (7 U.S.C.*
8 *3154(d)) is amended by striking “1997” and inserting*
9 *“2002”.*

10 **SEC. 308. POLICY RESEARCH CENTERS.**

20 *partnership” means a partnership consisting of a*
21 *land-grant college or university and other entities*
22 *specified in paragraph (1) of subsection (b) of section*
23 *402 that satisfies the eligibility criteria contained in*
24 *such subsection.*

1 (2) *SECRETARY.*—*The term “Secretary” means*
2 *the Secretary of Agriculture.*

3 **SEC. 402. ESTABLISHMENT AND CHARACTERISTICS OF**
4 **PARTNERSHIPS.**

5 (a) *ESTABLISHMENT BY GRANT.*—

6 (1) *IN GENERAL.*—*The Secretary may make*
7 *grants to an eligible partnership to coordinate and*
8 *manage research and extension activities to enhance*
9 *the quality of high-value agricultural products.*

10 (2) *AWARDING OF GRANTS.*—*Grants under para-*
11 *graph (1) shall be awarded on a competitive basis.*

12 (b) *CRITERIA FOR AN ELIGIBLE PARTNERSHIP.*—

13 (1) *PRIMARY INSTITUTIONS IN PARTNERSHIP.*—
14 *The primary institution involved in an eligible part-*
15 *nership shall be a land-grant college or university,*
16 *acting in partnership with other colleges or univer-*
17 *sities, nonprofit research and development entities,*
18 *and Federal laboratories.*

19 (2) *PRIORITIZATION OF RESEARCH ACTIVI-*
20 *TIES.*—*An eligible partnership shall prioritize re-*
21 *search and extension activities in order to—*

22 (A) *enhance the competitiveness of United*
23 *States agricultural products;*

24 (B) *increase exports of such products; and*

1 (C) substitute such products for imported
2 products.

3 (3) COORDINATION.—An eligible partnership
4 shall coordinate among the entities comprising the
5 partnership the activities supported by the eligible
6 partnership, including the provision of mechanisms
7 for sharing resources between institutions and labora-
8 tories and the coordination of public and private sec-
9 tor partners to maximize cost-effectiveness.

10 (c) TYPES OF RESEARCH AND EXTENSION ACTIVI-
11 TIES.—Research or extension supported by an eligible part-
12 nership may address the full spectrum of production, proc-
13 essing, packaging, transportation, and marketing issues re-
14 lated to a high-value agricultural product. Such issues in-
15 clude—

16 (1) environmentally responsible—

17 (A) pest management alternatives and bio-
18 technology;

19 (B) sustainable farming methods; and

20 (C) soil conservation and enhanced resource
21 management;

22 (2) genetic research to develop improved agricul-
23 tural-based products;

1 (3) *refinement of field production practices and*
2 *technology to improve quality, yield, and production*
3 *efficiencies;*

4 (4) *processing and package technology to im-*
5 *prove product quality, stability, or flavor intensity;*

6 (5) *marketing research regarding consumer per-*
7 *ceptions and preferences;*

8 (6) *economic research, including industry char-*
9 *acteristics, growth, competitive analysis; and*

10 (7) *research to facilitate diversified, value-added*
11 *enterprises in rural areas.*

12 **SEC. 403. ELEMENTS OF GRANT MAKING PROCESS.**

13 (a) *PERIOD OF GRANT.*—*The Secretary may award a*
14 *grant under this subtitle for a period not to exceed five*
15 *years.*

16 (b) *PREFERENCES.*—*In making grants under this sub-*
17 *title, the Secretary shall give preference to proposals that—*

18 (1) *demonstrate linkages with—*

19 (A) *agencies of the Department of Agri-*
20 *culture;*

21 (B) *other related Federal research labora-*
22 *tories and agencies;*

23 (C) *colleges and universities; and*

24 (D) *private industry; and*

1 (1) *PRECISION AGRICULTURE.*—The term “*precision agriculture*” means an integrated information-
2 and production-based farming system that is designed
3 to increase long-term, site specific and whole farm
4 production efficiencies, productivity, and profitability
5 while minimizing unintended impacts on wildlife and
6 the environment by—
7

8 (A) combining agricultural sciences, agri-
9 cultural inputs and practices, agronomic produc-
10 tion databases, and precision agriculture tech-
11 nologies to efficiently manage agronomic and
12 livestock production systems;

13 (B) gathering on-farm information pertain-
14 ing to the variation and interaction of site-spe-
15 cific spatial and temporal factors affecting crop
16 and livestock production;

17 (C) integrating such information with ap-
18 propriate data derived from field scouting, re-
19 mote sensing, and other precision agriculture
20 technologies in a timely manner in order to fa-
21 cilitate on-farm decisionmaking; or

22 (D) using such information to prescribe and
23 deliver site-specific application of agricultural
24 inputs and management practices in agricul-
25 tural production systems.

1 (2) *PRECISION AGRICULTURE TECHNOLOGIES.*—
2 The term “precision agriculture technologies” in-
3 cludes—

4 (A) *instrumentation and techniques ranging*
5 *from sophisticated sensors and software systems*
6 *to manual sampling and data collection tools*
7 *that measure, record, and manage spatial and*
8 *temporal data;*

9 (B) *technologies for searching out and as-*
10 *sembling information necessary for sound agri-*
11 *cultural production decision making;*

12 (C) *open systems technologies for data*
13 *networking and processing that produce valued*
14 *systems for farm management decisionmaking;*
15 or

16 (D) *machines that deliver information*
17 *based management practices.*

18 (3) *ADVISORY BOARD.*—The term “Advisory
19 Board” means the National Agricultural Research,
20 Extension, Education, and Economics Advisory
21 Board established under section 1408 of the National
22 Agricultural Research, Extension, and Teaching Pol-
23 icy Act of 1977 (7 U.S.C. 3123).

24 (4) *AGRICULTURAL INPUTS.*—The term “agricul-
25 tural inputs” includes all farm management, agro-

1 *nomie, and field applied agricultural production in-*
2 *puts, such as machinery, labor, time, fuel, irrigation*
3 *water, commercial nutrients, feed stuffs, veterinary*
4 *drugs and vaccines, livestock waste, crop protection*
5 *chemicals, agronomic data and information, applica-*
6 *tion and management services, seed, and other inputs*
7 *used in agriculture production.*

8 (5) *ELIGIBLE ENTITY.*—*The term “eligible en-*
9 *tity” means—*

10 (A) *a State agricultural experiment station;*

11 (B) *a college or university;*

12 (C) *a research institution or organization;*

13 (D) *a Federal or State government entity or*
14 *agency;*

15 (E) *a national laboratory;*

16 (F) *a private organization or corporation;*

17 (G) *an agricultural producer or other land*
18 *manager; or*

19 (H) *a precision agriculture partnership re-*
20 *ferred to in section 414.*

21 (6) *SYSTEMS RESEARCH.*—*The term “systems re-*
22 *search” means an integrated, coordinated, and itera-*
23 *tive investigative process, which considers the mul-*
24 *tiple interacting components and aspects of precision*
25 *agriculture systems, including synthesis of new*

1 *knowledge regarding the physical-chemical-biological*
2 *processes and complex interactions with cropping,*
3 *livestock production practices, and natural resource*
4 *systems, precision agriculture technologies develop-*
5 *ment and implementation, data and information col-*
6 *lection and interpretation, production scale planning,*
7 *production-scale implementation, and farm produc-*
8 *tion efficiencies, productivity, and profitability.*

9 **SEC. 412. COMPETITIVE GRANTS TO PROMOTE PRECISION**
10 **AGRICULTURE.**

11 *(a) GRANTS AUTHORIZED.—The Secretary of Agri-*
12 *culture may make competitive grants, for periods not to ex-*
13 *ceed five years, to eligible entities to conduct research, edu-*
14 *cation, or information dissemination projects for the devel-*
15 *opment and advancement of precision agriculture. Such*
16 *grants shall be limited to those projects that the Secretary*
17 *determines are unlikely to be financed by the private sector*
18 *in the absence of a grant under this section. The Secretary*
19 *shall make such grants in consultation with the Advisory*
20 *Board.*

21 *(b) PURPOSE OF PROJECTS.—Research, education, or*
22 *information dissemination projects supported by a grant*
23 *under subsection (a) shall address one or more of the follow-*
24 *ing:*

1 (1) *The study and promotion of components of*
2 *precision agriculture technologies using a systems re-*
3 *search approach that would increase long-term, site-*
4 *specified and whole farm production efficiencies, pro-*
5 *ductivity, profitability.*

6 (2) *The improvement in the understanding of ag-*
7 *ronomic systems, including, soil, water, land cover*
8 *(including grazing lands), pest management systems,*
9 *and meteorological variability.*

10 (3) *The provision of training and educational*
11 *programs for State cooperative extension services*
12 *agents, and other professionals involved in the agri-*
13 *cultural production and transfer of integrated preci-*
14 *sion agriculture technology.*

15 (4) *The development, demonstration, and dis-*
16 *semination of information regarding precision agri-*
17 *culture technologies and systems and the potential*
18 *benefits of precision agriculture as it relates to in-*
19 *creased long-term farm production efficiencies, pro-*
20 *ductivity, profitability, and the maintenance of the*
21 *environment, and improvements in international*
22 *trade into an integrated program to educate agricul-*
23 *tural producers and consumers, including family*
24 *owned and operated farms.*

1 (c) *GRANT PRIORITIES.*—*In making grants to eligible*
2 *entities under subsection (a), the Secretary, in consultation*
3 *with the Advisory Board, shall give priority to research,*
4 *education, or information dissemination projects designed*
5 *to accomplish the following:*

6 (1) *Evaluate the use of precision agriculture*
7 *technologies using a systems research approach to in-*
8 *crease long-term site-specific and whole farm produc-*
9 *tion efficiencies, productivity, profitability.*

10 (2) *Integrate research, education, and informa-*
11 *tion dissemination components in a practical and*
12 *readily available manner so that the findings of the*
13 *project will be made readily usable by farmers.*

14 (3) *Demonstrate the efficient use of agricultural*
15 *inputs, rather than the uniform reduction in the use*
16 *of agricultural inputs.*

17 (4) *Maximize the involvement and cooperation of*
18 *precision agriculture producers, certified crop advis-*
19 *ers, State cooperative extension services agents, agri-*
20 *cultural input machinery, product and service pro-*
21 *viders, nonprofit organizations, agribusiness, veteri-*
22 *narians, land-grant colleges and universities, and*
23 *Federal agencies in precision agriculture systems re-*
24 *search projects involving on-farm research, education,*

1 *tension services, other colleges and universities with*
2 *demonstrable expertise regarding precision agri-*
3 *culture, agencies of the Department of Agriculture,*
4 *national laboratories, agribusinesses, agricultural*
5 *equipment and input manufacturers and retailers,*
6 *certified crop advisers, commodity organizations,*
7 *veterinaries, other Federal or State government enti-*
8 *ties and agencies, or nonagricultural industries and*
9 *nonprofit organizations with demonstrable expertise*
10 *regarding precision agriculture; and*

11 *(2) agricultural producers or other land man-*
12 *agers.*

13 **SEC. 415. MISCELLANEOUS PROVISIONS.**

14 *(a) PROHIBITION ON USE OF FUNDS FOR CERTAIN*
15 *PURPOSES.—The Secretary of Agriculture may not make*
16 *a grant under section 412 for the planning, repair, rehabili-*
17 *tation, acquisition, or construction of a building or facility.*

18 *(b) APPLICATION OF OTHER LAWS.—The Federal Ad-*
19 *visory Committee Act (5 U.S.C. App.) and title XVIII of*

22 *purpose of reviewing applications or proposals submitted*
23 *under this subtitle.*

1 **SEC. 416. AUTHORIZATION OF APPROPRIATIONS.**

2 (a) *AUTHORIZATION OF APPROPRIATIONS.*—*There are*
 3 *hereby authorized to be appropriated to carry out this sub-*
 4 *title \$40,000,000 for each of the fiscal years 1998 through*
 5 *2002.*

6 (b) *ADMINISTRATIVE COSTS.*—*Not more than 3 per-*
 7 *cent of the amount appropriated under this subtitle may*
 8 *be retained by the Secretary to pay the administrative costs*
 9 *incurred by the Secretary in carrying out this subtitle.*

10 (c) *AVAILABILITY OF FUNDS.*—*Funds made available*
 11 *under paragraph (a) shall be available for obligation for*
 12 *a two-year period beginning on October 1 of the fiscal year*
 13 *for which the funds are made available.*

14 ***Subtitle C—Other Initiatives***

15 **SEC. 421. HIGH-PRIORITY RESEARCH AND EXTENSION INI-**

 23 *TENSION GRANTS AUTHORIZED.*—*The Secretary of Agri-*
 24 *culture, in consultation with the National Agricultural Re-*
 25 *search, Education, Extension, and Economics Advisory*
 26 *Board, may make competitive grants to support research*

1 *and extension activities in the high-priority research and*
2 *extension areas specified in subsection (e).*

3 “(b) *GRANT TYPES AND PROCESS; PROHIBITION ON*
4 *CONSTRUCTION.*—*Paragraphs (6), (7), and (11) of sub-*
5 *section (b) of the Competitive, Special, and Facilities Re-*
6 *search Grant Act (7 U.S.C. 450i) shall apply with respect*
7 *to the making of grants under this section.*

8 “(c) *MATCHING FUNDS REQUIRED.*—

9 “(1) *IN GENERAL.*—*The Secretary shall require*
10 *the recipient of a grant under this section to provide*
11 *funds or in-kind support from non-Federal sources in*
12 *an amount at least equal to the amount provided by*
13 *the Federal Government.*

14 “(2) *WAIVER AUTHORITY.*—*The Secretary may*
15 *waive the matching funds requirement specified in*
16 *paragraph (1) with respect to a research project if the*
17 *Secretary determines that—*

18 “(A) *the results of the project, while of par-*
19 *ticular benefit to a specific agricultural commod-*
20 *ity, are likely to be applicable to agricultural*

22 “(B) *the project involves a minor commod-*
23 *ity, deals with scientifically important research,*
24 *and the grant recipient would be unable to sat-*

1 “(d) *PARTNERSHIPS ENCOURAGED.*—Following the
2 completion of a peer review process for grant proposals re-
3 ceived under this section, the Secretary may give priority
4 to those grant proposals found to be scientifically meritori-
5 ous that involve the cooperation of multiple institutions.

6 “(e) *HIGH-PRIORITY RESEARCH AND EXTENSION*
7 *AREAS.*—

8 “(1) *BROWN CITRUS APHID AND CITRUS*
9 *TRISTEZA VIRUS RESEARCH AND EXTENSION.*—Re-
10 search and extension grants may be made under this
11 section for the purpose of—

12 “(A) developing methods to control or eradi-
13 cate the brown citrus aphid and the citrus
14 tristeza virus from citrus crops grown in the
15 United States; or

16 “(B) adapting citrus crops grown in the
17 United States to the brown citrus aphid and the
18 citrus tristeza virus.

19 “(2) *ETHANOL RESEARCH AND EXTENSION.*—Re-
20 search and extension grants may be made under this
21 section for the purpose of carrying on or enhancing
22 research on ethanol derived from agricultural crops as
23 an alternative fuel source.

24 “(3) *AFLATOXIN RESEARCH AND EXTENSION.*—
25 Research and extension grants may be made under

1 *this section for the purpose of identifying and control-*
2 *ling aflatoxin in the food and feed chains.*

3 “(4) *MESQUITE RESEARCH AND EXTENSION.*—
4 *Research and extension grants may be made under*
5 *this section for the purpose of developing enhanced*
6 *production methods and commercial uses of mesquite.*

7 “(5) *PRICKLY PEAR RESEARCH AND EXTEN-*
8 *SION.*—*Research and extension grants may be made*
9 *under this section for the purpose of investigating en-*
10 *hanced genetic selection and processing techniques of*
11 *prickly pears.*

12 “(6) *DEER TICK ECOLOGY RESEARCH AND EX-*
13 *TENSION.*—*Research and extension grants may be*
14 *made under this section for the purpose of studying*
15 *the population ecology of deer ticks and other insects*
16 *and pests which transmit Lyme disease.*

17 “(7) *RED MEAT SAFETY RESEARCH AND EXTEN-*
18 *SION.*—*Research and extension grants may be made*
19 *under this section for the purpose of developing—*

20 “(A) *intervention strategies that reduce mi-*
21 *crobial contamination on carcass surfaces;*

22 “(B) *microbiological mapping of carcass*
23 *surfaces; and*

1 **TITLE V—MISCELLANEOUS**
2 **PROVISIONS**

3 **SEC. 501. ROLE OF SECRETARY OF AGRICULTURE REGARD-**
4 **ING FOOD AND AGRICULTURAL SCIENCES RE-**
5 **SEARCH, EDUCATION, AND EXTENSION.**

6 *The Secretary of Agriculture shall be the principal offi-*
7 *cial in the executive branch responsible for coordinating all*
8 *Federal research and extension activities related to food and*
9 *agricultural sciences.*

10 **SEC. 502. OFFICE OF PEST MANAGEMENT POLICY.**

11 *(a) OBJECTIVE.—The establishment of an Office of*
12 *Pest Management Policy pursuant to this section is in-*
13 *tended to provide for the effective coordination of agricul-*
14 *tural policies and activities within the Department of Agri-*
15 *culture related to pesticides and of the development and use*
16 *of pest management tools, while taking into account the ef-*
17 *fects of regulatory actions of other government agencies.*

18 *(b) ESTABLISHMENT OF OFFICE; PRINCIPAL RESPON-*
19 *SIBILITIES.—The Secretary of Agriculture shall establish in*
20 *the Department of Agriculture an Office of Pest Manage-*
21 *ment Policy, which shall be responsible for—*

22 *(1) the development and coordination of Depart-*
23 *ment of Agriculture policy on pest management and*
24 *pesticides;*

1 (2) *the coordination of activities and services of*
2 *the Department, including research, extension, and*
3 *education activities, regarding the development, avail-*
4 *ability, and use of economically and environmentally*
5 *sound pest management tools and practices;*

6 (3) *assisting the Department in fulfilling its re-*
7 *sponsibilities related to pest management or pesticides*
8 *under the Food Quality Protection Act of 1996 (Pub-*
9 *lic Law 104–170; 110 Stat. 1489), the Federal Insec-*
10 *ticide, Fungicide, and Rodenticide Act (7 U.S.C. 136*
11 *et seq.), the Federal Food, Drug, and Cosmetic Act*
12 *(21 U.S.C. 301 et seq.), or other law; and*

13 (4) *performing such other functions as may be*
14 *required by law or prescribed by the Secretary.*

15 (c) *INTERAGENCY COORDINATION.—In support of its*
16 *responsibilities under subsection (a), the Office of Pest Man-*
17 *agement Policy shall provide leadership to ensure coordina-*
18 *tion of interagency activities with the Environmental Pro-*
19 *tection Agency, the Food and Drug Administration, and*
20 *other Federal and State agencies.*

21 (d) *OUTREACH.—The Office of Pest Management Pol-*
22 *icy shall consult with agricultural producers that may be*
23 *affected by pest management or pesticide-related activities*
24 *or actions of the Department or other agencies as necessary*

1 *in carrying out the Office's responsibilities under this sec-*
2 *tion.*

3 (e) *DIRECTOR.*—*The Office of Pest Management Policy*
4 *shall be under the direction of a Director appointed by the*
5 *Secretary who shall report directly to the Secretary or a*
6 *designee of the Secretary.*

7 (f) *AUTHORIZATION OF APPROPRIATIONS.*—*There are*
8 *authorized to be appropriated such sums as may be nec-*
9 *essary to carry out this section.*

10 **SEC. 503. FOOD SAFETY RESEARCH INFORMATION OFFICE**
11 **AND NATIONAL CONFERENCE.**

12 (a) *FOOD SAFETY RESEARCH INFORMATION OF-*
13 *FICE.*—

14 (1) *ESTABLISHMENT AND PURPOSE.*—*The Sec-*
15 *retary of Agriculture shall establish a Food Safety*
16 *Research Information Office at the National Agricul-*
17 *tural Library. The Office shall provide to the research*
18 *community and the general public information on*
19 *publicly funded, and to the extent possible, privately*
20 *funded food safety research initiatives for the purpose*
21 *of—*

22 (A) *preventing unintended duplication of*
23 *food safety research; and*

24 (B) *assisting the executive and legislative*
25 *branches of the Government and private research*

1 *entities to assess food safety research needs and*
2 *priorities.*

3 (2) *COOPERATION.*—*The Office shall carry out*
4 *paragraph (1) in cooperation with the National Insti-*
5 *tutes of Health, the Food and Drug Administration,*
6 *the Centers for Disease Control and Prevention, pub-*
7 *lic institutions, and on a voluntary basis, private re-*
8 *search interests.*

9 (b) *NATIONAL CONFERENCE.*—*Not later than 120 days*
10 *after the date of the enactment of this Act, the Secretary*
11 *shall sponsor a conference to be known as the “National*
12 *Conference on Food Safety Research”, for the purpose of*
13 *beginning the task of food safety research prioritization. The*
14 *Secretary shall sponsor annual workshops in each of the*
15 *subsequent four years after the conference so that priorities*
16 *can be updated or adjusted to reflect changing food safety*
17 *concerns.*

18 (c) *FOOD SAFETY REPORT.*—*With regard to the study*
19 *and report to be prepared by the National Academy of*
20 *Sciences on the scientific and organizational needs for an*
21 *effective food safety system, the study shall include rec-*
22 *ommendations to ensure that the food safety inspection sys-*
23 *tem, within the resources traditionally available to existing*
24 *food safety agencies, protects the public health.*

1 **SEC. 504. NUTRIENT COMPOSITION DATA.**

2 (a) *IN GENERAL.*—*The Secretary of Agriculture shall*
3 *update, on a periodic basis, nutrient composition data.*

4 (b) *REPORT.*—*Not later than 180 days after the date*
5 *of the enactment of this Act, the Secretary shall submit to*
6 *Congress a report that describes—*

7 (1) *the method the Secretary will use to update*
8 *nutrient composition data, including the quality as-*
9 *urance criteria that will be used and the method for*
10 *generating the data; and*

11 (2) *the timing for updating the data.*

12 **SEC. 505. AVAILABILITY OF FUNDS RECEIVED OR COL-**
13 **LECTED ON BEHALF OF NATIONAL ARBORE-**
14 **TUM.**

15 *Section 6(b) of the Act of March 4, 1927 (20 U.S.C.*
16 *196(b)), is amended by striking “Treasury” and inserting*
17 *“Treasury. Amounts in the special fund shall be available*
18 *to the Secretary of Agriculture, without further appropria-*
19 *tion,”.*

20 **SEC. 506. RETENTION AND USE OF AGRICULTURAL RE-**
21 **SEARCH SERVICE PATENT CULTURE COLLEC-**
22 **TION FEES.**

23 *All funds collected by the Agricultural Research Serv-*
24 *ice of the Department of Agriculture in connection with the*
25 *acceptance of microorganisms for deposit in, or the distribu-*
26 *tion of microorganisms from, the Patent Culture Collection*

1 *maintained and operated by the Agricultural Research*
2 *Service shall be credited to the appropriation supporting*
3 *the maintenance and operation of the Patent Culture Col-*
4 *lection. The collected funds shall be available to the Agricul-*
5 *tural Research Service, without further appropriation or*
6 *fiscal-year limitation, to carry out its responsibilities under*
7 *law (including international treaty) with respect to the*
8 *Patent Culture Collection.*

9 **SEC. 507. REIMBURSEMENT OF EXPENSES INCURRED**
10 **UNDER SHEEP PROMOTION, RESEARCH, AND**
11 **INFORMATION ACT OF 1994.**

12 *Using funds available to the Agricultural Marketing*
13 *Service, the Service may reimburse the American Sheep In-*
14 *dustry Association for expenses incurred by American*
15 *Sheep Industry Association between February 6, 1996, and*
16 *May 17, 1996, in preparation for the implementation of*
17 *a sheep and wool promotion, research, education, and infor-*
18 *mation order under the Sheep Promotion, Research, and In-*
19 *formation Act of 1994 (7 U.S.C. 7101 et seq.).*

20 **SEC. 508. SENSE OF CONGRESS REGARDING AGRICULTURAL**
21 **RESEARCH SERVICE EMPHASIS ON IN FIELD**
22 **RESEARCH REGARDING METHYL BROMIDE**
23 **ALTERNATIVES.**

24 *It is the sense of Congress that, of the Agricultural Re-*
25 *search Service funds made available for a fiscal year for*

1 *research regarding the development for agricultural use of*
2 *alternatives to methyl bromide, the Secretary of Agriculture*
3 *should use a substantial portion of such funds for research*
4 *to be conducted in real field conditions, in particular pre-*
5 *planting and post-harvest conditions, so as to expedite the*
6 *development and commercial use of methyl bromide alter-*
7 *natives.*

8 **SEC. 509. SENSE OF CONGRESS REGARDING IMPORTANCE**
9 **OF SCHOOL-BASED AGRICULTURAL EDU-**
10 **CATION.**

11 *It is the sense of Congress that the Secretary of Agri-*
12 *culture and the Secretary of Education should collaborate*
13 *and cooperate in providing both instructional and technical*
14 *support for school-based agricultural education.*

15 **SEC. 510. SENSE OF CONGRESS REGARDING DESIGNATION**
16 **OF DEPARTMENT CRISIS MANAGEMENT**
17 **TEAM.**

18 *(a) FINDINGS.—Congress finds the following:*

19 *(1) The Department of Agriculture plays a cru-*
20 *cial role in ensuring that the United States is a world*
21 *leader in maintaining the most affordable, abundant,*
22 *wholesome, and safe food supply for its citizens.*

23 *(2) It is in the best interest of consumers, pro-*
24 *ducers, processors, retailers, government officials, and*
25 *other interested parties to ensure that any crisis that*

1 *may affect the operation of the Department or the*
2 *production of a safe and wholesome food supply is*
3 *addressed in an effective manner.*

4 (3) *Unforeseen circumstances, including natural*
5 *disaster, personnel management problems, threats to*
6 *public health, and trade disruptions, have the poten-*
7 *tial to undermine the operation of the Department*
8 *and the Nation's ability to efficiently provide a safe,*
9 *affordable, abundant, and wholesome food supply.*

10 (4) *Department of Agriculture employees,*
11 *consumer confidence, and the food production sector*
12 *have been adversely impacted as a result of the chal-*
13 *lenges associated with Federal agencies' ability to re-*
14 *spond to incidents in a coordinated and timely fash-*
15 *ion.*

16 (5) *An effective response to crises, emergencies,*
17 *and similar situations depends upon the timely and*
18 *efficient coordination of Federal, State, and local gov-*
19 *ernment agencies.*

20 (6) *It is in the best interests of the Nation to en-*
21 *sure that whenever a crisis occurs the appropriate*
22 *Federal agencies coordinate their activities.*

23 (7) *The Department of Agriculture should take*
24 *the lead in ensuring a safe and wholesome supply of*
25 *food for the Nation because of its broad and diverse*

1 *relationship with consumers and the food production*
2 *sector.*

3 **(b) SENSE OF CONGRESS.**—*It is the sense of Congress*
4 *that the Secretary of Agriculture should—*

5 *(1) designate a Crisis Management Team within*
6 *the Department of Agriculture, which would be com-*
7 *posed of senior departmental personnel with strong*
8 *subject matter expertise selected from each relevant*
9 *agency of the Department and would be headed by a*
10 *team leader with strong management and commu-*
11 *nications skills;*

12 *(2) upon establishment of such a Crisis Manage-*
13 *ment Team, direct that the Crisis Management*
14 *Team—*

15 *(A) develop a department-wide crisis man-*
16 *agement plan, taking into account similar plans*
17 *developed by other government agencies and*
18 *other large organizations;*

19 *(B) develop detailed written procedures for*
20 *implementing the crisis management plan;*

21 *(C) conduct periodic reviews and revisions*
22 *of the crisis management plan and procedures;*

23 *(D) ensure compliance with crisis manage-*
24 *ment procedures by departmental personnel;*

1 (E) coordinate the Department's informa-
2 tion gathering and dissemination activities con-
3 cerning issues managed by the Crisis Manage-
4 ment Team;

5 (F) ensure that all employees of the Depart-
6 ment are familiar with the crisis management
7 plan and procedures and are encouraged to bring
8 information regarding crises or potential crises
9 to the attention of team members;

10 (G) ensure that departmental spokespersons
11 convey accurate, timely, and scientifically sound
12 information that is easily understood by the tar-
13 get audience; and

14 (H) cooperate and coordinate with other
15 Federal agencies, States, local governments, in-
16 dustry, and public interest groups; and

17 (3) seek to enter into cooperative agreements
18 with other Federal departments and agencies that
19 have related programs or activities to help ensure con-
20 sistent, accurate, and coordinated dissemination of
21 information throughout the executive branch in the
22 event of a crisis.
