## A BILL

To authorize additional appropriations for the Department of Defense for ballistic missile defenses and other measures to counter the emerging threat posed to the United States and its allies in the Middle East and Persian Gulf region by the development and deployment of ballistic missiles by Iran.

1       *Be it enacted by the Senate and House of Representa-*  
 2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Theater Missile Defense*  
 5       *Improvement Act of 1998”.*

1 **SEC. 2. FINDINGS.**

2 *Congress makes the following findings:*

3 *(1) Development of medium-range ballistic mis-*  
4 *siles by potential adversaries, such as Iran, has pro-*  
5 *ceeded much more rapidly than previously antici-*  
6 *ipated by the United States Government.*

7 *(2) Existence of such missiles in potentially hos-*  
8 *tile nations constitutes a serious threat to United*  
9 *States forces, allies, and friends in the Middle East*  
10 *and Persian Gulf region and cannot be adequately*  
11 *countered by currently deployed ballistic missile de-*  
12 *fense systems.*

13 *(3) It is a matter of high national interest to*  
14 *quickly reduce the vulnerability of United States*  
15 *forces, allies, and friends to these threats.*

16 *(4) Meaningful and cost effective steps to reduce*  
17 *these vulnerabilities are available and should be pur-*  
18 *sued expeditiously.*

19 **SEC. 3. ACCELERATION OF DEPARTMENT OF DEFENSE PRO-**  
20 **GRAMS TO COUNTER ENHANCED BALLISTIC**  
21 **MISSILE THREAT.**

22 *Funds are hereby authorized to be appropriated for the*  
23 *Department of Defense for fiscal year 1998 for Defense-wide*  
24 *research, development, test, and evaluation in the amount*  
25 *of \$147,000,000, to be available as follows:*

1           (1) *JOINT COMPOSITE TRACKING NETWORK.*—  
2           \$35,000,000 to be available for the *Joint Composite*  
3           *Tracking Network* program.

4           (2) *PATRIOT REMOTE LAUNCH CAPABILITY.*—  
5           \$15,000,000 to be available to accelerate development  
6           of the remote launch capability for the *Patriot Ad-*  
7           *vanced Capability (PAC-3)* missile defense system.

8           (3) *PAC-3 AND NAVY AREA DEFENSE TESTS.*—  
9           \$40,000,000 to be available to test the capabilities of  
10          the *Patriot Advanced Capability (PAC-3)* missile de-  
11          fense system, and to test the capabilities of the *Navy*  
12          *Area Defense System*, against missiles with the range  
13          of the *Iranian ballistic missiles* under development.

14          (4) *EARLY WARNING ENHANCEMENT.*—  
15          \$6,000,000 to be available for improved integration of  
16          the various elements of the *SHIELD* system.

17          (5) *PAC-3 PRODUCTION RATE ENHANCE-*  
18          *MENTS.*—\$41,000,000 to be available for production  
19          rate enhancements for the *Patriot Advanced Capabil-*  
20          *ity (PAC-3)* missile defense system.

21          (6) *ISRAELI ARROW MISSILE DEFENSE SYS-*  
22          *TEM.*—\$10,000,000 to be available to improve inter-  
23          operability of the *Israeli Arrow tactical ballistic mis-*  
24          *sile defense system* with *United States theater missile*  
25          *defense systems.*

1 **SEC. 4. IDENTIFICATION OF OTHER POSSIBLE ACTIONS.**

2 (a) *IDENTIFICATION.*—*The Secretary of Defense shall*  
3 *identify actions in addition to those authorized by section*  
4 *3 that could be taken by the Department of Defense to*  
5 *counter the threats posed to the United States and its na-*  
6 *tional security interests by the development or acquisition*  
7 *of medium-range ballistic missiles by Iran and other na-*  
8 *tions.*

9 (b) *SPECIFIC ACTIONS TO BE TAKEN.*—*The Secretary*  
10 *specifically shall explore—*

11 (1) *additional cooperative measures between the*  
12 *Department of Defense and the Ministry of Defense of*  
13 *Israel to further enhance Israel’s ability to defend*  
14 *itself against the threat posed by ballistic missiles de-*  
15 *ployed by Iran and other nations; and*

16 (2) *actions within the existing Navy Theater*  
17 *Wide Missile Defense System program that could pro-*  
18 *vide additional capabilities useful to addressing the*  
19 *threat posed by medium-range ballistic missiles with-*  
20 *in one to two years.*

21 (c) *INTERGOVERNMENTAL COORDINATION.*—*The Sec-*  
22 *retary shall undertake appropriate intergovernmental and*  
23 *interagency coordination that would be necessary to the*  
24 *conduct of any of the actions identified pursuant to sub-*  
25 *section (a).*

1 **SEC. 5. REPORT TO CONGRESS.**

2 *Not later than 60 days after the date of the enactment*  
3 *of this Act, the Secretary of Defense shall submit to Congress*  
4 *a report providing—*

5 *(1) a description of the Secretary's plans for use*  
6 *of funds appropriated pursuant to the authorizations*  
7 *of appropriations in this Act; and*

8 *(2) a description of possible additional actions*  
9 *identified by the Secretary pursuant to section 4(a)*  
10 *and the steps taken or planned (as of the time of the*  
11 *report) to carry out section 4(c).*

12 **SEC. 6. OFFSETTING REDUCTIONS IN AUTHORIZATIONS.**

13 *The total amount authorized in section 201 of the Na-*  
14 *tional Defense Authorization Act for Fiscal Year 1998 (Pub-*  
15 *lic Law 105–85) to be appropriated for fiscal year 1998*  
16 *for research, development, test, and evaluation for the De-*  
17 *partment of Defense is hereby reduced by \$147,000,000, of*  
18 *which—*

19 *(1) \$126,000,000 is to be derived from savings*  
20 *from the use of advisory and assistance services by the*  
21 *Department of Defense in accordance with section*  
22 *8041 of the Department of Defense Appropriations*  
23 *Act, 1998 (Public Law 105–56; 111 Stat. 1230); and*

24 *(2) \$21,000,000 is to be derived from savings*  
25 *from the use by the Department of Defense of defense*  
26 *federally funded research and development centers in*

1       *accordance with section 8035 of the Department of*  
2       *Defense Appropriations Act, 1998 (Public Law 105–*  
3       *56; 111 Stat. 1227).*

Amend the title so as to read: “A bill to authorize additional appropriations for the Department of Defense for ballistic missile defenses and other measures to counter the emerging threat posed to the United States and its allies by the accelerated development and deployment of ballistic missiles by nations hostile to United States interests.”.
