## A BILL

To extend certain programs under the Energy Policy and  
Conservation Act and the Energy Conservation and Pro-  
duction Act.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ENERGY POLICY AND CONSERVATION ACT**  
4 **AMENDMENTS.**

5 (a) INTERAGENCY WORKING GROUPS.—Section  
6 256(h) of the Energy Policy and Conservation Act (42  
7 U.S.C. 6276(h)) is amended to read as follows:

8 “(h) AUTHORIZATION OF APPROPRIATIONS.—There  
9 are authorized to be appropriated to the Secretary for fis-  
10 cal years 1998 through 2002 such sums as may be nec-

1 essary to carry out subsections (d) and (e), to be divided  
 2 equitably between the interagency working subgroups  
 3 based on program requirements.”.

4 (b) STATE ENERGY CONSERVATION PROGRAM.—Sec-  
 5 tion 365(f)(1) of the Energy Policy and Conservation Act  
 6 (42 U.S.C. 6325(f)(1)) is amended by striking “not to ex-  
 7 ceed” and all that follows through “fiscal year 1993” and  
 8 inserting in lieu thereof “for fiscal years 1998 through  
 9 2002 such sums as may be necessary”.

10 (c) SCHOOLS AND HOSPITALS.—Section 397 the En-  
 11 ergy Policy and Conservation Act (42 U.S.C. 6371f) is  
 12 amended to read as follows:

13 “AUTHORIZATION OF APPROPRIATIONS

14 “SEC. 397. For the purpose of carrying out this part,  
 15 there are authorized to be appropriated for fiscal years  
 16 1998 through 2002 such sums as may be necessary.”.

17 **SEC. 2. ENERGY CONSERVATION AND PRODUCTION ACT**  
 18 **AMENDMENT.**

19 Section 422 of the Energy Conservation and Produc-  
 20 tion Act (42 U.S.C. 6872) is amended to read as follows:

21 “AUTHORIZATION OF APPROPRIATIONS

22 “SEC. 422. For the purpose of carrying out the  
 23 weatherization program under this part, there are author-  
 24 ized to be appropriated for fiscal years 1998 through 2002  
 25 such sums as may be necessary.”.
