1 **SECTION 1. FUNDS FOR CUSTOMS INSPECTIONAL PERSON-**
2 **NEL.**

3 (a) ACCESS TO CUSTOMS USER FEE ACCOUNT.—
4 Section 13031(f)(3)(A) of the Consolidated Omnibus
5 Budget Reconciliation Act of 1985 (19 U.S.C.
6 58c(f)(3)(A)), is amended—

7 (1) in clause (i)(V), by striking “and” at the
8 end;

9 (2) in clause (ii)—

10 (A) by striking “to make reimbursements”
11 and inserting “after making reimbursements”;
12 and

13 (B) by striking the period at the end and
14 inserting “, and”; and

15 (3) by inserting after clause (ii) the following:

16 “(iii) to the extent funds remain available after
17 making reimbursements under clause (ii), in provid-
18 ing salaries for up to 50 full-time equivalent
19 inspectional positions through September 30, 1998,
20 that enhance customs services in connection with the
21 arrival in Florida of passengers aboard commercial
22 vessels, regardless of whether those passengers are
23 required to pay fees under paragraphs (1) through
24 (8) of subsection (a).”.
