AN ACT

To extend the Advisory Council on California Indian Policy to allow the Advisory Council to advise Congress on the implementation of the proposals and recommendations of the Advisory Council.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Advisory Council on
3 California Indian Policy Extension Act of 1998”.

4 **SEC. 2. FINDING AND PURPOSE.**

5 (a) FINDING.—Congress finds that the Advisory
6 Council on California Indian Policy, pursuant to the Advi-
7 sory Council on California Indian Policy Act of 1992
8 (Public Law 102–416; 25 U.S.C. 651 note), submitted its
9 proposals and recommendations regarding remedial meas-
10 ures to address the special status of California’s termi-
11 nated and unacknowledged Indian tribes and the needs of
12 California Indians relating to economic self-sufficiency,
13 health, and education.

14 (b) PURPOSE.—The purpose of this Act is to allow
15 the Advisory Council on California Indian Policy to advise
16 Congress on the implementation of such proposals and
17 recommendations.

18 **SEC. 3. DUTIES OF ADVISORY COUNCIL REGARDING IMPLE-**
19 **MENTATION OF PROPOSALS AND REC-**
20 **COMMENDATIONS.**

21 (a) IN GENERAL.—Section 5 of the Advisory Council
22 on California Indian Policy Act of 1992 (106 Stat. 2133)
23 is amended by striking “and” at the end of paragraph (6),
24 by striking the period at the end of paragraph (7) and
25 inserting “; and”, and by adding at the end the following
26 new paragraph:

1 “(8) work with Congress, the Secretary, the
2 Secretary of Health and Human Services, and the
3 California Indian tribes, to implement the Council’s
4 proposals and recommendations contained in the re-
5 port submitted under paragraph (6), including—

6 “(A) consulting with Federal departments
7 and agencies to identify those recommendations
8 that can be implemented immediately, or in the
9 very near future, and those which will require
10 long-term changes in law, regulations, or policy;

11 “(B) working with Federal departments
12 and agencies to expedite to the greatest extent
13 possible the implementation of the Council’s
14 recommendations;

15 “(C) presenting draft legislation to Con-
16 gress for implementation of the recommenda-
17 tions requiring legislative changes;

18 “(D) initiating discussions with the State
19 of California and its agencies to identify specific
20 areas where State actions or tribal-State co-
21 operation can complement actions by the Fed-
22 eral Government to implement specific rec-
23 ommendations;

24 “(E) providing timely information to and
25 consulting with California Indian tribes on dis-

1 cussions between the Council and Federal and
2 State agencies regarding implementation of the
3 recommendations; and

4 “(F) providing annual progress reports to
5 the Committee on Indian Affairs of the Senate
6 and the Committee on Resources of the House
7 of Representatives on the status of the imple-
8 mentation of the recommendations.”.

9 (b) **TERMINATION.**—The first sentence of section 8
10 of the Advisory Council on California Indian Policy Act
11 of 1992 (106 Stat. 2136) is amended to read as follows:
12 “The Council shall cease to exist on March 31, 2000.”.

13 **SEC. 4. HEALTH OR SOCIAL SERVICES FACILITY.**

14 *Section 1004(a) of the Coast Guard Authorization Act*
15 *of 1996 (Public Law 104–324; 110 Stat. 3956) is amended*
16 *by striking “use other than for a facility for the provision*
17 *of health programs funded by the Indian Health Service*
18 *(not including any such programs operated by Ketchikan*
19 *Indian Corporation prior to 1993)” and inserting “use as*
20 *a health or social services facility”.*
