To amend the John F. Kennedy Center Act to authorize appropriations for the John F. Kennedy Center for the Performing Arts and to further define the criteria for capital repair and operation and maintenance.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “John F. Kennedy Cen-
3 ter for the Performing Arts Authorization Act of 1998”.

4 **SEC. 2. CAPITAL REPAIR DUTIES.**

5 Section 4(a)(1)(G) of the John F. Kennedy Center
6 Act (20 U.S.C. 76j(a)(1)(G)) is amended to read as fol-
7 lows:

8 “(G) with respect to the building and site
9 of the John F. Kennedy Center for the Per-
10 forming Arts, plan, design, and construct each
11 capital repair, replacement, improvement, reha-
12 bilitation, alteration, or modification necessary
13 to maintain the functionality of the building
14 and site at current standards of life, safety, se-
15 curity, and accessibility;”.

16 **SEC. 3. OPERATION AND MAINTENANCE DUTIES.**

17 Section 4(a)(1)(H)(ii) of the John F. Kennedy Cen-
18 ter Act (20 U.S.C. 76j(a)(1)(H)(ii)) is amended to read
19 as follows:

20 “(ii) with respect to the building and
21 site of the John F. Kennedy Center for the
22 Performing Arts, all necessary mainte-
23 nance, repair, and alteration of, and all
24 janitorial, security, and other services and
25 equipment necessary for the operations of,
26 the building and site, in a manner consist-

1 ent with requirements for high quality op-
 2 erations; and”.

3 **SEC. 4. REPEAL OF AUDIT REQUIREMENT.**

4 Section 6 of the John F. Kennedy Center Act (20
 5 U.S.C. 76l) is amended by striking subsection (d) and re-
 6 designating subsections (e) and (f) as subsections (d) and
 7 (e), respectively.

8 **SEC. 5. AUTHORIZATION OF APPROPRIATIONS.**

9 Section 12 of the John F. Kennedy Center Act (20
 10 U.S.C. 76r) is amended by striking subsections (a) and
 11 (b) and inserting the following:

12 “(a) MAINTENANCE, REPAIR, AND SECURITY.—
 13 There are authorized to be appropriated to the Board to
 14 carry out section 4(a)(1)(H)—

15 “(1) \$13,000,000 for fiscal year 1999;

16 “(2) \$14,000,000 for each of fiscal years 2000
 17 and 2001; and

18 “(3) \$15,000,000 for each of fiscal years 2002
 19 and 2003.

20 “(b) CAPITAL PROJECTS.—There are authorized to
 21 be appropriated to the Board to carry out subparagraphs
 22 (F) and (G) of section 4(a)(1)—

23 “(1) \$20,000,000 for each of fiscal years 1999,
 24 2000, and 2001;

25 “(2) \$19,000,000 for fiscal year 2002; and

1 “(3) \$17,000,000 for fiscal year 2003.”.
