1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

1 **SECTION 1. DESIGNATION.**

2 The Federal Courthouse located at 316 North 26th  
3 Street in Billings, Montana, shall be known and des-  
4 ignated as the “James F. Battin Federal Courthouse”.

5 **SEC. 2. REFERENCES.**

6 Any reference in a law, map, regulation, document,  
7 paper, or other record of the United States to the Federal  
8 Courthouse referred to in section 1 shall be deemed to be  
9 a reference to the “James F. Battin Federal Courthouse”.

10 **SECTION 1. DESIGNATION.**

11 *The United States courthouse located at 316 North*  
12 *26th Street in Billings, Montana, shall be known and des-*  
13 *ignated as the “James F. Battin United States Court-*  
14 *house”.*

15 **SEC. 2. REFERENCES.**

16 *Any reference in a law, map, regulation, document,*  
17 *paper, or other record of the United States to the United*  
18 *States courthouse referred to in section 1 shall be deemed*  
19 *to be a reference to the “James F. Battin United States*  
20 *Courthouse”.*

Amend the title so as to read: “A bill to designate the United States courthouse located at 316 North 26th Street in Billings, Montana, as the ‘James F. Battin United States Courthouse’.”.
