A BILL

Amending the Fastener Quality Act to exempt from its coverage certain fasteners approved by the Federal Aviation Administration for use in aircraft.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AMENDMENT.**

4 Section 15 of the Fastener Quality Act (15 U.S.C.
5 5414) is amended—

6 (1) by inserting “(a) TRANSITIONAL RULE.—”
7 before “The requirements of this Act”; and

8 (2) by adding at the end the following new sub-
9 section:

10 “(b) AIRCRAFT EXEMPTION.—

11 “(1) IN GENERAL.—The requirements of this
12 Act shall not apply to fasteners specifically manufac-
13 tured or altered for use on an aircraft if the quality
14 and suitability of those fasteners for that use has
15 been approved by the Federal Aviation Administra-
16 tion, except as provided in paragraph (2).

17 “(2) EXCEPTION.—Paragraph (1) shall not
18 apply to fasteners represented by the fastener manu-
19 facturer as having been manufactured in conform-
20 ance with standards or specifications established by
21 a consensus standards organization or a Federal
22 agency other than the Federal Aviation Administra-
23 tion.”.

1 **SECTION 1. AMENDMENT.**

2 *Section 15 of the Fastener Quality Act (15 U.S.C.*
3 *5414) is amended—*

4 *(1) by inserting “(a) TRANSITIONAL RULE.—”*
5 *before “The requirements of this Act”; and*

6 *(2) by adding at the end the following new sub-*
7 *section:*

8 *“(b) AIRCRAFT EXEMPTION.—*

9 *“(1) IN GENERAL.—The requirements of this Act*
10 *shall not apply to fasteners specifically manufactured*
11 *or altered for use on an aircraft if the quality and*
12 *suitability of those fasteners for that use has been ap-*
13 *proved by the Federal Aviation Administration, ex-*
14 *cept as provided in paragraph (2).*

15 *“(2) EXCEPTION.—Paragraph (1) shall not*
16 *apply to fasteners represented by the fastener manu-*
17 *facturer as having been manufactured in conformance*
18 *with standards or specifications established by a con-*
19 *sensus standards organization or a Federal agency*
20 *other than the Federal Aviation Administration.”.*

21 **SEC. 2. DELAYED IMPLEMENTATION OF REGULATIONS.**

22 *The regulations issued under the Fastener Quality Act*
23 *by the National Institute of Standards and Technology on*
24 *April 14, 1998, and any other regulations issued by the Na-*
25 *tional Institute of Standards and Technology covering the*
26 *same or similar subjects, shall not take effect until after*

1 *the later of June 1, 1999, or the expiration of 120 days*
2 *after the Secretary of Commerce transmits to the Congress*
3 *a report on—*

4 (1) *changes in fastener manufacturing processes*
5 *that have occurred since the enactment of the Fastener*
6 *Quality Act; and*

7 (2) *any changes in that Act that may be war-*
8 *ranted because of the changes reported under para-*
9 *graph (1).*

10 *The report required by this section shall be transmitted to*
11 *the Congress by February 1, 1999.*
