3 **SECTION 1. DESIGNATION.**

4 The United States courthouse to be constructed at
5 the corner of Superior and Huron Roads, in Cleveland,
6 Ohio, shall be known and designated as the “Carl B.
7 Stokes United States Courthouse”.

8 **SEC. 2. REFERENCES.**

9 Any reference in a law, map, regulation, document,
10 paper, or other record of the United States to the United
11 States courthouse referred to in section 1 shall be deemed
12 to be a reference to the “Carl B. Stokes United States
