A BILL

To facilitate a land exchange involving private land within the exterior boundaries of Wenatchee National Forest in Chelan County, Washington.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. TREATMENT OF CERTAIN LANDS ACQUIRED BY**
2 **LAND EXCHANGE, WENATCHEE NATIONAL**
3 **FOREST, WASHINGTON.**

4 (a) ADMINISTRATION BY SECRETARY OF THE INTE-
5 RIOR.—Notwithstanding section 206(e) of the Federal
6 Land Policy and Management Act of 1976 (43 U.S.C.
7 1716(e)), any lands described in subsection (b) that are
8 acquired by the Secretary of the Interior by exchange shall
9 be administered by the Secretary through the Bureau of
10 Land Management. The acquired lands shall not be re-
11 served for or become a part of the Wenatchee National
12 Forest.

13 (b) COVERED LANDS.—The lands referred to in sub-
14 section (a) are those lands located within that portion of
15 the Wenatchee National Forest in Chelan County, Wash-
16 ington, encompassed by section 1 of township 23 north,
17 range 19 east, Willamette meridian.

18 **SECTION 1. BOUNDARY ADJUSTMENT, WENATCHEE NA-**
19 **TIONAL FOREST, WASHINGTON.**

20 *The boundary of the Wenatchee National Forest in*
21 *Chelan County, Washington, is hereby adjusted to exclude*
22 *section 1 of Township 23 North, Range 19 East, Willamette*
23 *Meridian.*
