Ms. PRYCE of Ohio, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 867) to promote the adoption of children in foster care.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 867) to promote the adoption of
6 children in foster care. The first reading of the bill shall
7 be dispensed with. Points of order against consideration

1 of the bill for failure to comply with clause 2(1)(6) of rule
2 XI or section 303(a) or 308(a) of the Congressional Budg-
3 et Act of 1974 are waived. General debate shall be con-
4 fined to the bill and shall not exceed one hour equally di-
5 vided and controlled by the chairman and ranking minor-
6 ity member of the Committee on Ways and Means. After
7 general debate the bill shall be considered for amendment
8 under the five-minute rule. It shall be in order to consider
9 as an original bill for the purpose of amendment under
10 the five-minute rule the amendment in the nature of a sub-
11 stitute recommended by the Committee on Ways and
12 Means now printed in the bill, modified as specified in the
13 report of the Committee on Rules accompanying this reso-
14 lution. Each section of the committee amendment in the
15 nature of a substitute, as modified, shall be considered as
16 read. Points of order against the committee amendment
17 in the nature of a substitute, as modified, for failure to
18 comply with clause 7 of rule XVI or section 303(a) or 306
19 of the Congressional Budget Act of 1974 are waived. Dur-
20 ing consideration of the bill for amendment, the Chairman
21 of the Committee of the Whole may accord priority in rec-
22 ognition on the basis of whether the Member offering an
23 amendment has caused it to be printed in the portion of
24 the Congressional Record designated for that purpose in
25 clause 6 of rule XXIII. Amendments so printed shall be

1 considered as read. At the conclusion of consideration of
2 the bill for amendment the Committee shall rise and re-
3 port the bill to the House with such amendments as may
4 have been adopted. Any Member may demand a separate
5 vote in the House on any amendment adopted in the Com-
6 mittee of the Whole to the bill or to the committee amend-
7 ment in the nature of a substitute, as modified. The pre-
8 vious question shall be considered as ordered on the bill
9 and amendments thereto to final passage without inter-
10 vening motion except one motion to recommit with or
11 without instructions.
