Mr. SOLOMON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the concurrent resolution (H. Con. Res. 84) establishing the congressional budget for the United States Government for fiscal year 1998 and setting forth appropriate budgetary levels for fiscal years 1999, 2000, 2001, and 2002.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the concurrent resolution (H. Con. Res. 84) estab-

1 lishing the congressional budget for the United States
2 Government for fiscal year 1998 and setting forth appro-
3 priate budgetary levels for fiscal years 1990, 2000, 2001,
4 and 2002. The first reading of the concurrent resolution
5 shall be dispensed with. All points of order against the
6 concurrent resolution and against its consideration are
7 waived. General debate shall be confined to the congres-
8 sional budget and shall not exceed five hours and twenty
9 minutes (including one hour on the subject of economic
10 goals and policies), with five hours equally divided and
11 controlled by the chairman and ranking minority member
12 of the Committee on the Budget and twenty minutes con-
13 trolled by Representative Minge of Minnesota or his des-
14 ignee. After general debate the concurrent resolution shall
15 be considered for amendment under the five-minute rule.
16 The concurrent resolution shall be considered as read. No
17 amendment shall be in order except the amendments in
18 the nature of substitutes designated in section 2 of this
19 resolution, if printed in the portion of the Congressional
20 Record designated for that purpose in clause 6 of rule
21 XXIII. Each amendment may be offered only in the order
22 designated, may be offered only by a Member designated,
23 shall be considered as read, shall be debatable for twenty
24 minutes (except as otherwise provided in section 2) equally
25 divided and controlled by the proponent and an opponent,

1 and shall not be subject to amendment. All points of order
2 against the amendments designated in section 2 are
3 waived except that the adoption of an amendment in the
4 nature of a substitute shall constitute the conclusion of
5 consideration of the concurrent resolution for amendment.
6 The Chairman of the Committee of the Whole may: (1)
7 postpone until a time during further consideration in the
8 Committee of the Whole a request for a recorded vote on
9 any amendment; and (2) reduce to five minutes the mini-
10 mum time for electronic voting on any postponed question
11 that follows another electronic vote without intervening
12 business, provided that the minimum time for electronic
13 voting on the first in any series of questions shall be fif-
14 teen minutes. After the conclusion of consideration of the
15 concurrent resolution for amendment, the Committee shall
16 rise and report the concurrent resolution to the House
17 with such amendments as may have been adopted. The
18 previous question shall be considered as ordered on the
19 concurrent resolution and amendments thereto to final
20 adoption without intervening motion except amendments
21 offered by the chairman of the Committee on the Budget
22 pursuant to section 305(a)(5) of the Congressional Budget
23 Act of 1974 to achieve mathematical consistency. The con-
24 current resolution shall not be subject to a demand for
25 division of the question of its adoption.

1 SEC. 2. The following amendments are in order pur-
2 suant to the first section of this resolution:

3 (1) the amendment numbered 1, which shall be
4 debatable for one hour;

5 (2) the amendment numbered 2;

6 (3) the amendment numbered 3;

7 (4) the amendment numbered 4; and

8 (5) the amendment numbered 5.

9 SEC. 3. Rule XLIX shall not apply with respect to
10 the adoption by the Congress of a concurrent resolution
11 on the budget for fiscal year 1998.
