Mr. LINDER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2846) to prohibit spending Federal education funds on national testing without explicit and specific legislation.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 2846) to prohibit spending Federal
6 education funds on national testing without explicit and
7 specific legislation. The first reading of the bill shall be

1 dispensed with. General debate shall be confined to the
2 bill and shall not exceed one hour equally divided and con-
3 trolled by the chairman and ranking minority member of
4 the Committee on Education and the Workforce. After
5 general debate the bill shall be considered for amendment
6 under the five-minute rule. It shall be in order to consider
7 as an original bill for the purpose of amendment under
8 the five-minute rule the amendment in the nature of a sub-
9 stitute recommended by the Committee on Education and
10 the Workforce now printed in the bill. The committee
11 amendment in the nature of a substitute shall be consid-
12 ered as read. During consideration of the bill for amend-
13 ment, the Chairman of the Committee of the Whole may
14 accord priority in recognition on the basis of whether the
15 Member offering an amendment has caused it to be print-
16 ed in the portion of the Congressional Record designated
17 for that purpose in clause 6 of rule XXIII. Amendments
18 so printed shall be considered as read. The Chairman of
19 the Committee of the Whole may: (1) postpone until a
20 time during further consideration in the Committee of the
21 Whole a request for a recorded vote on any amendment;
22 and (2) reduce to five minutes the minimum time for elec-
23 tronic voting on any postponed question that follows an-
24 other electronic vote without intervening business, pro-
25 vided that the minimum time for electronic voting on the

1 first in any series of questions shall be fifteen minutes.
2 At the conclusion of consideration of the bill for amend-
3 ment the Committee shall rise and report the bill to the
4 House with such amendments as may have been adopted.
5 Any Member may demand a separate vote in the House
6 on any amendment adopted in the Committee of the Whole
7 to the bill or to the committee amendment in the nature
8 of a substitute. The previous question shall be considered
9 as ordered on the bill and amendments thereto to final
10 passage without intervening motion except one motion to
11 recommit with or without instructions.
