Mr. DIAZ-BALART, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2431) to establish an Office of Religious Persecution Monitoring, to provide for the imposition of sanctions against countries engaged in a pattern of religious persecution, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-

1 ation of the bill (H.R. 2431) to establish an Office of Reli-
2 gious Persecution Monitoring, to provide for the imposi-
3 tion of sanctions against countries engaged in a pattern
4 of religious persecution, and for other purposes. The first
5 reading of the bill shall be dispensed with. General debate
6 shall be confined to the bill and shall not exceed one hour
7 equally divided and controlled by the chairman and rank-
8 ing minority member of the Committee on International
9 Relations. After general debate the bill shall be considered
10 for amendment under the five-minute rule. In lieu of the
11 amendments recommended by the Committees on Inter-
12 national Relations, the Judiciary, and Ways and Means
13 now printed in the bill, it shall be in order to consider
14 as an original bill for the purpose of amendment under
15 the five-minute rule an amendment in the nature of a sub-
16 stitute consisting of the text of H.R. 3806, modified by
17 the amendments printed in part 1 of the report of the
18 Committee on Rules accompanying this resolution. That
19 amendment in the nature of a substitute shall be consid-
20 ered as read. No amendment to that amendment in the
21 nature of a substitute shall be in order except those print-
22 ed in part 2 of the report of the Committee on Rules. Each
23 amendment may be offered only in the order printed in
24 the report, may be offered only by a Member designated
25 in the report, shall be considered as read, shall be debat-

1 able for the time specified in the report equally divided
2 and controlled by the proponent and an opponent, shall
3 not be subject to amendment, and shall not be subject to
4 a demand for division of the question in the House or in
5 the Committee of the Whole. All points of order against
6 the amendments printed in the report are waived. At the
7 conclusion of consideration of the bill for amendment the
8 Committee shall rise and report the bill to the House with
9 such amendments as may have been adopted. Any Member
10 may demand a separate vote in the House on any amend-
11 ment adopted in the Committee of the Whole to the bill
12 or to the amendment in the nature of a substitute made
13 in order as original text. The previous question shall be
14 considered as ordered on the bill and amendments thereto
15 to final passage without intervening motion except one
16 motion to recommit with or without instructions.
