Mr. SOLOMON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4101) making appropriations for Agriculture, Rural Development, Food and Drug Administration, and Related Agencies programs for the fiscal year ending September 30, 1999, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 4101) making appropriations for

1 Agriculture, Rural Development, Food and Drug Adminis-
2 tration, and Related Agencies programs for the fiscal year
3 ending September 30, 1999, and for other purposes. The
4 first reading of the bill shall be dispensed with. Points of
5 order against consideration of the bill for failure to comply
6 with clause 2(1)(6) of rule XI or clause 7 of rule XXI are
7 waived. General debate shall be confined to the bill and
8 shall not exceed one hour equally divided and controlled
9 by the chairman and ranking minority member of the
10 Committee on Appropriations. After general debate the
11 bill shall be considered for amendment under the five-
12 minute rule. The amendment printed in the report of the
13 Committee on Rules accompanying this resolution shall be
14 considered as adopted in the House and in the Committee
15 of the Whole. Points of order against provisions in the
16 bill, as amended, for failure to comply with clause 2 or
17 6 of rule XXI are waived. During consideration of the bill
18 for further amendment, the Chairman of the Committee
19 of the Whole may accord priority in recognition on the
20 basis of whether the Member offering an amendment has
21 caused it to be printed in the portion of the Congressional
22 Record designated for that purpose in clause 6 of rule
23 XXIII. Amendments so printed shall be considered as
24 read. The Chairman of the Committee of the Whole may:
25 (1) postpone until a time during further consideration in

1 the Committee of the Whole a request for a recorded vote
2 on any amendment; and (2) reduce to five minutes the
3 minimum time for electronic voting on any postponed
4 question that follows another electronic vote without inter-
5 vening business, provided that the minimum time for elec-
6 tronic voting on the first in any series of questions shall
7 be 15 minutes. At the conclusion of consideration of the
8 bill for amendment the Committee shall rise and report
9 the bill, as amended, to the House with such amendments
10 as may have been adopted. The previous question shall
11 be considered as ordered on the bill and amendments
12 thereto to final passage without intervening motion except
13 one motion to recommit with or without instructions.
