AN ACT

To adjust the boundary of the William Howard Taft National
Historic Site in the State of Ohio, to authorize an ex-
change of land in connection with the historic site, and
for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “William Howard Taft
3 National Historic Site Boundary Adjustment Act of
4 2001”.

5 **SEC. 2. EXCHANGE OF LANDS AND BOUNDARY ADJUST-**
6 **MENT, WILLIAM HOWARD TAFT NATIONAL**
7 **HISTORIC SITE, OHIO.**

8 (a) DEFINITIONS.—In this section:

9 (1) HISTORIC SITE.—The term “historic site”
10 means the William Howard Taft National Historic
11 Site in Cincinnati, Ohio, established pursuant to
12 Public Law 91–132 (83 Stat. 273; 16 U.S.C. 461
13 note).

14 (2) MAP.—The term “map” means the map en-
15 titled “Proposed Boundary Map, William Howard
16 Taft National Historic Site, Hamilton County, Cin-
17 cinnati, Ohio,” numbered 448/80,025, and dated
18 November 2000.

19 (3) SECRETARY.—The term “Secretary” means
20 the Secretary of the Interior, acting through the Di-
21 rector of the National Park Service.

22 (b) AUTHORIZATION OF LAND EXCHANGE.—

23 (1) EXCHANGE.—The Secretary may acquire a
24 parcel of real property consisting of less than one
25 acre, which is depicted on the map as the “Proposed
26 Exchange Parcel (Outside Boundary)”, in exchange

1 for a parcel of real property, also consisting of less
2 than one acre, which is depicted on the map as the
3 “Current USA Ownership (Inside Boundary)”.

4 (2) EQUALIZATION OF VALUES.—If the values
5 of the parcels to be exchanged under paragraph (1)
6 are not equal, the difference may be equalized by do-
7 nation, payment using donated or appropriated
8 funds, or the conveyance of additional land.

9 (3) ADJUSTMENT OF BOUNDARY.—The Sec-
10 retary shall revise the boundary of the historic site
11 to reflect the exchange upon its completion.

12 (c) ADDITIONAL BOUNDARY REVISION AND ACQUISI-
13 TION AUTHORITY.—

14 (1) INCLUSION OF PARCEL IN BOUNDARY.—Ef-
15 fective on the date of the enactment of this Act, the
16 boundary of the historic site is revised to include an
17 additional parcel of real property, which is depicted
18 on the map as the “Proposed Acquisition”.

19 (2) ACQUISITION AUTHORITY.—The Secretary
20 may acquire the parcel referred to in paragraph (1)
21 by donation, purchase from willing sellers with do-
22 nated or appropriated funds, or exchange.

23 (d) AVAILABILITY OF MAP.—The map shall be on file
24 and available for public inspection in the appropriate of-
25 fices of the National Park Service.

1 (e) ADMINISTRATION OF ACQUIRED LANDS.—Any
2 lands acquired under this section shall be administered by
3 the Secretary as part of the historic site in accordance
4 with applicable laws and regulations.
