Mr. SCHAFER introduced the following bill; which was referred to the Committee on Resources

A BILL

To amend the Cache La Poudre River Corridor Act to make technical amendments.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Cache la Poudre River
5 Corridor Technical Amendments Act of 2001”.

6 **SEC. 2. CACHE LA POUFRE RIVER CORRIDOR.**

7 Section 103(b) of the Cache La Poudre River Cor-
8 ridor Act (16 U.S.C. 461 note; Public Law 104–323) is
9 amended in paragraphs (12) through (19) by striking

1 “LARIMER COUNTY” each place it appears and inserting
2 “WELD COUNTY”.

3 **SEC. 3. CACHE LA POUFRE RIVER CORRIDOR COMMISSION.**

4 Section 104 of the Cache La Poudre River Corridor
5 Act (16 U.S.C. 461 note; Public Law 104–323) is
6 amended—

7 (1) by striking subsection (a) and inserting the
8 following:

9 “(a) IN GENERAL.—There is established a commis-
10 sion to be known as the ‘Cache La Poudre Corridor Com-
11 mission.’”; and

12 (2) in subsection (b)—

13 (A) by striking “The Secretary may pro-
14 vide recognition under subsection (a) only if the
15 Commission reflects the following.”;

16 (B) in paragraph (1)(A)—

17 (i) by striking “6 months after the
18 date of enactment of this Act” and insert-
19 ing the following: “180 days after the date
20 of enactment of the Cache la Poudre River
21 Corridor Technical Amendments Act of
22 2001”;

23 (ii) by striking clause (iii) and insert-
24 ing the following:

1 “(iii) 3 members who reside in
2 Larimer County or Weld County, and who
3 are knowledgeable in the interests of the
4 Corridor, shall be appointed by the Sec-
5 retary from a list of candidates rec-
6 ommended by the Governor, of whom—

7 “(I) 1 member shall represent
8 the State;

9 “(II) 1 member shall represent
10 Colorado State University in Fort
11 Collins, Colorado; and

12 “(III) 1 member shall represent
13 the Northern Colorado Water Conser-
14 vancy District;”;

15 (iii) in clause (iv)—

16 (I) by striking “who are rec-
17 ommended by the Governor and ap-
18 pointed by the Secretary,” and insert-
19 ing “who shall be appointed by the
20 Secretary from a list of candidates
21 recommended by the Governor,”;

22 (II) by striking subclause (II)
23 and inserting the following:

24 “(II) 2 members, who shall reside
25 in Larimer County and shall be

1 knowledgeable in the interests of
2 Larimer County, and of whom 1 shall
3 be knowledgeable in agriculture or ir-
4 rigated water interests, shall represent
5 Larimer County;”;

6 (III) by striking subclause (IV)
7 and inserting the following:

8 “(IV) 2 members, who shall re-
9 side in Weld County and shall be
10 knowledgeable in the interests of Weld
11 County, and of whom 1 shall be
12 knowledgeable in agriculture or irri-
13 gated water interests, shall represent
14 Weld County;”;

15 (IV) in clause (V), by striking
16 “and” at the end;

17 (iv) in clause (v)—

18 (I) by striking “shall be rec-
19 ommended by the Governor and ap-
20 pointed by the Secretary,” and insert-
21 ing “shall be appointed by the Sec-
22 retary from a list of candidates rec-
23 ommended by the Governor;”;

24 (II) in subclause (III)—

1 (aa) by striking “within”
2 and inserting “in the vicinity of”;
3 and

4 (bb) by striking the period
5 at the end and inserting “; and”;
6 and

7 (v) by inserting after clause (v) the
8 following:

9 “(vi) the members appointed under
10 clauses (iii) through (v) of paragraph
11 (1)(A) shall be considered to be govern-
12 ment employees subject to the Ethics in
13 Government Act (5 U.S.C. App.).”; and

14 (C) in paragraph (2), by striking subpara-
15 graph (B) and inserting the following:

16 “(B) INITIAL MEMBERS.—

17 “(i) IN GENERAL.—The initial mem-
18 bers of the Commission appointed under
19 paragraph (1)(A) shall be appointed in ac-
20 cordance with clauses (ii) through (iv).

21 “(ii) 3-YEAR TERMS.—The following
22 initial members shall serve for a 3-year
23 term:

24 “(I) The member appointed
25 under paragraph (1)(A)(i).

1 “(II) 1 member appointed under
2 paragraph (1)(A)(iv)(II).

3 “(III) 1 member appointed under
4 paragraph (1)(A)(iv)(IV).

5 “(IV) 1 member appointed under
6 paragraph (1)(A)(iv)(V).

7 “(V) 1 member appointed under
8 paragraph (1)(A)(v).

9 “(iii) 2-YEAR TERMS.—The following
10 initial members shall serve for a 2-year
11 term:

12 “(I) The member appointed
13 under paragraph (1)(A)(ii).

14 “(II) The member appointed
15 under paragraph (1)(A)(iii)(I).

16 “(III) The member appointed
17 under paragraph (1)(A)(iii)(II).

18 “(IV) 1 member appointed under
19 paragraph (1)(A)(iii)(III).

20 “(iv) 1-YEAR TERMS.—The following
21 initial members shall serve for a 1-year
22 term:

23 “(I) The member appointed
24 under paragraph (1)(A)(iv)(I).

1 “(II) 1 member appointed under
2 paragraph (1)(A)(iv)(II).

3 “(III) 1 member appointed under
4 paragraph (1)(A)(iv)(III).

5 “(IV) 1 member appointed under
6 paragraph (1)(A)(iv)(IV).

7 “(V) 1 member appointed under
8 paragraph (1)(A)(v).”.

9 **SEC. 4. DUTIES OF COMMISSION.**

10 Section 107 of the Cache La Poudre River Corridor
11 Act (16 U.S.C. 461 note; Public Law 104–323) is amend-
12 ed by striking subsection (a) and inserting the following:

13 “(a) IN GENERAL.—The Commission shall—

14 “(1) prepare, obtain approval for, implement,
15 and support the Plan in accordance with section
16 108;

17 “(2) administer the Corridor; and

18 “(3) carry out all other duties of the Commis-
19 sion under this Act.”;

20 **SEC. 5. AUTHORIZATION OF APPROPRIATIONS.**

21 Section 113(a) of the Cache La Poudre River Cor-
22 ridor Act (16 U.S.C. 461 note; Public Law 104–323) is
23 amended by striking “date of enactment of this Act” and
24 inserting the following: “date of enactment of the Cache

1 la Poudre River Corridor Technical Amendments Act of
2 2001”.
