2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. STUDY AND REPORT REGARDING WACO MAM-**
2 **MOTH SITE AREA.**

3 (a) *STUDY.*—*The Secretary of the Interior, in con-*
4 *sultation with the State of Texas, the city of Waco, and*
5 *other appropriate organizations, shall carry out a special*
6 *resource study regarding the national significance, suit-*
7 *ability, and feasibility of designating the Waco Mammoth*
8 *Site Area located in the city of Waco, Texas, as a unit of*
9 *the National Park System.*

10 (b) *STUDY PROCESS AND COMPLETION.*—*Section 8(c)*
11 *of Public Law 91–383 (16 U.S.C. 1a–5(c)) shall apply to*
12 *the conduct and completion of the study required by this*
13 *section.*

14 (c) *SUBMISSION OF STUDY RESULTS.*—*Not later than*
15 *3 years after funds are first made available for this section,*
16 *the Secretary shall submit to the Committee on Resources*
17 *of the House of Representatives and the Committee on En-*
18 *ergy and Natural Resources of the Senate a report describ-*
19 *ing the results of the study.*
