A BILL

To authorize the Secretary of the Interior to conduct a special resource study of Virginia Key Beach, Florida, for possible inclusion in the National Park System.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. STUDY AND REPORT.**

4 (a) *STUDY.*—*The Secretary of the Interior (in this Act*
5 *referred to as “the Secretary”)* shall conduct a study of Vir-
6 *ginia Key Beach Park in Biscayne Bay, Florida, which*
7 *was used for recreation by African Americans at a time*
8 *when public beaches were racially segregated by law. The*
9 *study shall evaluate the national significance of the site and*
10 *the suitability and feasibility of establishing the site as a*
11 *unit of the National Park System.*

12 (b) *CRITERIA.*—*In conducting the study required by*
13 *subsection (a), the Secretary shall use the criteria for the*
14 *study of areas for potential inclusion in the National Park*
15 *System contained in section 8 of Public Law 91–383 (16*
16 *U.S.C. 1a–5; popularly known as the National Park System*
17 *General Authorities Act).*

18 (c) *REPORT.*—*Upon completion of the study, the Sec-*
19 *retary shall transmit to the Congress a report on the find-*
20 *ings of the study and the conclusions and recommendations*
21 *of the Secretary.*

Amend the title so as to read: “A bill to authorize the Secretary of the Interior to conduct a special resource study of Virginia Key Beach Park in Biscayne Bay, Florida, for possible inclusion in the National Park System.”.
