A BILL

To make clerical and other technical amendments to title 18, United States Code, and other laws relating to crime and criminal procedure.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Criminal Law Tech-
5 nical Amendments Act of 2001”.

1 **SEC. 2. TECHNICAL AMENDMENTS RELATING TO CRIMINAL**
2 **LAW AND PROCEDURE.**

3 (a) **MISSING AND INCORRECT WORDS.—**

4 (1) **CORRECTION OF GARBLED SENTENCE.—**

5 Section 510(c) of title 18, United States Code, is
6 amended by striking “fine of under this title” and
7 inserting “fine under this title”.

8 (2) **INSERTION OF MISSING WORDS.—**Section

9 981(d) of title 18, United States Code, is amended
10 by striking “proceeds from the sale of this section”
11 and inserting “proceeds from the sale of such prop-
12 erty under this section”.

13 (3) **CORRECTION OF INCORRECT WORD.—**Sec-

14 tions 1425 through 1427, 1541 through 1544 and
15 1546(a) of title 18, United States Code, are each
16 amended by striking “to facility” and inserting “to
17 facilitate”.

18 (4) **CORRECTING ERRONEOUS AMENDATORY**

19 **LANGUAGE ON EXECUTED AMENDMENT.—**Effective

20 on the date of the enactment of Public Law 103–
21 322, section 60003(a)(13) of such public law is
22 amended by striking “\$1,000,000 or imprisonment”
23 and inserting “\$1,000,000 and imprisonment”.

24 (5) **INSERTION OF MISSING WORD.—**Section

25 3286 of title 18, United States Code, is amended by
26 inserting “section” before “2332b”.

1 (6) CORRECTION OF REFERENCE TO SHORT
2 TITLE OF LAW.—That section 2332d(a) of title 18,
3 United States Code, which relates to financial trans-
4 actions is amended by inserting “of 1979” after
5 “Export Administration Act”.

6 (7) ELIMINATION OF TYPO.—Section 1992(b)
7 of title 18, United States Code, is amended by strik-
8 ing “term or years” and inserting “term of years”.

9 (8) SPELLING CORRECTION.—Section 2339A(a)
10 of title 18, United States Code, is amended by strik-
11 ing “or an escape” and inserting “of an escape”.

12 (9) SECTION 3553.—Section 3553(e) of title 18,
13 United States Code, is amended by inserting “a” be-
14 fore “minimum”.

15 (10) MISSPELLING IN SECTION 205.—Section
16 205(d)(1)(B) of title 18, United States Code, is
17 amended by striking “groups’s” and inserting
18 “group’s”.

19 (11) CONFORMING CHANGE AND INSERTING
20 MISSING WORD IN SECTION 709.—The paragraph in
21 section 709 of title 18, United States Code, that be-
22 gins with “A person who” is amended—

23 (A) by striking “A person who” and insert-
24 ing “Whoever”; and

1 (B) by inserting “or” after the semicolon
2 at the end.

3 (12) ERROR IN LANGUAGE BEING STRICKEN.—
4 Effective on the date of its enactment, section
5 726(2) of the Antiterrorism and Effective Death
6 Penalty Act of 1996 (Public Law 104–132) is
7 amended—

8 (A) in subparagraphs (C) and (E), by
9 striking “section” the first place it appears; and

10 (B) in subparagraph (G), by striking “re-
11 lating to” the first place it appears.

12 (b) MARGINS, PUNCTUATION, AND SIMILAR ER-
13 RORS.—

14 (1) MARGIN ERROR.—Section 1030(c)(2) of
15 title 18, United States Code, is amended so that the
16 margins of subparagraph (B) and each of its
17 clauses, are moved 2 ems to the left.

18 (2) CORRECTING CAPITALIZATION IN LAN-
19 GUAGE TO BE STRICKEN.—Effective on the date of
20 its enactment, section 607(g)(2) of the Economic
21 Espionage Act of 1996 is amended by striking “ter-
22 ritory” and inserting “Territory”.

23 (3) CORRECTING PARAGRAPHING.—The mate-
24 rial added to section 521(a) of title 18, United
25 States Code, by section 607(q) of the Economic Es-

1 pionage Act of 1996 is amended to appear as a
2 paragraph indented 2 ems from the left margin.

3 (4) SUBSECTION PLACEMENT CORRECTION.—
4 Section 1513 of title 18, United States Code, is
5 amended by transferring subsection (d) so that it
6 appears following subsection (c).

7 (5) INSERTION OF PARENTHETICAL DESCRIP-
8 TIONS.—Section 2332b(g)(5)(B)(i) of title 18,
9 United States Code, is amended—

10 (A) by inserting “(relating to certain
11 killings in Federal facilities)” after “930(c)”;

12 (B) by inserting “(relating to wrecking
13 trains)” after “1992”; and

14 (C) by striking “2332c.”.

15 (6) CORRECTION TO ALLOW FOR INSERTION OF
16 NEW SUBPARAGRAPH AND CORRECTION OF ERRO-
17 NEOUS INDENTATION.—Section 1956(c)(7) of title
18 18, United States Code, is amended—

19 (A) in subparagraph (B)(ii), by moving the
20 margin 2 ems to the right;

21 (B) by striking “or” at the end of subpara-
22 graph (D);

23 (C) by striking the period at the end of
24 subparagraph (E) and inserting “; or”; and

1 (D) in subparagraph (F), by striking
2 “Any” and inserting “any”.

3 (7) CORRECTION OF CONFUSING SUBDIVISION
4 DESIGNATION.—Section 1716 of title 18, United
5 States Code, is amended—

6 (A) in the first undesignated paragraph, by
7 inserting “(j)(1)” before “Whoever”;

8 (B) in the second undesignated
9 paragraph—

10 (i) by striking “not more than
11 \$10,000” and inserting “under this title”;
12 and

13 (ii) by inserting “(2)” at the begin-
14 ning of that paragraph;

15 (C) by inserting “(3)” at the beginning of
16 the third undesignated paragraph; and

17 (D) by redesignating subsection (j) as sub-
18 section (k).

19 (8) PUNCTUATION CORRECTION IN SECTION
