## A BILL

To amend the Violent Crime Control and Law Enforcement Act of 1994 to provide enhanced penalties for crimes of violence against children under age 13.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as “Matthew’s Law”.

5 **SEC. 2. ENHANCED PENALTIES FOR CRIMES OF VIOLENCE**

6 **AGAINST CHILDREN UNDER AGE 13.**

7 (a) IN GENERAL.—Title XVII of the Violent Crime  
8 Control and Law Enforcement Act of 1994 is amended  
9 by adding at the end the following:

1 **“Subtitle C—Enhanced Penalties**  
2 **for Crimes of Violence Against**  
3 **Children Under Age 13**

4 **“SEC. 170301. ENHANCED PENALTIES FOR CRIMES OF VIO-**  
5 **LENCE AGAINST CHILDREN UNDER AGE 13.**

6 “(a) IN GENERAL.—The United States Sentencing  
7 Commission shall amend the Federal sentencing guidelines  
8 to provide a sentencing enhancement of not less than 5  
9 levels above the offense level otherwise provided for a  
10 crime of violence, if the crime of violence is against a child.

11 “(b) DEFINITIONS.—In this section—

12 “(1) the term ‘crime of violence’ means any  
13 crime punishable by imprisonment for a term ex-  
14 ceeding one year that has as an element the use, at-  
15 tempted use, or threatened use of physical force  
16 against the person of another; and

17 “(2) the term ‘child’ means a person who has  
18 not attained 13 years of age at the time of the of-  
19 fense.”.

20 (b) CONFORMING REPEAL.—Section 240002 of such  
21 Act (28 U.S.C. 994 note) is repealed.

22 (c) CLERICAL AMENDMENT.—The table of contents  
23 of such Act is amended by striking the item relating to  
24 subtitle C of title XVII and the items relating to sections  
25 170301 through 170303 and inserting the following:

“Subtitle C—Enhanced Penalties for Crimes of Violence Against Children  
Under Age 13

“Sec. 170301. Enhanced penalties for crimes of violence against children under  
age 13.”.

1 **SEC. 3. FEDERAL BUREAU OF INVESTIGATION ASSISTANCE**  
2 **AVAILABLE TO STATE OR LOCAL LAW AU-**  
3 **THORITIES IN INVESTIGATING POSSIBLE**  
4 **HOMICIDES OF CHILDREN UNDER THE AGE**  
5 **OF 13.**

6 To the maximum extent practicable, the Federal Bu-  
7 reau of Investigation may provide to State and local law  
8 enforcement authorities such assistance as such authori-  
9 ties may require in investigating the death of an individual  
10 who has not attained 13 years of age under circumstances  
11 indicating that the death may have been a homicide.
