## A BILL

To authorize emergency appropriations for fiscal year 2002 for the Department of Defense to respond to the infrastructure sustainment and restoration crisis and spare and repair parts shortages adversely affecting the readiness of the Armed Forces and the quality of life of members of the Armed Forces and their families on military installations.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “National Defense  
3 Emergency Authorization Act for Fiscal Year 2002”.

4 **SEC. 2. AUTHORIZATION OF EMERGENCY APPROPRIA-**  
5 **TIONS.**

6 (a) **AUTHORIZATION OF APPROPRIATIONS.**—Funds  
7 are hereby authorized to be appropriated for fiscal year  
8 2002 to the Secretary of Defense for the use of the Armed  
9 Forces and other activities and agencies of the Depart-  
10 ment of Defense for expenses, not otherwise provided for,  
11 for the following operation and maintenance purposes and  
12 in the following amounts:

13 (1) For infrastructure sustainment and restora-  
14 tion, \$5,000,000,000.

15 (2) For acquisition of spare and repair parts,  
16 \$1,000,000,000.

17 (b) **TREATMENT AS ADDITIONAL AUTHORIZATION.**—  
18 The amounts authorized to be appropriated by subsection  
19 (a) are in addition to amounts otherwise authorized to be  
20 appropriated for fiscal year 2002 for the use of the Armed  
21 Forces and other activities and agencies of the Depart-  
22 ment of Defense.

23 (c) **EMERGENCY DESIGNATION.**—Amounts appro-  
24 priated pursuant to the authorization of appropriations in  
25 subsection (a)—

1           (1) may be designated by Congress as an emer-  
2           gency requirement pursuant to section 251(b)(2)(A)  
3           of the Balanced Budget and Emergency Deficit Con-  
4           trol Act of 1985; and

5           (2) shall be available only if an official budget  
6           request for the entire amount appropriated, that in-  
7           cludes designation of the entire amount as an emer-  
8           gency requirement as defined in the Balanced Budg-  
9           et and Emergency Deficit Control Act of 1985, is  
10          transmitted by the President to Congress.

11 **SEC. 3. TRANSFER AUTHORITY.**

12          (a) **INFRASTRUCTURE SUSTAINMENT AND RESTORA-**  
13 **TION.**—The Secretary of Defense may transfer amounts  
14 appropriated pursuant to the authorization of appropria-  
15 tions in section 2(a)(1) as follows:

16           (1) For the Army, \$1,000,000,000.

17           (2) For the Navy, \$1,000,000,000.

18           (3) For the Marine Corps, \$500,000,000.

19           (4) For the Air Force, \$1,000,000,000.

20           (5) For Defense-wide activities, \$500,000,000.

21          (b) **SPARE AND REPAIR PARTS ACQUISITION.**—The  
22 Secretary of Defense may transfer amounts appropriated  
23 pursuant to the authorization of appropriations in section  
24 2(a)(2) as follows:

25           (1) For the Army, \$250,000,000.

1           (2) For the Navy, \$250,000,000.

2           (3) For the Marine Corps, \$125,000,000.

3           (4) For the Air Force, \$250,000,000.

4           (5) For Defense-wide activities, \$125,000,000.

5           (c) TREATMENT OF TRANSFERRED AMOUNTS.—

6 Funds transferred under this section shall be merged with,

7 and shall be available for the same time period as, the

8 appropriations to which the funds are transferred.
