## A BILL

To amend title 5, United States Code, to allow certain catch-up contributions to the Thrift Savings Plan to be made by participants age 50 or over.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. CATCH-UP CONTRIBUTIONS.**

2 (a) CIVIL SERVICE RETIREMENT SYSTEM.—Para-  
3 graph (2) of section 8351(b) of title 5, United States  
4 Code, is amended by adding at the end the following:

5 “(C) Notwithstanding any limitation under this para-  
6 graph, an eligible participant (as defined by section 414(v)  
7 of the Internal Revenue Code of 1986) may make such  
8 additional contributions to the Thrift Savings Fund as are  
9 permitted by such section 414(v) and regulations of the  
10 Executive Director consistent therewith.”.

11 (b) FEDERAL EMPLOYEES’ RETIREMENT SYSTEM.—

12 (1) PROVISION APPLICABLE TO EMPLOYEES  
13 GENERALLY.—Subsection (a) of section 8432 of title  
14 5, United States Code, is amended by adding at the  
15 end the following:

16 “(3) Notwithstanding any limitation under this sub-  
17 section, an eligible participant (as defined by section  
18 414(v) of the Internal Revenue Code of 1986) may make  
19 such additional contributions to the Thrift Savings Fund  
20 as are permitted by such section 414(v) and regulations  
21 of the Executive Director consistent therewith.”.

22 (2) PROVISION APPLICABLE TO CERTAIN OTHER  
23 INDIVIDUALS.—Section 8440f of title 5, United  
24 States Code, is amended—

25 (A) by striking “The maximum” and in-  
26 serting “(a) The maximum”; and

1 (B) by adding at the end the following:

2 “(b) Notwithstanding any limitation under this sec-  
3 tion, an eligible participant (as defined by section 414(v)  
4 of the Internal Revenue Code of 1986) may make such  
5 additional contributions to the Thrift Savings Fund as are  
6 permitted by such section 414(v) and regulations of the  
7 Executive Director consistent therewith.”.

8 (c) EFFECTIVE DATE.—The amendments made by  
9 this section shall take effect as of the earliest practicable  
10 date, as determined by the Executive Director (appointed  
11 under section 8474(a) of title 5, United States Code) in  
12 regulations.
