## A BILL

To protect certain lands held in fee by the Pechanga Band of Luiseno Mission Indians from condemnation until a final decision is made by the Secretary of the Interior regarding a pending fee to trust application for that land, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. LAND OF PECHANGA BAND OF LUISENO MIS-**  
4 **SION INDIANS.**

5 (a) LIMITATION ON CONVEYANCE.—Land described  
6 in subsection (b) (or any interest in that land) shall not  
7 be voluntarily or involuntarily transferred or otherwise  
8 made available for condemnation until the date on  
9 which—

10 (1)(A) the Secretary of the Interior renders a  
11 final decision on the fee to trust application pending  
12 on the date of the enactment of this Act concerning  
13 the land; and

14 (B) final decisions have been rendered regard-  
15 ing all appeals relating to that application decision;  
16 or

17 (2) the fee to trust application described in  
18 paragraph (1)(A) is withdrawn.

19 (b) DESCRIPTION OF LAND.—The land referred to in  
20 subsection (a) is land located in Riverside County, Cali-  
21 fornia, that is held in fee by the Pechanga Band of  
22 Luiseno Mission Indians, as described in Document No.  
23 211130 of the Office of the Recorder, Riverside County,  
24 California, and recorded on May 15, 2001.

1       (c) RULE OF CONSTRUCTION.—Nothing in this sec-  
2 tion designates, or shall be used to construe, any land de-  
3 scribed in subsection (b) (or any interest in that land) as  
4 an Indian reservation, Indian country, Indian land, or res-  
5 ervation land (as those terms are defined under any Fed-  
6 eral law (including a regulation)) for any purpose under  
7 any Federal law.
