To make certain adjustments to the boundaries of the Mount
Nebo Wilderness Area, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Mount Nebo Wilder-
3 ness Boundary Adjustment Act”.

4 **SEC. 2. BOUNDARY ADJUSTMENTS.**

5 (a) **LANDS REMOVED.**—The boundary of the Mount
6 Nebo Wilderness is adjusted to exclude the following:

7 (1) **MONUMENT SPRINGS.**—The approximately
8 8.4 acres of land depicted on the Map as “Monu-
9 ment Springs”.

10 (2) **GARDNER CANYON.**—The approximately
11 177.8 acres of land depicted on the Map as “Gard-
12 ner Canyon”.

13 (3) **BIRCH CREEK.**—The approximately 5.0
14 acres of land depicted on the Map as “Birch Creek”.

15 (4) **INGRAM CANYON.**—The approximately 15.4
16 acres of land depicted on the Map as “Ingram Can-
17 yon”.

18 (5) **WILLOW NORTH A.**—The approximately 3.4
19 acres of land depicted on the Map as “Willow North
20 A”.

21 (6) **WILLOW NORTH B.**—The approximately 6.6
22 acres of land depicted on the Map as “Willow North
23 B”.

24 (7) **WILLOW SOUTH.**—The approximately 21.5
25 acres of land depicted on the Map as “Willow
26 South”.

1 (8) MENDENHALL CANYON.—The approxi-
2 mately 9.8 acres of land depicted on the Map as
3 “Mendenhall Canyon”.

4 (9) WASH CANYON.—The approximately 31.4
5 acres of land depicted on the Map as “Wash Can-
6 yon”.

7 (b) LANDS ADDED.—Subject to valid existing rights,
8 the boundary of the Mount Nebo Wilderness is adjusted
9 to include the approximately 293.2 acres of land depicted
10 on the Map for addition to the Mount Nebo Wilderness.
11 The Utah Wilderness Act of 1984 (Public Law 94–428)
12 shall apply to the land added to the Mount Nebo Wilder-
13 ness pursuant to this subsection.

14 **SEC. 3. MAP.**

15 (a) DEFINITION.—For the purpose of this Act, the
16 term “Map” shall mean the map entitled “Mt. Nebo Wil-
17 derness Boundary Adjustment”, numbered 531, and dated
18 May 29, 2001.

19 (b) MAP ON FILE.—The Map and the final document
20 entitled “Mount Nebo, Proposed Boundary Adjustments,
21 Parcel Descriptions (See Map #531)” and dated June 4,
22 2001, shall be on file and available for inspection in the
23 office of the Chief of the Forest Service, Department of
24 Agriculture.

1 (c) CORRECTIONS.—The Secretary of Agriculture
2 may make technical corrections to the Map.

3 **SEC. 4. TECHNICAL BOUNDARY ADJUSTMENT.**

4 The boundary of the Mount Nebo Wilderness is ad-
5 justed to exclude the approximately 21.26 acres of private
6 property located in Andrews Canyon, Utah, and depicted
7 on the Map as “Dale”.
