**AN ACT**

To adjust the boundaries of Santa Monica Mountains  
National Recreation Area, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Santa Monica Moun-  
3 tains National Recreation Area Boundary Adjustment  
4 Act”.

5 **SEC. 2. BOUNDARY ADJUSTMENT.**

6 Section 507(c) of the National Parks and Recreation  
7 Act of 1978 (92 Stat. 3501; 16 U.S.C. 460kk) estab-  
8 lishing Santa Monica Mountains National Recreation Area  
9 is amended—

10 (1) in paragraph (1), by striking “‘Boundary  
11 Map, Santa Monica Mountains National Recreation  
12 Area, California, and Santa Monica Mountains  
13 Zone’, numbered SMM–NRA 80,000, and dated  
14 May 1978” and inserting “‘Santa Monica Moun-  
15 tains National Recreation Area and Santa Monica  
16 Mountains Zone, California, Boundary Map’, ~~num-~~  
17 ~~bered 80,047, and dated February 2001~~” *numbered*  
18 *80,047–C and dated August 2001*”; and

19 (2) by adding the following sentence after the  
20 third sentence of paragraph (2)(A): “Lands within  
21 the ‘Wildlife Corridor Expansion Zone’ identified on  
22 the boundary map referred to in paragraph (1) may  
23 be acquired only by donation or with donated  
24 funds.”.

1 **SEC. 3. TECHNICAL CORRECTIONS.**

2 Section 507 of the National Parks and Recreation  
3 Act of 1978 (92 Stat. 3501; 16 U.S.C. 460kk) estab-  
4 lishing Santa Monica Mountains National Recreation Area  
5 is amended—

6 (1) in subsection (c)(1), by striking “Committee  
7 on Natural Resources” and inserting “Committee on  
8 Resources”;

9 (2) in subsection (c)(2)(B), by striking “of cer-  
10 tain” in the first sentence and inserting “certain”;  
11 and

12 (3) in subsection (n)(5), by striking “laws” in  
13 the second sentence and inserting “laws,”.
