## A BILL

To reauthorize the Rhinoceros and Tiger Conservation Act  
of 1994.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “Rhinoceros and Tiger*  
3 *Conservation Reauthorization Act of 2001”.*

4 **SEC. 2. REAUTHORIZATION OF RHINOCEROS AND TIGER**  
5 **CONSERVATION ACT OF 1994.**

6 *Section 9 of the Rhinoceros and Tiger Conservation*  
7 *Act of 1994 (16 U.S.C. 5306) is amended by striking “1996*  
8 *through 2002” and inserting “2001, 2002, 2003, 2004,*  
9 *2005, 2006, and 2007”.*

10 **SEC. 3. ADMINISTRATIVE EXPENSES.**

11 *Section 9 of the Rhinoceros and Tiger Conservation*  
12 *Act of 1994 (16 U.S.C. 5306) is further amended—*

13 *(1) by striking “There are authorized” and in-*  
14 *serting “(a) IN GENERAL.—There is authorized”; and*

15 *(2) by adding at the end the following:*

16 *“(b) ADMINISTRATIVE EXPENSES.—Of amounts avail-*  
17 *able each fiscal year to carry out this Act, the Secretary*  
18 *may expend not more than 3 percent or \$80,000, whichever*  
19 *is greater, to pay the administrative expenses necessary to*  
20 *carry out this Act.”.*

21 **SEC. 4. COOPERATION.**

22 *The Rhinoceros and Tiger Conservation Act of 1994*  
23 *is further amended by redesignating section 9 (16 U.S.C.*  
24 *5306) as section 10, and by inserting after section 8 the*  
25 *following:*

1 **“SEC. 9. ADVISORY GROUP.**

2       “(a) *IN GENERAL.*—*To assist in carrying out this Act,*  
3 *the Secretary may convene an advisory group consisting*  
4 *of individuals representing public and private organiza-*  
5 *tions actively involved in the conservation of rhinoceros and*  
6 *tiger species.*

7       “(b) *PUBLIC PARTICIPATION.*—

8               “(1) *MEETINGS.*—*The Advisory Group shall—*

9                       “(A) *ensure that each meeting of the advi-*  
10 *sory group is open to the public; and*

11                       “(B) *provide, at each meeting, an oppor-*  
12 *tunity for interested persons to present oral or*  
13 *written statements concerning items on the agen-*  
14 *da.*

15               “(2) *NOTICE.*—*The Secretary shall provide to the*  
16 *public timely notice of each meeting of the advisory*  
17 *group.*

18               “(3) *MINUTES.*—*Minutes of each meeting of the*  
19 *advisory group shall be kept by the Secretary and*  
20 *shall be made available to the public.*

21       “(c) *EXEMPTION FROM FEDERAL ADVISORY COM-*  
22 *MITTEE ACT.*—*The Federal Advisory Committee Act (5*  
23 *U.S.C. App.) shall not apply to the advisory group.”.*

24 **SEC. 5. PROJECT SUSTAINABILITY.**

25       *Section 5(e) of the Rhinoceros and Tiger Conservation*  
26 *Act of 1994 (16 U.S.C. 5304) is amended to read as follows:*

1           “(e) *PROJECT SUSTAINABILITY*.—*To the maximum ex-*  
2 *tent practical, in determining whether to approve project*  
3 *proposals under this section, the Secretary shall give consid-*  
4 *eration to projects which will enhance sustainable conserva-*  
5 *tion programs to ensure effective long-term conservation of*  
6 *rhinoceros and tigers.*”.

7 **SEC. 6. TECHNICAL AND CONFORMING AMENDMENTS.**

8           (a) *CONFORMING AMENDMENTS*.—*The Rhinoceros and*  
9 *Tiger Conservation Act of 1994 is amended as follows:*

10           (1) *Section 4(3) (16 U.S.C. 5303(3)) is amended*  
11 *by striking “Rhinoceros and Tiger Conservation Fund*  
12 *established under section 6(a)” and inserting “the ac-*  
13 *count established by division A, section 101(e), title I*  
14 *of Public Law 105–277 under the heading ‘MULTI-*  
15 *NATIONAL SPECIES CONSERVATION FUND’*”.

16           (2) *Section 6 (16 U.S.C. 5305) is amended by*  
17 *striking the section heading and all that follows*  
18 *through “(d) ACCEPTANCE AND USE OF DONA-*  
19 *TIONS.—” and inserting the following:*

20 **“SEC. 6. ACCEPTANCE AND USE OF DONATIONS.”.**

21           (b) *TECHNICAL CORRECTION*.—*Title I of section 101(e)*  
22 *of division A of Public Law 105–277 (112 Stat. 2681–237)*  
23 *is amended under the heading “MULTINATIONAL SPECIES*  
24 *CONSERVATION FUND” by striking “Rhinoceros and Tiger*

- 1 *Conservation Act, subchapter I' and inserting "Rhinoceros*
- 2 *and Tiger Conservation Act of 1994, part I'.*
