A BILL

To establish the Oil Region National Heritage Area.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE; DEFINITIONS.**

2 (a) *SHORT TITLE.*—*This Act may be cited as the “Oil*
3 *Region National Heritage Area Act”.*

4 (b) *DEFINITIONS.*—*For the purposes of this Act, the*
5 *following definitions shall apply:*

6 (1) *HERITAGE AREA.*—*The term “Heritage*
7 *Area” means the Oil Region National Heritage Area*
8 *established in section 3(a).*

9 (2) *MANAGEMENT ENTITY.*—*The term “manage-*
10 *ment entity” means the Oil Heritage Region, Inc., or*
11 *its successor entity.*

12 (3) *SECRETARY.*—*The term “Secretary” means*
13 *the Secretary of the Interior.*

14 **SEC. 2. FINDINGS AND PURPOSE.**

15 (a) *FINDINGS.*—*The Congress finds the following:*

16 (1) *The Oil Region of Northwestern Pennsyl-*
17 *vania, with numerous sites and districts listed on the*
18 *National Register of Historic Places, and designated*
19 *by the Governor of Pennsylvania as one of the State*
20 *Heritage Park Areas, is a region with tremendous*
21 *physical and natural resources and possesses a story*
22 *of State, national, and international significance.*

23 (2) *The single event of Colonel Edwin Drake’s*
24 *drilling of the world’s first successful oil well in 1859*
25 *has affected the industrial, natural, social, and polit-*
26 *ical structures of the modern world.*

1 (3) *Six national historic districts are located*
2 *within the State Heritage Park boundary, in*
3 *Emlenton, Franklin, Oil City, and Titusville, as well*
4 *as 17 separate National Register sites.*

5 (4) *The Allegheny River, which was designated*
6 *as a component of the national wild and scenic rivers*
7 *system in 1992 by Public Law 102–271, traverses the*
8 *Oil Region and connects several of its major sites, as*
9 *do some of the river’s tributaries such as Oil Creek,*
10 *French Creek, and Sandy Creek.*

11 (5) *The unspoiled rural character of the Oil Re-*
12 *gion provides many natural and recreational re-*
13 *sources, scenic vistas, and excellent water quality for*
14 *people throughout the United States to enjoy.*

15 (6) *Remnants of the oil industry, visible on the*
16 *landscape to this day, provide a direct link to the*
17 *past for visitors, as do the historic valley settlements,*
18 *riverbed settlements, plateau developments, farmlands,*
19 *and industrial landscapes.*

20 (7) *The Oil Region also represents a cross section*
21 *of American history associated with Native Ameri-*
22 *cans, frontier settlements, the French and Indian*
23 *War, African Americans and the Underground Rail-*
24 *road, and immigration of Swedish and Polish indi-*
25 *viduals, among others.*

1 (8) *Involvement by the Federal Government shall*
2 *serve to enhance the efforts of the Commonwealth of*
3 *Pennsylvania, local subdivisions of the Common-*
4 *wealth of Pennsylvania, volunteer organizations, and*
5 *private businesses, to promote the cultural, national,*
6 *and recreational resources of the region in order to*
7 *fulfill their full potential.*

8 (b) *PURPOSE.*—*The purpose of this Act is to enhance*
9 *a cooperative management framework to assist the Com-*
10 *monwealth of Pennsylvania, its units of local government,*
11 *and area citizens in conserving, enhancing, and inter-*
12 *preting the significant features of the lands, water, and*
13 *structures of the Oil Region, in a manner consistent with*
14 *compatible economic development for the benefit and inspi-*
15 *ration of present and future generations in the Common-*
16 *wealth of Pennsylvania and the United States.*

17 **SEC. 3. OIL REGION NATIONAL HERITAGE AREA.**

18 (a) *ESTABLISHMENT.*—*There is hereby established the*
19 *Oil Region National Heritage Area.*

20 (b) *BOUNDARIES.*—*The boundaries of the Heritage*
21 *Area shall include all of those lands depicted on a map enti-*
22 *tled “Oil Region National Heritage Area”, numbered*
23 *OIRE/20,000 and dated October, 2000. The map shall be*
24 *on file in the appropriate offices of the National Park Serv-*
25 *ice. The Secretary of the Interior shall publish in the Fed-*

1 *eral Register, as soon as practical after the date of the en-*
2 *actment of this Act, a detailed description and map of the*
3 *boundaries established under this subsection.*

4 *(c) MANAGEMENT ENTITY.—The management entity*
5 *for the Heritage Area shall be the Oil Heritage Region, Inc.,*
6 *the locally based private, nonprofit management corpora-*
7 *tion which shall oversee the development of a management*
8 *plan in accordance with section 5(b).*

9 **SEC. 4. COMPACT.**

10 *To carry out the purposes of this Act, the Secretary*
11 *shall enter into a compact with the management entity. The*
12 *compact shall include information relating to the objectives*
13 *and management of the area, including a discussion of the*
14 *goals and objectives of the Heritage Area, including an ex-*
15 *planation of the proposed approach to conservation and in-*
16 *terpretation and a general outline of the protection meas-*
17 *ures committed to by the Secretary and management entity.*

18 **SEC. 5. AUTHORITIES AND DUTIES OF MANAGEMENT**

19 **ENTITY.**

20 *(a) AUTHORITIES OF THE MANAGEMENT ENTITY.—*
21 *The management entity may use funds made available*
22 *under this Act for purposes of preparing, updating, and*
23 *implementing the management plan developed under sub-*
24 *section (b). Such purposes may include—*

1 (1) *making grants to, and entering into coopera-*
2 *tive agreements with, States and their political sub-*
3 *divisions, private organizations, or any other person;*

4 (2) *hiring and compensating staff; and*

5 (3) *undertaking initiatives that advance the pur-*
6 *poses of the Heritage Area.*

7 (b) *MANAGEMENT PLAN.—The management entity*
8 *shall develop a management plan for the Heritage Area*
9 *that—*

10 (1) *presents comprehensive strategies and rec-*
11 *ommendations for conservation, funding, manage-*
12 *ment, and development of the Heritage Area;*

13 (2) *takes into consideration existing State, coun-*
14 *ty, and local plans and involves residents, public*
15 *agencies, and private organizations working in the*
16 *Heritage Area;*

17 (3) *includes a description of actions that units*
18 *of government and private organizations have agreed*
19 *to take to protect the resources of the Heritage Area;*

20 (4) *specifies the existing and potential sources of*
21 *funding to protect, manage, and develop the Heritage*
22 *Area;*

23 (5) *includes an inventory of the resources con-*
24 *tained in the Heritage Area, including a list of any*
25 *property in the Heritage Area that is related to the*

1 *themes of the Heritage Area and that should be pre-*
2 *served, restored, managed, developed, or maintained*
3 *because of its natural, cultural, historic, recreational,*
4 *or scenic significance;*

5 *(6) recommends policies for resource manage-*
6 *ment which consider and detail application of appro-*
7 *prate land and water management techniques, in-*
8 *cluding, but not limited to, the development of inter-*
9 *governmental and interagency cooperative agreements*
10 *to protect the Heritage Area's historical, cultural, rec-*
11 *reational, and natural resources in a manner con-*
12 *sistent with supporting appropriate and compatible*
13 *economic viability;*

14 *(7) describes a program for implementation of*
15 *the management plan by the management entity, in-*
16 *cluding plans for restoration and construction, and*
17 *specific commitments for that implementation that*
18 *have been made by the management entity and any*
19 *other persons for the first 5 years of implementation;*

20 *(8) includes an analysis of ways in which local,*
21 *State, and Federal programs, including the role for*
22 *the National Park Service in the Heritage Area, may*
23 *best be coordinated to promote the purposes of this*
24 *Act;*

1 (9) lists any revisions to the boundaries of the
2 Heritage Area proposed by the management entity
3 and requested by the affected local government; and

4 (10) includes an interpretation plan for the Her-
5 itage Area.

6 (c) *DEADLINE; TERMINATION OF FUNDING.*—

7 (1) *DEADLINE.*—The management entity shall
8 submit the management plan to the Secretary within
9 2 years after the funds are made available for this
10 Act.

11 (2) *TERMINATION OF FUNDING.*—If a manage-
12 ment plan is not submitted to the Secretary in ac-
13 cordance with this subsection, the management entity
14 shall not qualify for Federal assistance under this
15 Act.

16 (d) *DUTIES OF MANAGEMENT ENTITY.*—The manage-
17 ment entity shall—

18 (1) give priority to implementing actions set
19 forth in the compact and management plan;

20 (2) assist units of government, regional planning
21 organizations, and nonprofit organizations in—

22 (A) establishing and maintaining interpre-
23 tive exhibits in the Heritage Area;

24 (B) developing recreational resources in the
25 Heritage Area;

1 (C) increasing public awareness of and ap-
2 preciation for the natural, historical, and archi-
3 tectural resources and sites in the Heritage Area;

4 (D) the restoration of any historic building
5 relating to the themes of the Heritage Area;

6 (E) ensuring that clear, consistent, and en-
7 vironmentally appropriate signs identifying ac-
8 cess points and sites of interest are put in place
9 throughout the Heritage Area; and

10 (F) carrying out other actions that the
11 management entity determines to be advisable to
12 fulfill the purposes of this Act;

13 (3) encourage by appropriate means economic
14 viability in the Heritage Area consistent with the
15 goals of the management plan;

16 (4) consider the interests of diverse governmental,
17 business, and nonprofit groups within the Heritage
18 Area; and

19 (5) for any year in which Federal funds have
20 been provided to implement the management plan
21 under subsection (b)—

22 (A) conduct public meetings at least annu-
23 ally regarding the implementation of the man-
24 agement plan;

1 (B) submit an annual report to the Sec-
2 retary setting forth accomplishments, expenses
3 and income, and each person to which any grant
4 was made by the management entity in the year
5 for which the report is made; and

6 (C) require, for all agreements entered into
7 by the management entity authorizing expendi-
8 ture of Federal funds by any other person, that
9 the person making the expenditure make avail-
10 able to the management entity for audit all
11 records pertaining to the expenditure of such
12 funds.

13 (e) *PROHIBITION ON THE ACQUISITION OF REAL*
14 *PROPERTY.*—The management entity may not use Federal
15 funds received under this Act to acquire real property or
16 an interest in real property.

17 **SEC. 6. DUTIES AND AUTHORITIES OF THE SECRETARY.**

18 (a) *TECHNICAL AND FINANCIAL ASSISTANCE.*—

19 (1) *IN GENERAL.*—

20 (A) *OVERALL ASSISTANCE.*—The Secretary
21 may, upon the request of the management entity,
22 and subject to the availability of appropriations,
23 provide technical and financial assistance to the
24 management entity to carry out its duties under
25 this Act, including updating and implementing

1 *a management plan that is submitted under sec-*
2 *tion 5(b) and approved by the Secretary and,*
3 *prior to such approval, providing assistance for*
4 *initiatives.*

5 *(B) OTHER ASSISTANCE.—If the Secretary*
6 *has the resources available to provide technical*
7 *assistance to the management entity to carry out*
8 *its duties under this Act (including updating*
9 *and implementing a management plan that is*
10 *submitted under section 5(b) and approved by*
11 *the Secretary and, prior to such approval, pro-*
12 *viding assistance for initiatives), upon the re-*
13 *quest of the management entity the Secretary*
14 *shall provide such assistance on a reimbursable*
15 *basis. This subparagraph does not preclude the*
16 *Secretary from providing nonreimbursable as-*
17 *sistance under subparagraph (A).*

18 *(2) PRIORITY.—In assisting the management en-*
19 *tity, the Secretary shall give priority to actions that*
20 *assist in the—*

21 *(A) implementation of the management*
22 *plan;*

23 *(B) provision of educational assistance and*
24 *advice regarding land and water management*

1 *techniques to conserve the significant natural re-*
2 *sources of the region;*

3 *(C) development and application of tech-*
4 *niques promoting the preservation of cultural*
5 *and historic properties;*

6 *(D) preservation, restoration, and reuse of*
7 *publicly and privately owned historic buildings;*

8 *(E) design and fabrication of a wide range*
9 *of interpretive materials based on the manage-*
10 *ment plan, including guide brochures, visitor*
11 *displays, audio-visual and interactive exhibits,*
12 *and educational curriculum materials for public*
13 *education; and*

14 *(F) implementation of initiatives prior to*
15 *approval of the management plan.*

16 (3) *DOCUMENTATION OF STRUCTURES.—The Sec-*
17 *retary, acting through the Historic American Build-*
18 *ing Survey and the Historic American Engineering*
19 *Record, shall conduct studies necessary to document*
20 *the industrial, engineering, building, and architec-*
21 *tural history of the Heritage Area.*

22 (b) *APPROVAL AND DISAPPROVAL OF MANAGEMENT*
23 *PLANS.—The Secretary, in consultation with the Governor*
24 *of Pennsylvania, shall approve or disapprove a manage-*
25 *ment plan submitted under this Act not later than 90 days*

1 *after receiving such plan. In approving the plan, the Sec-*
2 *retary shall take into consideration the following criteria:*

3 (1) *The extent to which the management plan*
4 *adequately preserves and protects the natural, cul-*
5 *tural, and historical resources of the Heritage Area.*

6 (2) *The level of public participation in the devel-*
7 *opment of the management plan.*

8 (3) *The extent to which the board of directors of*
9 *the management entity is representative of the local*
10 *government and a wide range of interested organiza-*
11 *tions and citizens.*

12 (c) *ACTION FOLLOWING DISAPPROVAL.—If the Sec-*
13 *retary disapproves a management plan, the Secretary shall*
14 *advise the management entity in writing of the reasons for*
15 *the disapproval and shall make recommendations for revi-*
16 *sions in the management plan. The Secretary shall approve*
17 *or disapprove a proposed revision within 90 days after the*
18 *date it is submitted.*

19 (d) *APPROVING CHANGES.—The Secretary shall review*
20 *and approve amendments to the management plan under*
21 *section 5(b) that make substantial changes. Funds appro-*
22 *priated under this Act may not be expended to implement*
23 *such changes until the Secretary approves the amendments.*

24 (e) *EFFECT OF INACTION.—If the Secretary does not*
25 *approve or disapprove a management plan, revision, or*

1 *change within 90 days after it is submitted to the Secretary,*
2 *then such management plan, revision, or change shall be*
3 *deemed to have been approved by the Secretary.*

4 **SEC. 7. DUTIES OF OTHER FEDERAL ENTITIES.**

5 *Any Federal entity conducting or supporting activities*
6 *directly affecting the Heritage Area shall—*

7 *(1) consult with the Secretary and the manage-*
8 *ment entity with respect to such activities;*

9 *(2) cooperate with the Secretary and the man-*
10 *agement entity in carrying out their duties under this*
11 *Act and, to the maximum extent practicable, coordi-*
12 *nate such activities with the carrying out of such du-*
13 *ties; and*

14 *(3) to the maximum extent practicable, conduct*
15 *or support such activities in a manner that the man-*
16 *agement entity determines shall not have an adverse*
17 *effect on the Heritage Area.*

18 **SEC. 8. SUNSET.**

19 *The Secretary may not make any grant or provide any*
20 *assistance under this Act after the expiration of the 15-year*
21 *period beginning on the date of the enactment of this Act.*

22 **SEC. 9. USE OF FEDERAL FUNDS FROM OTHER SOURCES.**

23 *Nothing in this Act shall preclude the management en-*
24 *tity from using Federal funds available under Acts other*

1 *than this Act for the purposes for which those funds were*
2 *authorized.*

3 **SEC. 10. AUTHORIZATION OF APPROPRIATIONS.**

4 (a) *IN GENERAL.*—*There are authorized to be appro-*
5 *priated to carry out this Act—*

6 (1) *not more than \$1,000,000 for any fiscal year;*

7 *and*

8 (2) *not more than a total of \$10,000,000.*

9 (b) *50 PERCENT MATCH.*—*Financial assistance pro-*
10 *vided under this Act may not be used to pay more than*
11 *50 percent of the total cost of any activity carried out with*
12 *that assistance.*
