

In the Senate of the United States,

December 18, 2001.

Resolved, That the bill from the House of Representatives (H.R. 700) entitled “An Act to reauthorize the Asian Elephant Conservation Act of 1997.”, do pass with the following

AMENDMENT:

1 Page 4, strike out all after line 12 down to and in-
2 cluding line 19 and insert:

3 *(b) TECHNICAL CORRECTIONS.—*

6 *the Department of the Interior and Related Agencies*

10 *that follows through “section 6 of the Asian Ele-*

12 *“section 5 of the Rhinoceros and Tiger Conserva-*

1 *tion Act of 1994 (16 U.S.C. 5304), part I of the*
2 *African Elephant Conservation Act (16 U.S.C.*
3 *4211 et seq.), and section 5 of the Asian Ele-*
4 *phant Conservation Act of 1997 (16 U.S.C.*
5 *4264)”;*

6 *(B) by striking “16 U.S.C. 4224” and in-*
7 *serting “section 2204 of the African Elephant*
8 *Conservation Act (16 U.S.C. 4224)”;*

9 *(C) by striking “16 U.S.C. 4225” and in-*
10 *serting “section 2205 of the African Elephant*
11 *Conservation Act (16 U.S.C. 4225)”; and*

12 *(D) by striking “16 U.S.C. 4211” and in-*
13 *serting “section 2101 of the African Elephant*
14 *Conservation Act (16 U.S.C. 4211)”.*

15 *(2) Effective on the day after the date of enact-*
16 *ment of the African Elephant Conservation Reauthor-*
17 *ization Act of 2001 (107th Congress)—*

18 *(A) section 2104(a) of the African Elephant*
19 *Conservation Act is amended by striking “this*
20 *Act” and inserting “this title”; and*

21 *(B) section 2306(b) of the African Elephant*
22 *Conservation Act (16 U.S.C. 4245(b)) is amend-*
23 *ed by striking “this Act” each place it appears*
24 *and inserting “this title”.*

3 *Section 10(a)(1) of the National Fish and Wildlife*

8 *(2) in subparagraph (A), by striking*
9 *“\$20,000,000” and inserting “\$25,000,000”.*
