A BILL

To provide a biennial budget for the United State
Government.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; FINDINGS.**

4 (a) **SHORT TITLE.**—This Act may be cited as the
5 “Budget Responsibility and Efficiency Act of 2001”.

6 (b) **FINDINGS.**—The Congress finds that—

7 (1) the annual appropriations and budget proc-
8 ess increasingly dominates the congressional agenda
9 and Congress regularly fails to meet the deadlines of
10 the Congressional Budget Act of 1974;

11 (2) the design of the budget process has led to
12 repetitive and time-consuming budget votes, decreas-
13 ing the time available for the systematic and pro-
14 grammatic oversight of Federal programs and delay-
15 ing the enactment of legislation necessary to fund
16 the Government;

17 (3) Congress’ responsibility to improve the effi-
18 ciency, economy, and effectiveness of governmental
19 operations, evaluate programs and performance, de-
20 tect and prevent poor administration, waste, or
21 abuse in Government programs, ensure that execu-
22 tive policies reflect the public interest, ensure admin-
23 istrative compliance with legislative intent, and pre-
24 vent executive encroachment on legislative authority

1 and prerogatives is undermined by the current time-
2 consuming and repetitive budget process;

3 (4) an annual budget process encourages ineffi-
4 ciency in the management, stability, and predict-
5 ability of Federal funding, particularly for States
6 and localities;

7 (5) a biennial budget process will reduce the
8 number of budget-related votes during each Con-
9 gress, enhance congressional oversight of Govern-
10 ment operations, encourage longer time horizons in
11 policy planning and greater stability in fiscal policy;

12 (6) a biennial budget process was a principal
13 recommendation of the 1993 Joint Committee on
14 the Organization of Congress and the Vice Presi-
15 dent's National Performance Review;

16 (7) since the enactment of the Congressional
17 Budget Act of 1974, more than 50 bills addressing
18 a two-year budget cycle have been introduced, 10 bi-
19 ennial budget related provisions were reported by
20 congressional committees, 7 passed either chamber
21 and 4 were enacted; more than 40 congressional or
22 special committee hearings addressed the issue of bi-
23 ennial budgeting; and the Congressional Budget Of-
24 fice, the Office of Management and Budget, and 5
25 different special task forces or joint committees of

1 Congress have either recommended biennial budg-
 2 eting or further studies of it;

3 (8) the adoption of a biennial budget process
 4 was recommended by President Reagan in the fiscal
 5 year 1989 budget submission, by President Bush in
 6 the fiscal year 1990 and 1991 budget submissions,
 7 by President Clinton in the fiscal year 1995, 2000,
 8 and 2001 budget submissions, and by President
 9 Bush in the fiscal year 2002 budget submission; and
 10 (9) a bipartisan majority of Members of the
 11 House of Representatives support a biennial budget
 12 process.

13 **SEC. 2. REVISION OF TIMETABLE.**

14 Section 300 of the Congressional Budget Act of 1974
 15 (2 U.S.C. 631) is amended to read as follows:

16 “TIMETABLE

17 “SEC. 300. (a) IN GENERAL.—Except as provided by
 18 subsection (b), the timetable with respect to the congres-
 19 sional budget process for any Congress (beginning with
 20 the One Hundred Ninth Congress) is as follows:

1 “(b) SPECIAL RULE.—In the case of any first session
2 of Congress that begins in any year during which the term
3 of a President (except a President who succeeds himself)
4 begins, the following dates shall supersede those set forth
5 in subsection (a):

1 **SEC. 3. AMENDMENTS TO THE CONGRESSIONAL BUDGET**
2 **AND IMPOUNDMENT CONTROL ACT OF 1974.**

3 (a) **DECLARATION OF PURPOSE.**—Section 2(2) of the
4 Congressional Budget and Impoundment Control Act of
5 1974 (2 U.S.C. 621(2)) is amended by striking “each
6 year” and inserting “biennially”.

7 (b) **DEFINITIONS.**—

8 (1) **BUDGET RESOLUTION.**—Section 3(4) of
9 such Act (2 U.S.C. 622(4)) is amended by striking
10 “fiscal year” each place it appears and inserting “bi-
11 ennium”.

12 (2) **BIENNIUM.**—Section 3 of such Act (2
13 U.S.C. 622) (as amended by section 3) is further
14 amended by adding at the end the following new
15 paragraph:

16 “(13) The term ‘biennium’ means the period of
17 2 consecutive fiscal years beginning on October 1 of
18 any odd-numbered year.”.

19 (c) **BIENNIAL CONCURRENT RESOLUTION ON THE**
20 **BUDGET.**—

21 (1) **CONTENTS OF RESOLUTION.**—Section

1 (i) striking “April 15 of each year”
2 and inserting “May 15 of each odd-num-
3 bered year”;

4 (ii) striking “the fiscal year beginning
5 on October 1 of such year” the first place
6 it appears and inserting “the biennium be-
7 ginning on October 1 of such year”; and

8 (iii) striking “the fiscal year beginning
9 on October 1 of such year” the second
10 place it appears and inserting “each fiscal
11 year in such period”;

12 (B) in paragraph (6), by striking “for the
13 fiscal year” and inserting “for each fiscal year
14 in the biennium”; and

15 (C) in paragraph (7), by striking “for the
16 fiscal year” and inserting “for each fiscal year
17 in the biennium”.

7 (A) striking “fiscal year” and inserting
8 “biennium”; and

9 (B) inserting after the second sentence the
10 following: “On or before April 1 of each odd-
11 numbered year (or, if applicable, as provided by
12 section 300(b)), the Committee on the Budget
13 of each House shall report to its House the con-
14 current resolution on the budget referred to in
15 subsection (a) for the biennium beginning on
16 October 1 of that year.”.

15 303(b) of such Act (2 U.S.C. 634(b)) is amended—

16 (A) in paragraph (1)(A), by striking “the
17 budget year” and inserting “the biennium”;

18 (B) in paragraph (1)(B), by striking “the
19 fiscal year” and inserting “the biennium”; and

20 (C) in paragraph (2), by inserting “(or
21 June 1 whenever section 300(b) is applicable)”.

22 (3) APPLICATION TO THE SENATE.—Section
23 303(c)(1) of such Act (2 U.S.C. 634(c)) is amended
24 by—

1 (A) striking “fiscal year” and inserting
2 “biennium”; and

3 (B) striking “that year” and inserting
4 “each fiscal year of that biennium”.

5 (f) PERMISSIBLE REVISIONS OF CONCURRENT RESO-
6 LUTIONS ON THE BUDGET.—Section 304 of such Act (2
7 U.S.C. 635) is amended—

8 (1) by striking “fiscal year” the first two places
9 it appears and inserting “biennium”;

10 (2) by striking “for such fiscal year”; and

11 (3) by inserting before the period “for such bi-
12 ennium”.

13 (g) PROCEDURES FOR CONSIDERATION OF BUDGET
14 RESOLUTIONS.—Section 305(a)(3) of such Act (2 U.S.C.
15 636(b)(3)) is amended by striking “fiscal year” and in-
16 serting “biennium”.

17 (h) COMPLETION OF HOUSE COMMITTEE ACTION ON
18 APPROPRIATION BILLS.—Section 307 of such Act (2
19 U.S.C. 638) is amended—

20 (1) by striking “each year” and inserting “each
21 odd-numbered year (or, if applicable, as provided by
22 section 300(b), July 1)”;

23 (2) by striking “annual” and inserting “bien-
24 nial”;

1 (3) by striking “fiscal year” and inserting “bi-
2 ennium”; and

3 (4) by striking “that year” and inserting “each
4 odd-numbered year”.

5 (i) QUARTERLY BUDGET REPORTS.—Section 308 of
6 such Act (2 U.S.C. 639) is amended by adding at the end
7 the following new subsection:

8 “(d) QUARTERLY BUDGET REPORTS.—The Director
9 of the Congressional Budget Office shall, as soon as prac-
10 ticable after the completion of each quarter of the fiscal
11 year, prepare an analysis comparing revenues, spending,
12 and the deficit or surplus for the current fiscal year to
13 assumptions included in the congressional budget resolu-
14 tion. In preparing this report, the Director of the Congres-
15 sional Budget Office shall combine actual budget figures
16 to date with projected revenue and spending for the bal-
17 ance of the fiscal year. The Director of the Congressional
18 Budget Office shall include any other information in this
19 report that it deems useful for a full understanding of the
20 current fiscal position of the Federal Government. The re-
21 ports mandated by this subsection shall be transmitted by
22 the Director to the Senate and House Committees on the
23 Budget, and the Congressional Budget Office shall make
24 such reports available to any interested party upon re-
25 quest.”.

20 (3) by striking subsection (f) and redesignating
21 subsection (g) as subsection (f).

22 (l) SECTION 311 POINT OF ORDER.—

24 Act (2 U.S.C. 642(a)) is amended—

1 (A) by striking “for a fiscal year” and in-
2 serting “for a biennium”;

3 (B) by striking “the first fiscal year” each
4 place it appears and inserting “either fiscal
5 year of the biennium”; and

6 (C) by striking “that first fiscal year” and
7 inserting “each fiscal year in the biennium”.

8 (2) IN THE SENATE.—Section 311(a)(2) of

11 the first fiscal year” and inserting “for either

1 (b) BUDGET CONTENTS AND SUBMISSION TO THE
2 CONGRESS.—

3 (1) SCHEDULE.—The matter preceding para-
4 graph (1) in section 1105(a) of title 31, United
5 States Code, is amended to read as follows:

6 “(a) On or before the first Monday in February of
7 each odd-numbered year (or, if applicable, as provided by
8 section 300(b) of the Congressional Budget Act of 1974),
9 beginning with the One Hundred Ninth Congress, the
10 President shall transmit to the Congress, the budget for
11 the biennium beginning on October 1 of such calendar
12 year. The budget transmitted under this subsection shall
13 include a budget message and summary and supporting
14 information. The President shall include in each budget
15 the following:”.

23 United States Code, is amended by striking “the fis-
24 cal year for which the budget is submitted and the
25 4 fiscal years after that year” and inserting “each

1 fiscal year in the biennium for which the budget is
2 submitted and in the succeeding 4 years”.

3 (4) BALANCE STATEMENTS.—Section
4 1105(a)(9)(C) of title 31, United States Code, is
5 amended by striking “the fiscal year” and inserting
6 “each fiscal year in the biennium”.

7 (5) GOVERNMENT FUNCTIONS AND ACTIVI-
8 TIES.—Section 1105(a)(12) of title 31, United
9 States Code, is amended in subparagraph (A), by
10 striking “the fiscal year” and inserting “each fiscal
11 year in the biennium”.

14 fiscal year” and inserting “each fiscal year in the bi-
15 ennium”.

1 “(3) For purposes of this subsection, the term ‘meas-
 2 ure’ means a bill, joint resolution, amendment, motion, or
 3 conference report.”.

19 September 30, 2004, meeting the requirements of
20 subsection (a)”.

21 (g) PERFORMANCE PLANS.—Section 2803(a) of title
22 39, United States Code, is amended—

23 (1) in the matter before paragraph (1), by
24 striking “an annual” and inserting “a biennial”;

1 (2) in paragraph (1), by inserting after “pro-
2 gram activity” the following: “for both years 1 and
3 2 of the biennial plan”;

4 (3) in paragraph (5), by striking “and” after
5 the semicolon;

6 (4) in paragraph (6), by striking the period and
7 inserting “; and”; and

8 (5) by adding after paragraph (6) the following:

9 “(7) cover each fiscal year of the biennium be-
10 ginning with the first fiscal year of the next biennial
11 budget cycle.”.

12 (h) COMMITTEE VIEWS OF PLANS AND REPORTS.—

6 activity may be included in a general appropriation bill
7 or amendment thereto.”.

8 (2) Clause 5(b)(1) of rule XXII of the House of Rep-
9 resentatives is amended by striking “or (c)” and inserting
10 “or (3) or 2(c)”.

11 (b) IN THE SENATE.—(1) Title III of the Congres-
12 sional Budget Act of 1974 (2 U.S.C. 631 et seq.) (as
13 amended by section 7) is further amended by adding at
14 the end the following:

15 “CONSIDERATION OF BIENNIAL APPROPRIATION BILLS
16 “SEC. 319. It shall not be in order in the Senate in
17 any odd-numbered year to consider any regular appropria-
18 tion bill providing new budget authority or a limitation
19 on obligations under the jurisdiction of the Committee on
20 Appropriations for only the first fiscal year of a biennium,
21 unless the program, project, or activity for which the new
22 budget authority or obligation limitation is provided will
23 require no additional authority beyond one year and will
24 be completed or terminated after the amount provided has
25 been expended.”.

3 (c) SUMMARIES BY COMPTROLLER GENERAL.—With-
4 in thirty days after the receipt of a request from a chair-
5 man and ranking minority member of a standing com-
6 mittee having jurisdiction over a program being reviewed
7 and studied by such committee under this section, the
8 Comptroller General of the United States shall furnish to
9 such committee summaries of any audits or reviews of
10 such program which the Comptroller General has com-
11 pleted during the preceding six years.

12 (d) CONGRESSIONAL ASSISTANCE.—Consistent with
13 their duties and functions under law, the Comptroller Gen-
14 eral of the United States, the Director of the Congres-

1 **SEC. 11. REPORT ON TWO-YEAR FISCAL PERIOD.**

2 Not later than 180 days after the date of enactment
3 of this Act, the Director of the Office of Management and
4 Budget shall—

5 (1) determine the impact and feasibility of
6 changing the definition of a fiscal year and the
7 budget process based on that definition to a 2-year
8 fiscal period with a biennial budget process based
9 on the 2-year period; and

10 (2) report the findings of the study to the Com-
11 mittees on the Budget of the House of Representa-
12 tives and the Senate and the Committee on Rules of
13 the House of Representatives.

14 **SEC. 12. SPECIAL TRANSITION PERIOD FOR THE 107TH**
15 **CONGRESS.**

16 (a) **PRESIDENT'S BUDGET SUBMISSION FOR FISCAL**
17 **YEAR 2004.**—The budget submission of the President
18 pursuant to section 1105(a) of title 31, United States
19 Code, for fiscal year 2004 shall include the following:

20 (1) An identification of the budget accounts for
21 which an appropriation should be made for each fis-
22 cal year of the fiscal year 2004–2005 biennium.

23 (2) Budget authority that should be provided
24 for each such fiscal year for the budget accounts
25 identified under paragraph (1).

1 (b) REVIEW AND RECOMMENDATIONS OF THE COM-
2 MITTEES ON APPROPRIATIONS.—The Committee on Ap-
3 propriations of the House of Representatives and the Sen-
4 ate shall review the items included pursuant to subsection
5 (a) in the budget submission of the President for fiscal
6 year 2004 and include its recommendations thereon in its
7 views and estimates made under section 301(d) of the
8 Congressional Budget Act of 1974 within 6 weeks of that
9 budget submission.

10 (c) ACTIONS BY THE COMMITTEES ON THE BUDG-
11 ET.—(1) The Committee on the Budget of the House of
12 Representatives and the Senate shall review the items in-
13 cluded pursuant to subsection (a) in the budget submis-
14 sion of the President for fiscal year 2004 and the rec-
15 ommendations submitted by the Committee on Appropria-
16 tions of its House pursuant to subsection (b) included in
17 its views and estimates made under section 301(d) of the
18 Congressional Budget Act of 1974.

19 (2) The report of the Committee on the Budget of
20 each House accompanying the concurrent resolution on
21 the budget for fiscal year 2004 and the joint explanatory
22 statement of managers accompanying such resolution shall
23 also include allocations to the Committee on Appropria-
24 tions of its House of total new budget authority and total
25 outlays (which shall be deemed to be made pursuant to

1 section 302(a) of the Congressional Budget Act of 1974
2 for purposes of budget enforcement under section 302(f))
3 for fiscal year 2005 from which the Committee on Appro-
4 priations may report regular appropriation bills for fiscal
5 year 2004 that include funding for certain accounts for
6 each of fiscal years 2004 and 2005.

7 (3) The report of the Committee on the Budget of
8 each House accompanying the concurrent resolution on
9 the budget for fiscal year 2004 and the joint explanatory
10 statement of managers accompanying such resolution shall
11 also include the assumptions upon which such allocations
12 referred to in paragraph (2) are based.

13 (d) GAO PROGRAMMATIC OVERSIGHT ASSIST-
14 ANCE.—(1) During the first session of the 108th Congress
15 the committees of the House of Representatives and the
16 Senate are directed to work with the Comptroller General
17 of the United States to develop plans to transition pro-
18 gram authorizations to a multi-year schedule.

19 (2) During the 108th Congress, the Comptroller Gen-
20 eral of the United States will continue to provide assist-
21 ance to the Congress with respect to programmatic over-
22 sight and in particular will assist the committees of Con-
23 gress in designing and conforming programmatic oversight
24 procedures for the fiscal year 2005–2006 biennium.

1 (e) CBO AUTHORIZATION REPORT.—On or before
2 January 15, 2004, the Director of the Congressional
3 Budget Office, after consultation with the appropriate
4 committees of the House of Representatives and Senate,
5 shall submit to the Congress a report listing (A) all pro-
6 grams and activities funded during fiscal year 2004 for
7 which authorizations for appropriations have not been en-
8 acted for that fiscal year and (B) all programs and activi-
9 ties funded during fiscal year 2004 for which authoriza-
10 tions for appropriations will expire during that fiscal year,
11 fiscal year 2005, or fiscal year 2006.

12 (f) PRESIDENT’S BUDGET SUBMISSION FOR FISCAL
13 YEAR 2005.—The budget submission of the President
14 pursuant to section 1105(a) of title 31, United States
15 Code, for fiscal year 2005 shall include an evaluation of,
16 and recommendations regarding, the transitional biennial
17 budget process for the fiscal year 2004–2005 biennium
18 that was carried out pursuant to this section.

19 (g) CBO TRANSITIONAL REPORT.—On or before
20 March 31, 2004, the Director of the Congressional Budget
21 Office shall submit to Congress an evaluation of, and rec-
22 ommendations regarding, the transitional biennial budget
23 process for the fiscal year 2004–2005 biennium that was
24 carried out pursuant to this section.

1 **SEC. 13. EFFECTIVE DATE.**

2 Except as provided by sections 8, 11, and 12, this
3 Act and the amendments made by it shall take effect on
4 January 1, 2005, and shall apply to budget resolutions
5 and appropriations for the biennium beginning with fiscal
6 year 2006.
