Mr. SESSIONS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2311) making appropriations for energy and water development for the fiscal year ending September 30, 2002, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the Bill (H.R. 2311) making appropriations for
6 energy and water development for the fiscal year ending

1 September 30, 2002, and for other purposes. The first
2 reading of the bill shall be dispensed with. All points of
3 order against consideration of the bill are waived. General
4 debate shall be confined to the bill and shall not exceed
5 one hour equally divided and controlled by the chairman
6 and ranking minority member of the Committee on Appro-
7 priations. After general debate the bill shall be considered
8 for amendment under the five-minute rule. The amend-
9 ment printed in the report of the Committee on Rules ac-
10 companying this resolution shall be considered as adopted
11 in the House and in the Committee of the Whole. Points
12 of order against provisions in the bill, as amended, for fail-
13 ure to comply with clause 2 of rule XXI are waived except
14 section 308. During consideration of the bill for further
15 amendment, the Chairman of the Committee of the Whole
16 may accord priority in recognition on the basis of whether
17 the Member offering an amendment has caused it to be
18 printed in the portion of the Congressional Record des-
19 ignated for that purpose in clause 8 of rule XVIII. Amend-
20 ments so printed shall be considered as read. At the con-
21 clusion of consideration of the bill for amendment the
22 Committee shall rise and report the bill, as amended, to
23 the House with such further amendments as may have
24 been adopted. The previous question shall be considered
25 as ordered on the bill and amendments thereto to final

- 1 passage without intervening motion except one motion to
- 2 recommit with or without instructions.
