Mr. LINDER, from the Committee on Rules, reported the following resolution which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 2500) making appropriations for the Departments of Commerce, Justice, and State, the Judiciary, and related agencies for the fiscal year ending September 30, 2002, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 2(b) of  
3 rule XVIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 2500) making appropriations for

1 the Departments of Commerce, Justice, and State, the Ju-  
2 diciary, and related agencies for the fiscal year ending  
3 September 30, 2002, and for other purposes. The first  
4 reading of the bill shall be dispensed with. All points of  
5 order against consideration of the bill are waived. General  
6 debate shall be confined to the bill and shall not exceed  
7 one hour equally divided and controlled by the chairman  
8 and ranking minority member of the Committee on Appro-  
9 priations. After general debate the bill shall be considered  
10 for amendment under the five-minute rule. Points of order  
11 against provisions in the bill for failure to comply with  
12 clause 2 of rule XXI are waived except as follows: begin-  
13 ning with “Provided” on page 19, line 13, through  
14 “workyears:” on line 19. Where points of order are waived  
15 against part of a paragraph, points of order against a pro-  
16 vision in another part of such paragraph may be made  
17 only against such provision and not against the entire  
18 paragraph. During consideration of the bill for amend-  
19 ment, the Chairman of the Committee of the Whole may  
20 accord priority in recognition on the basis of whether the  
21 Member offering an amendment has caused it to be print-  
22 ed in the portion of the Congressional Record designated  
23 for that purpose in clause 8 of rule XVIII. Amendments  
24 so printed shall be considered as read. At the conclusion  
25 of consideration of the bill for amendment the Committee

1 shall rise and report the bill to the House with such  
2 amendments as may have been adopted. The previous  
3 question shall be considered as ordered on the bill and  
4 amendments thereto to final passage without intervening  
5 motion except one motion to recommit with or without in-  
6 structions.
