Mr. LINDER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2590) making appropriations for the Treasury Department, the United States Postal Service, the Executive Office of the President, and certain Independent Agencies, for the fiscal year ending September 30, 2002, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 2590) making appropriations for

1 the Treasury Department, the United States Postal Serv-
2 ice, the Executive Office of the President, and certain
3 Independent Agencies, for the fiscal year ending Sep-
4 tember 30, 2002, and for other purposes. The first reading
5 of the bill shall be dispensed with. All points of order
6 against consideration of the bill are waived. General de-
7 bate shall be confined to the bill and shall not exceed one
8 hour equally divided and controlled by the chairman and
9 ranking minority member of the Committee on Appropria-
10 tions. After general debate the bill shall be considered for
11 amendment under the five-minute rule. The amendments
12 printed in the report of the Committee on Rules accom-
13 panying this resolution shall be considered as adopted in
14 the House and in the Committee of the Whole. Points of
15 order against provisions in the bill, as amended, for failure
16 to comply with clause 2 of rule XXI are waived. The
17 amendment printed in the Congressional Record and num-
18 bered 5 pursuant to clause 8 of rule XVIII may be offered
19 only by Representative Smith of New Jersey or his des-
20 ignee and only at the appropriate point in the reading of
21 the bill. All points of order against that amendment are
22 waived. During consideration of the bill for further amend-
23 ment, the Chairman of the Committee of the Whole may
24 accord priority in recognition on the basis of whether the
25 Member offering an amendment has caused it to be print-

1 ed in the portion of the Congressional Record designated
2 for that purpose in clause 8 of rule XVIII. Amendments
3 so printed shall be considered as read. At the conclusion
4 of consideration of the bill for amendment the Committee
5 shall rise and report the bill, as amended, to the House
6 with such further amendments as may have been adopted.
7 The previous question shall be considered as ordered on
8 the bill and amendments thereto to final passage without
9 intervening motion except one motion to recommit with
10 or without instructions.
