Mr. DIAZ-BALART, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 3389) to reauthorize the National Sea Grant College Program Act, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 3389) to reauthorize the National
6 Sea Grant College Program Act, and for other purposes.
7 The first reading of the bill shall be dispensed with. Gen-

1 eral debate shall be confined to the bill and shall not ex-
2 ceed one hour, with 40 minutes equally divided and con-
3 trolled by the chairman and ranking minority member of
4 the Committee on Resources and 20 minutes equally di-
5 vided and controlled by the chairman and ranking minor-
6 ity member of the Committee on the Science. After general
7 debate the bill shall be considered for amendment under
8 the five-minute rule. In lieu of the amendments rec-
9 ommended by the Committee on Resources and the Com-
10 mittee on Science now printed in the bill, it shall be in
11 order to consider as an original bill for the purpose of
12 amendment under the five-minute rule the amendment in
13 the nature of a substitute printed in the report of the
14 Committee on Rules accompanying this resolution. Each
15 section of that amendment in the nature of a substitute
16 shall be considered as read. All points of order against
17 that amendment in the nature of a substitute are waived.
18 During consideration of the bill for amendment, the Chair-
19 man of the Committee of the Whole may accord priority
20 in recognition on the basis of whether the Member offering
21 an amendment has caused it to be printed in the portion
22 of the Congressional Record designated for that purpose
23 of clause 8 of rule XVIII. Amendments so printed shall
24 be considered as read. At the conclusion of consideration
25 of the bill for amendment the Committee shall rise and

1 report the bill to the House with such amendments as may
2 have been adopted. Any Member may demand a separate
3 vote in the House on any amendment adopted in the Com-
4 mittee of the Whole to the bill or to the amendment in
5 the nature of a substitute made in order as original text.
6 The previous question shall be considered as ordered on
7 the bill and amendments thereto to final passage without
8 intervening motion except one motion to recommit with
9 or without instructions.
