Mr. DIAZ-BALART, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 5121) making appropriations for the Legislative Branch for the fiscal year ending September 30, 2003, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 5121) making appropriations for
6 the Legislative Branch for the fiscal year ending Sep-

1 tember 30, 2003, and for other purposes. The first reading
2 of the bill shall be dispensed with. General debate shall
3 be confined to the bill and shall not exceed one hour equal-
4 ly divided and controlled by the chairman and ranking mi-
5 nority member of the Committee on Appropriations. After
6 general debate the bill shall be considered for amendment
7 under the five-minute rule. The bill shall be considered
8 as read through page 61, line 16. Points of order against
9 provisions in the bill for failure to comply with clause 2
10 of rule XXI are waived except as follows: beginning with
11 “Provided” on page 11, line 4, through line 9; page 16,
12 line 21, through page 21, line 17. Where points of order
13 are waived against part of a paragraph, points of order
14 against a provision in another part of such paragraph may
15 be made only against such provision and not against the
16 entire paragraph. No amendment to the bill shall be in
17 order except the amendment printed in the report of the
18 Committee on Rules accompanying this resolution and ex-
19 cept pro forma amendments offered by the chairman or
20 ranking minority member of the Committee on Appropria-
21 tions or their designees for the purpose of debate. The
22 amendment printed in the report may be offered only by
23 a Member designated in the report, shall be considered
24 as read, shall be debatable for the time specified in the
25 report equally divided and controlled by the proponent and

1 an opponent, and shall not be subject to amendment. At
2 the conclusion of consideration of the bill for amendment
3 the Committee shall rise and report the bill to the House
4 with such amendment as may have been adopted. The pre-
5 vious question shall be considered as ordered on the bill
6 and the amendment thereto to final passage without inter-
7 vening motion except one motion to recommit with or
8 without instructions.
