## RESOLUTION

Providing for consideration of the joint resolution (H.J. Res. 124) making further continuing appropriations for the fiscal year 2003, and for other purposes, and for consideration of the bill (H.R. 5708) to reduce preexisting PAYGO balances, and for other purposes.

1       *Resolved*, That upon the adoption of this resolution  
2 it shall be in order without intervention of any point of  
3 order to consider in the House the joint resolution (H.J.  
4 Res. 124) making further continuing appropriations for

1 the fiscal year 2003, and for other purposes. The joint  
2 resolution shall be considered as read for amendment. The  
3 previous question shall be considered as ordered on the  
4 joint resolution to final passage without intervening mo-  
5 tion except: (1) one hour of debate on the joint resolution  
6 equally divided and controlled by the chairman and rank-  
7 ing minority member of the Committee on Appropriations;  
8 and (2) one motion to recommit.

9       SEC. 2. Upon the adoption of this resolution it shall  
10 be in order without intervention of any point of order to  
11 consider in the House the bill (H.R. 5708) to reduce pre-  
12 existing PAYGO balances, and for other purposes. The bill  
13 shall be considered as read for amendment. The previous  
14 question shall be considered as ordered on the bill to final  
15 passage without intervening motion except: (1) one hour  
16 of debate on the bill equally divided and controlled by the  
17 chairman and ranking minority member of the committee  
18 on the Budget; and (2) one motion to recommit.
