## RESOLUTION

Providing for the expenses of certain committees of the  
House of Representatives in the One Hundred Seventh  
Congress.

1       *Resolved,*

2       **SECTION 1. COMMITTEE EXPENSES FOR THE ONE HUN-**  
3                               **DRED SEVENTH CONGRESS.**

4           (a) IN GENERAL.—With respect to the One Hundred  
5 Seventh Congress, there shall be paid out of the applicable  
6 accounts of the House of Representatives, in accordance  
7 with this primary expense resolution, not more than the  
8 amount specified in subsection (b) for the expenses (in-  
9 cluding the expenses of all staff salaries) of each com-  
10 mittee named in that subsection.

1 (b) COMMITTEES AND AMOUNTS.—The committees  
2 and amounts referred to in subsection (a) are: Committee  
3 on Agriculture, \$10,010,397; Committee on Armed Serv-  
4 ices, \$10,847,677; Committee on the Budget,  
5 \$11,221,912.71; Committee on Education and the Work-  
6 force, \$15,590,870; Committee on Energy and Commerce,  
7 \$18,813,475; Committee on Financial Services,  
8 \$15,095,429; Committee on Government Reform,  
9 \$21,842,000; Committee on House Administration,

21 **SEC. 2. FIRST SESSION LIMITATIONS.**

22 (a) IN GENERAL.—Of the amount provided for in  
23 section 1 for each committee named in subsection (b), not  
24 more than the amount specified in such subsection shall  
25 be available for expenses incurred during the period begin-

1 ning at noon on January 3, 2001, and ending immediately  
2 before noon on January 3, 2002.

3 (b) COMMITTEES AND AMOUNTS.—The committees

22 **SEC. 3. SECOND SESSION LIMITATIONS.**

23 (a) IN GENERAL.—Of the amount provided for in  
24 section 1 for each committee named in subsection (b), not  
25 more than the amount specified in such subsection shall

1 be available for expenses incurred during the period begin-  
2 ning at noon on January 3, 2002, and ending immediately  
3 before noon on January 3, 2003.

4 (b) COMMITTEES AND AMOUNTS.—The committees  
5 and amounts referred to in subsection (a) are: Committee  
6 on Agriculture, \$5,091,900; Committee on Armed Serv-  
7 ices, \$5,665,080; Committee on the Budget, \$5,708,608;  
8 Committee on Education and the Workforce, \$7,452,904;  
9 Committee on Energy and Commerce, \$9,874,563.60;  
10 Committee on Financial Services, \$7,526,923; Committee  
11 on Government Reform, \$11,150,000; Committee on  
12 House Administration, \$4,093,846; Permanent Select  
13 Committee on Intelligence, \$3,815,052.38; Committee on  
14 International Relations, \$7,491,411; Committee on the  
15 Judiciary, \$7,894,624; Committee on Resources,  
16 \$6,175,994; Committee on Rules, \$2,726,264; Committee  
17 on Science, \$6,254,222.50; Committee on Small Business,  
18 \$2,486,439; Committee on Standards of Official Conduct,  
19 \$1,537,383.20; Committee on Transportation and Infra-

23 **SEC. 4. VOUCHERS.**

24 Payments under this resolution shall be made on  
25 vouchers authorized by the committee involved, signed by

1 the chairman of such committee, and approved in the  
2 manner directed by the Committee on House Administra-  
3 tion.

4 **SEC. 5. REGULATIONS.**

5       Amounts made available under this resolution shall  
6 be expended in accordance with regulations prescribed by  
7 the Committee on House Administration.

8 **SEC. 6. ADJUSTMENT AUTHORITY.**

9       The Committee on House Administration shall have  
10 authority to make adjustments in amounts under section  
11 1, if necessary to comply with an order of the President  
12 issued under section 254 of the Balanced Budget and  
13 Emergency Deficit Control Act of 1985 or to conform to  
14 any reduction in appropriations for the purposes of such  
15 section 1.
