A BILL

To amend the Public Health Service Act to increase the supply of pancreatic islet cells for research, and to provide for better coordination of Federal efforts and information on islet cell transplantation.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Pancreatic Islet Cell
5 Transplantation Act of 2004”.

1 **SEC. 2. ORGAN PROCUREMENT ORGANIZATION CERTIFI-**
2 **CATION.**

3 Section 371 of the Public Health Service Act (42
4 U.S.C. 273) is amended by adding at the end the fol-
5 lowing:

6 “(c) Pancreata procured by an organ procurement or-
7 ganization and used for islet cell transplantation or re-
8 search shall be counted for purposes of certification or re-
9 certification under subsection (b).”.

10 **SEC. 3. ANNUAL ASSESSMENT ON PANCREATIC ISLET CELL**
11 **TRANSPLANTATION.**

12 Section 429 of the Public Health Service Act (42
13 U.S.C. 285c-3) is amended by adding at the end the fol-
14 lowing:

15 “(d) In each annual report prepared by the Diabetes
16 Mellitus Interagency Coordinating Committee pursuant to
17 subsection (c), the Committee shall include an assessment
18 of the Federal activities and programs related to pan-
19 creatic islet cell transplantation. Such assessment shall,
20 at a minimum, address the following:

21 “(1) The adequacy of Federal funding for tak-
22 ing advantage of scientific opportunities relating to
23 pancreatic islet cell transplantation.

24 “(2) Current policies and regulations affecting
25 the supply of pancreata for islet cell transplantation.

1 “(3) The effect of xenotransplantation on ad-
2 vancing pancreatic islet cell transplantation.

3 “(4) The effect of United Network for Organ
4 Sharing policies regarding pancreas retrieval and
5 islet cell transplantation.

6 “(5) The existing mechanisms to collect and co-
7 ordinate outcomes data from existing islet cell trans-
8 plantation trials.

9 “(6) Implementation of multiagency clinical in-
10 vestigations of pancreatic islet cell transplantation.

11 “(7) Recommendations for such legislation and
12 administrative actions as the Committee considers
13 appropriate to increase the supply of pancreata
14 available for islet cell transplantation.”.
