RESOLUTION

Providing for consideration of the resolution (H. Res. 627) deploring the abuse of persons in United States custody in Iraq, regardless of the circumstances of their detention, urging the Secretary of the Army to bring to swift justice any member of the Armed Forces who has violated the Uniform Code of Military Justice, expressing the deep appreciation of the Nation to the courageous and honorable members of the Armed Forces who have

selflessly served, or are currently serving, in Operation Iraqi Freedom, and for other purposes.

1 *Resolved*, That upon the adoption of this resolution
2 it shall be in order to consider in the House the resolution
3 (H. Res. 627) deploring the abuse of persons in United
4 States custody in Iraq, regardless of the circumstances of
5 their detention, urging the Secretary of the Army to bring
6 to swift justice any member of the Armed Forces who has
7 violated the Uniform Code of Military Justice, expressing
8 the deep appreciation of the Nation to the courageous and
9 honorable members of the Armed Forces who have self-
10 lessly served, or are currently serving, in Operation Iraqi
11 Freedom, and for other purposes. The resolution shall be
12 considered as read for amendment. The previous question
13 shall be considered as ordered on the resolution to final
14 adoption without intervening motion or demand for a divi-
15 sion of the question except: (1) one hour of debate equally
16 divided and controlled by the chairman and ranking mi-
17 nority member of the Committee on Armed Services; and
18 (2) one motion to recommit which may not contain in-
19 structions.
