Mr. MORELLE, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 1644) to restore the open internet order of the Federal Communications Commission; providing for consideration of the bill (H.R. 2021) to amend the Balanced Budget and Emergency Deficit Control Act of 1985 and to establish a congressional budget for fiscal year 2020; and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of

1 the Whole House on the state of the Union for consider-
2 ation of the bill (H.R. 1644) to restore the open internet
3 order of the Federal Communications Commission. The
4 first reading of the bill shall be dispensed with. All points
5 of order against consideration of the bill are waived. Gen-
6 eral debate shall be confined to the bill and shall not ex-
7 ceed one hour equally divided and controlled by the chair
8 and ranking minority member of the Committee on En-
9 ergy and Commerce. After general debate the bill shall be
10 considered for amendment under the five-minute rule. In
11 lieu of the amendment in the nature of a substitute rec-
12 ommended by the Committee on Energy and Commerce
13 now printed in the bill, it shall be in order to consider
14 as an original bill for the purpose of amendment under
15 the five-minute rule an amendment in the nature of a sub-
16 stitute consisting of the text of Rules Committee Print
17 116-10. That amendment in the nature of a substitute
18 shall be considered as read. All points of order against
19 that amendment in the nature of a substitute are waived.
20 No amendment to that amendment in the nature of a sub-
21 stitute shall be in order except those printed in part A
22 of the report of the Committee on Rules accompanying
23 this resolution. Each such amendment may be offered only
24 in the order printed in the report, may be offered only
25 by a Member designated in the report, shall be considered

1 as read, shall be debatable for the time specified in the
2 report equally divided and controlled by the proponent and
3 an opponent, shall not be subject to amendment, and shall
4 not be subject to a demand for division of the question
5 in the House or in the Committee of the Whole. All points
6 of order against such amendments are waived. At the con-
7 clusion of consideration of the bill for amendment the
8 Committee shall rise and report the bill to the House with
9 such amendments as may have been adopted. Any Member
10 may demand a separate vote in the House on any amend-
11 ment adopted in the Committee of the Whole to the bill
12 or to the amendment in the nature of a substitute made
13 in order as original text. The previous question shall be
14 considered as ordered on the bill and amendments thereto
15 to final passage without intervening motion except one
16 motion to recommit with or without instructions.

17 SEC. 2. At any time after adoption of this resolution
18 the Speaker may, pursuant to clause 2(b) of rule XVIII,
19 declare the House resolved into the Committee of the
20 Whole House on the state of the Union for consideration
21 of the bill (H.R. 2021) to amend the Balanced Budget
22 and Emergency Deficit Control Act of 1985 and to estab-
23 lish a congressional budget for fiscal year 2020. The first
24 reading of the bill shall be dispensed with. All points of
25 order against consideration of the bill are waived. General

1 debate shall be confined to the bill and shall not exceed
2 one hour equally divided and controlled by the chair and
3 ranking minority member of the Committee on the Budg-
4 et. After general debate the bill shall be considered for
5 amendment under the five-minute rule. It shall be in order
6 to consider as an original bill for the purpose of amend-
7 ment under the five-minute rule an amendment in the na-
8 ture of a substitute consisting of the text of Rules Com-
9 mittee Print 116-11. That amendment in the nature of
10 a substitute shall be considered as read. All points of order
11 against that amendment in the nature of a substitute are
12 waived. No amendment to that amendment in the nature
13 of a substitute shall be in order except those printed in
14 part B of the report of the Committee on Rules accom-
15 panying this resolution. Each such amendment may be of-
16 fered only in the order printed in the report, may be of-
17 fered only by a Member designated in the report, shall
18 be considered as read, shall be debatable for the time spec-
19 ified in the report equally divided and controlled by the
20 proponent and an opponent, shall not be subject to amend-
21 ment, and shall not be subject to a demand for division
22 of the question in the House or in the Committee of the
23 Whole. All points of order against such amendments are
24 waived. At the conclusion of consideration of the bill for
25 amendment the Committee shall rise and report the bill

1 to the House with such amendments as may have been
2 adopted. Any Member may demand a separate vote in the
3 House on any amendment adopted in the Committee of
4 the Whole to the bill or to the amendment in the nature
5 of a substitute made in order as original text. The previous
6 question shall be considered as ordered on the bill and
7 amendments thereto to final passage without intervening
8 motion except one motion to recommit with or without in-
9 structions.

10 SEC. 3. House Resolution 293 is hereby adopted.

11 SEC. 4. On any legislative day during the period from
12 April 11, 2019, through April 26, 2019—

13 (a) the Journal of the proceedings of the previous day
14 shall be considered as approved; and

15 (b) the Chair may at any time declare the House ad-
16 journed to meet at a date and time, within the limits of
17 clause 4, section 5, article I of the Constitution, to be an-
18 nounced by the Chair in declaring the adjournment.

19 SEC. 5. The Speaker may appoint Members to per-
20 form the duties of the Chair for the duration of the period
21 addressed by section 4 of this resolution as though under
22 clause 8(a) of rule I.

23 SEC. 6. Each day during the period addressed by sec-
24 tion 4 of this resolution shall not constitute a calendar

1 day for purposes of section 7 of the War Powers Resolu-
2 tion (50 U.S.C. 1546).

3 SEC. 7. Each day during the period addressed by sec-
4 tion 4 of this resolution shall not constitute a legislative
5 day for purposes of clause 7 of rule XIII.
