A BILL

To make revisions in title 51, United States Code, as necessary to keep the title current, and to make technical amendments to improve the United States Code.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TABLE OF CONTENTS.**

1 **SEC. 2. PURPOSES; RESTATEMENT DOES NOT CHANGE**
2 **MEANING OR EFFECT OF EXISTING LAW.**

3 (a) PURPOSES.—The purposes of this Act are—

4 (1) to make revisions in title 51, United States
5 Code, as necessary to keep the title current; and

6 (2) to make technical amendments to improve
7 the United States Code.

8 (b) RESTATEMENT DOES NOT CHANGE MEANING OR
9 EFFECT OF EXISTING LAW.—

10 (1) IN GENERAL.—The restatement of existing
11 law enacted by this Act does not change the mean-
12 ing or effect of the existing law. The restatement in-
13 corporates in title 51, United States Code, various
14 provisions that were enacted separately over a period
15 of years, reorganizing them, conforming style and
16 terminology, modernizing obsolete language, and cor-
17 recting drafting errors. These changes serve to re-
18 move ambiguities, contradictions, and other imper-
19 fections, but they do not change the meaning or ef-
20 fect of the existing law or impair the precedential
21 value of earlier judicial decisions or other interpreta-
22 tions.

1 (2) RULE OF CONSTRUCTION.—

2 (A) IN GENERAL.—Notwithstanding the
 3 plain meaning rule or other rules of statutory
 4 construction, a change in wording made in the
 5 restatement of existing law enacted by this Act
 6 serves to clarify the existing law as indicated in
 7 paragraph (1), but not to change the meaning
 8 or effect of the existing law.

9 (B) REVISION NOTES.—Subparagraph (A)
 10 applies whether or not a change in wording is
 11 explained by a revision note appearing in a con-
 12 gressional report accompanying this Act. If
 13 such a revision note does appear, a court shall
 14 consider the revision note in interpreting the
 15 change.

11 title 51, United States Code, is amended—

12 (1) in subsection (a), by striking “The Adminis-
13 tration may carry out a program to award prizes
14 only in conformity with this section.”; and

15 (2) in subsection (i)(4), by striking “Committee
16 on Science and Technology” and inserting “Com-
17 mittee on Science, Space, and Technology”.

18 (c) REVISION OF SECTION 20145.—Section 20145 of
19 title 51, United States Code, is amended—

1 (1) by redesignating subsections (f) and (g) as
2 subsections (g) and (h), respectively; and

3 (2) by inserting after subsection (e) the fol-
4 lowing:

5 “(f) PROCEEDS.—Proceeds from leases entered into
6 under this section shall be deposited in the Administration
7 construction and environmental compliance and restora-
8 tion appropriations account. The proceeds shall be avail-
9 able for a period of 5 years, to the extent and in amounts
10 provided in appropriations acts.”.

22 “(1) IN GENERAL.—The Administrator shall
23 evaluate and, to the extent possible—

24 “(A) expand efforts to maximize the Ad-
25 ministration’s contribution to interagency ef-

1 forts to enhance science, technology, engineer-
 2 ing, and mathematics education capabilities;
 3 and

4 “(B) enhance the Nation’s technological
 5 excellence and global competitiveness.

6 “(2) IDENTIFICATION IN REPORT.—The Admin-
 7 istrator shall identify the expanded efforts and en-
 8 hancements made under paragraph (1) in the annual
 9 reports required by subsection (e).”.

10 (e) REVISION OF CHAPTER 301.—

11 (1) CHAPTER HEADING.—The chapter heading
 12 of chapter 301 of title 51, United States Code, is
 13 amended by striking “**APPROPRIATIONS,**
 14 **BUDGETS, AND ACCOUNTING**” and insert-
 15 ing “**FUNDING**”.

16 (2) CHAPTER TABLE OF CONTENTS.—The

9 implementation during the preceding year of the corrective
10 action plan referred to in section 1203(a)(4) of the Na-

13 “(b) CONTENTS.—A report under this section shall
14 contain the following:

15 “(1) DESCRIPTION OF OVER-BUDGET OR DE-
16 LAYED PROGRAMS.—For the year covered by the re-
17 port, a description of each Administration program
18 that has exceeded its cost baseline by 15 percent or
19 more or is more than 2 years behind its projected
20 development schedule.

21 “(2) CORRECTIVE PLANS.—For each program
22 described under paragraph (1), a plan for a decrease
23 in scope or requirements, or other measures, to be
24 undertaken to control cost and schedule, including
25 any cost monitoring or corrective actions undertaken

1 pursuant to the National Aeronautics and Space Ad-
2 ministration Authorization Act of 2005 (Public Law
3 109–155), and the amendments made by that Act.”.

4 (7) REVISION OF SECTION 30121.—Section
5 30121 of title 51, United States Code (as redesign-
6 nated and transferred by paragraph (3)(A)), is
7 amended—

8 (A) in the section heading, by striking
9 “**Budgets**” and inserting “**General budget**
10 **documentation requirements**”; and

11 (B) in subsection (b) (matter before para-
12 graph (1)), by striking “Committee on Science
13 and Technology” and inserting “Committee on
14 Science, Space, and Technology”.

 2 **mate**

3 “Each fiscal year, the President shall submit to Con-
 4 gress a budget request for the Administration that in-
 5 cludes—

6 “(1) a budget request for the immediate fiscal
 7 year and the following fiscal year; and

8 “(2) budget estimates for the 3d fiscal year.”.

9 (f) REVISION OF SECTION 30310.—Section 30310 of
 10 title 51, United States Code, is amended by striking “Sec-
 11 tion 526(a) of the Energy Independence and Security Act
 12 of 2007 (42 U.S.C. 17142(a))” and inserting “Section
 13 526 of the Energy Independence and Security Act of 2007
 14 (42 U.S.C. 17142)”.

15 (g) ENACTMENT OF SECTION 30311.—

16 (1) CHAPTER TABLE OF CONTENTS.—The
 17 chapter table of contents of chapter 303 of title 51,
 18 United States Code, is amended by adding at the
 19 end the following:

“30311. Counterfeit parts.”.

20 (2) ENACTMENT OF SECTION.—Chapter 303 of
 21 title 51, United States Code, is amended by adding
 22 at the end the following:

23 **“§ 30311. Counterfeit parts**

24 “(a) IN GENERAL.—The Administrator shall plan,
 25 develop, and implement a program, in coordination with

1 other Federal agencies, to detect, track, catalog, and re-
2 duce the number of counterfeit electronic parts in the Ad-
3 ministration supply chain.

4 “(b) REQUIREMENTS.—In carrying out the program,
5 the Administrator shall establish—

6 “(1) counterfeit part identification training for
7 all employees who procure, process, distribute, and
8 install electronic parts that will—

9 “(A) teach employees how to identify coun-
10 terfeit parts;

11 “(B) educate employees on procedures to
12 follow if they suspect a part is counterfeit;

13 “(C) regularly update employees on new
14 threats, identification techniques, and reporting
15 requirements; and

16 “(D) integrate industry associations, man-
17 ufacturers, suppliers, and other Federal agen-
18 cies, as appropriate;

19 “(2) an internal database to track all suspected
20 and confirmed counterfeit electronic parts that will
21 maintain, at a minimum—

22 “(A) companies and individuals known and
23 suspected of selling counterfeit parts;

1 “(B) parts known and suspected of being
2 counterfeit, including lot and date codes, part
3 numbers, and part images;

4 “(C) countries of origin;

5 “(D) sources of reporting;

6 “(E) United States Customs seizures; and

7 “(F) Government-Industry Data Exchange
8 Program reports and other public- or private-
9 sector database notifications; and

10 “(3) a mechanism—

11 “(A) to report all information on suspected
12 and confirmed counterfeit electronic parts to
13 law enforcement agency databases, industry as-
14 sociation databases, and other databases; and

15 “(B) to issue bulletins to industry on coun-
16 terfeit electronic parts and related counterfeit
17 activity.

18 “(c) REVIEW OF PROCUREMENT AND ACQUISITION
19 POLICY.—

20 “(1) IN GENERAL.—In establishing the pro-
21 gram, the Administrator shall amend acquisition and
22 procurement policy in effect on October 11, 2010, to
23 require the purchase of electronic parts from trusted
24 or approved manufacturers. To determine trusted or
25 approved manufacturers, the Administrator shall es-

1 establish a list, assessed and adjusted at least annu-
2 ally, and create criteria for manufacturers to meet
3 in order to be placed on the list.

4 “(2) CRITERIA.—The criteria may include—

5 “(A) authentication or encryption codes;

6 “(B) embedded security markings in parts;

7 “(C) unique, hard-to-copy labels and mark-
8 ings;

9 “(D) identification of distinct lot and serial
10 codes on external packaging;

11 “(E) radio frequency identification embed-
12 ded into high-value parts;

13 “(F) physical destruction of all defective,
14 damaged, and sub-standard parts that are by-
15 products of the manufacturing process;

16 “(G) testing certifications;

17 “(H) maintenance of procedures for han-
18 dling any counterfeit parts that slip through;

19 “(I) maintenance of secure facilities to pre-
20 vent unauthorized access to proprietary infor-
21 mation; and

22 “(J) maintenance of product return, buy
23 back, and inventory control practices that limit
24 counterfeiting.”.

25 (h) ENACTMENT OF SECTIONS 30505 AND 30506.—

1 (1) CHAPTER TABLE OF CONTENTS.—The
2 chapter table of contents of chapter 305 of title 51,
3 United States Code, is amended by adding at the

9 “(a) DEFINITION OF INFORMATION INFRASTRUC-
10 TURE.—In this section, the term ‘information infrastruc-
11 ture’ means the underlying framework that information
12 systems and assets rely on to process, transmit, receive,
13 or store information electronically, including program-
14 mable electronic devices and communications networks
15 and any associated hardware, software, or data.

16 “(b) MONITORING RISK.—

17 “(1) BIENNIAL UPDATE ON SYSTEM IMPLEMEN-
18 TATION.—On a biennial basis, the chief information
19 officer of the Administration, in coordination with
20 other national security agencies, shall provide to the
21 Committee on Commerce, Science, and Transpor-
22 tation of the Senate and the Committee on Science,
23 Space, and Technology of the House of Representa-
24 tives—

1 “(A) an update on efforts to implement a
2 system to provide dynamic, comprehensive, real-
3 time information regarding risk of unauthorized
4 remote, proximity, and insider use or access, for
5 all information infrastructure under the respon-
6 sibility of the chief information officer, and mis-
7 sion-related networks, including contractor net-
8 works;

9 “(B) an assessment of whether the system
10 has demonstrably and quantifiably reduced net-
11 work risk compared with alternative methods of
12 measuring security; and

13 “(C) an assessment of the progress that
14 each center and facility has made toward imple-
15 menting the system.

16 “(2) EXISTING ASSESSMENTS.—The assess-
17 ments required of the Inspector General under sec-
18 tion 3555 of title 44 shall evaluate the effectiveness
19 of the system described in this subsection.

20 “(c) INFORMATION SECURITY AWARENESS AND EDU-
21 CATION.—

22 “(1) IN GENERAL.—In consultation with the
23 Department of Education, other national security
24 agencies, and other agency directorates, the chief in-
25 formation officer shall institute an information secu-

1 rity awareness and education program for all opera-
2 tors and users of Administration information infra-
3 structure, with the goal of reducing unauthorized re-
4 mote, proximity, and insider use or access.

5 “(2) PROGRAM REQUIREMENTS.—

6 “(A) BRIEFINGS, EXERCISES, AND EXAMI-
7 NATIONS.—The program shall include, at a
8 minimum, ongoing classified and unclassified
9 threat-based briefings, and automated exercises
10 and examinations that simulate common attack
11 techniques.

12 “(B) PARTICIPATION.—All agency employ-
13 ees and contractors engaged in the operation or
14 use of agency information infrastructure shall
15 participate in the program.

16 “(C) ACCESS.—Access to Administration
17 information infrastructure shall be granted only
18 to operators and users who regularly satisfy the
19 requirements of the program.

20 “(D) REWARDING ACHIEVEMENT.—The
21 chief human capital officer of the Administra-
22 tion, in consultation with the chief information
23 officer, shall create a system to reward opera-
24 tors and users of agency information infrastruc-

1 ture for continuous high achievement in the
2 program.

3 **“§ 30506. Workforce development for minority and**
4 **underrepresented groups**

5 “(a) ADDRESSING IMPEDIMENTS.—To the extent
6 practicable, the Administrator shall take all necessary
7 steps to address any impediments identified in the assess-
8 ment described in subsection (b).

9 “(b) ASSESSMENT.—The assessment referred to in
10 subsection (a) is the independent assessment of impedi-
11 ments to space science and engineering workforce develop-
12 ment for minority and underrepresented groups at the Ad-
13 ministration that was prepared under section 203(a) of
14 the America COMPETES Reauthorization Act of 2010
15 (Public Law 111–358, 124 Stat. 3994).”.

16 (i) REVISION OF SECTION 30704.—Section 30704(2)
17 of title 51, United States Code, is amended by striking
18 “the Buy American Act (41 U.S.C. 10a et seq.)” and in-
19 serting “chapter 83 of title 41”.

20 (j) ENACTMENT OF SECTION 30705.—

21 (1) CHAPTER TABLE OF CONTENTS.—The
22 chapter table of contents of chapter 307 of title 51,
23 United States Code, is amended by adding at the
24 end the following:

“30705. Limitation on international agreements concerning outer space activi-
ties.”.

1 (2) ENACTMENT OF SECTION.—Chapter 307 of
2 title 51, United States Code, is amended by adding
3 at the end the following:

4 **“§ 30705. Limitation on international agreements con-**
5 **cerning outer space activities**

6 “(a) DEFINITIONS.—In this section:

7 “(1) CONGRESSIONAL DEFENSE COMMIT-
8 TEES.—The term ‘congressional defense committees’
9 means—

10 “(A) the Committee on Armed Services
11 and the Committee on Appropriations of the
12 Senate; and

13 “(B) the Committee on Armed Services
14 and the Committee on Appropriations of the
15 House of Representatives.

16 “(2) COVERED CONGRESSIONAL COMMIT-
17 TEES.—The term ‘covered congressional committees’
18 means—

19 “(A) the Committee on Armed Services,
20 the Committee on Foreign Relations, and the
21 Select Committee on Intelligence of the Senate;
22 and

23 “(B) the Committee on Armed Services,
24 the Committee on Foreign Affairs, and the Per-

1 manent Select Committee on Intelligence of the
2 House of Representatives.

3 “(b) CERTIFICATION.—If the United States becomes
4 a signatory to a non-legally binding international agree-
5 ment concerning an International Code of Conduct for
6 Outer Space Activities or any similar agreement, at the
7 same time as the United States becomes a signatory—

8 “(1) the President shall submit to the congres-
9 sional defense committees, the Permanent Select
10 Committee on Intelligence of the House of Rep-
11 resentatives, and the Select Committee on Intel-
12 ligence of the Senate a certification that the agree-
13 ment has no legally binding effect or basis for lim-
14 iting the activities of the United States in outer
15 space; and

16 “(2) the Secretary of Defense, the Chairman of
17 the Joint Chiefs of Staff, and the Director of Na-
18 tional Intelligence shall jointly submit to the con-
19 gressional defense committees a certification that
20 the agreement will be equitable, enhance national se-
21 curity, and have no militarily significant impact on
22 the ability of the United States to conduct military
23 or intelligence activities in space.

24 “(c) BRIEFINGS AND NOTIFICATIONS REQUIRED.—

1 “(1) RESTATEMENT OF POLICY FORMULATION
2 UNDER THE ARMS CONTROL AND DISARMAMENT ACT
3 WITH RESPECT TO OUTER SPACE.—No action shall
4 be taken that would obligate the United States to re-
5 duce or limit the Armed Forces or armaments of the
6 United States in outer space in a militarily signifi-
7 cant manner, except pursuant to the treaty-making
8 power of the President under Article II, Section 2,
9 Clause II of the Constitution or unless authorized by
10 the enactment of further affirmative legislation by
11 Congress.

12 “(2) BRIEFINGS.—

13 “(A) REQUIREMENT.—The Secretary of
14 Defense, the Secretary of State, and the Direc-
15 tor of National Intelligence shall jointly provide
16 to the covered congressional committees reg-
17 ular, detailed updates on the negotiation of a
18 non-legally binding international agreement
19 concerning an International Code of Conduct
20 for Outer Space Activities or any similar agree-
21 ment.

22 “(B) TERMINATION OF REQUIREMENT.—
23 The requirement to provide regular briefings
24 under subparagraph (A) shall terminate on the
25 date on which the United States becomes a sig-

1 natory to an agreement referred to in subpara-
2 graph (A), or on the date on which the Presi-
3 dent certifies to Congress that the United
4 States is no longer negotiating an agreement
5 referred to in subparagraph (A), whichever is
6 earlier.

7 “(3) NOTIFICATIONS.—If the United States be-
8 comes a signatory to a non-legally binding inter-
9 national agreement concerning an International
10 Code of Conduct for Outer Space Activities or any
11 similar agreement, not less than 60 days prior to
12 any action that would obligate the United States to
13 reduce or limit the Armed Forces, armaments, or ac-
14 tivities of the United States in outer space, the head
15 of each Department or agency of the Federal Gov-
16 ernment that would be affected by the action shall
17 submit to Congress a notice of the action and its ef-
18 fect on the Department or agency.”.

19 (k) REDESIGNATION OF CHAPTER 315 AS CHAPTER
20 399.—

21 (1) RESERVED CHAPTERS.—Title 51, United
22 States Code, is amended by inserting after section
23 31302 the following:

24 **“CHAPTERS 317 THROUGH 397—RE-**
25 **SERVED”.**

1 (2) REDESIGNATION OF CHAPTER.—Title 51,
2 United States Code, is amended by redesignating
3 chapter 315 as chapter 399.

4 (3) REDESIGNATION OF SECTIONS.—Chapter
5 399 of title 51, United States Code (as redesignated
6 by paragraph (2)), is amended—

7 (A) in the chapter table of contents, by re-
8 designating the items for sections 31501

7 “(5) COMMERCIAL CREW RESCUE CAPABILI-
8 TIES.—The provision of a commercial capability to
9 provide International Space Station crew services
10 shall include crew rescue requirements, and shall be
11 undertaken through the procurement process initi-
12 ated in conformance with this section. In the event
13 such development is initiated, the Administrator
14 shall make available any relevant government-owned
15 intellectual property deriving from the development
16 of a multipurpose crew vehicle authorized by this
17 section and sections 71522 and 71523 of this title
18 to commercial entities involved with such crew res-
19 cue capability development which shall be relevant to
20 the design of a crew rescue capability. In addition,
21 the Administrator shall seek to ensure that contracts
22 for development of the multipurpose crew vehicle
23 contain provisions for the licensing of relevant intel-
24 lectual property to participating commercial pro-
25 viders of any crew rescue capability development un-

1 dertaken pursuant to this section. If 1 or more con-
2 tractors involved with development of the multipur-
3 pose crew vehicle seek to compete in development of
4 a commercial crew service with crew rescue capa-
5 bility, separate legislative authority must be enacted
6 to enable the Administrator to provide funding for
7 any modifications of the multipurpose crew vehicle
8 necessary to fulfill the International Space Station
9 crew rescue function.

17 “(d) COST MINIMIZATION.—The Administrator shall
18 strive through the competitive selection process to mini-

6 “(B) USE OF INTERNATIONAL SPACE STA-
7 TION.—The International Space Station shall
8 continue to be utilized as a key component of
9 international efforts to build missions and capa-
10 bilities that further the development of a
11 human presence beyond near-Earth space and
12 advance United States security and economic
13 goals. The Administrator shall actively seek
14 ways to encourage and enable the use of Inter-
15 national Space Station capabilities to support

3 “(a) IN GENERAL.—The Administrator shall take all
4 actions necessary to ensure the safe and effective oper-
5 ation, maintenance, and maximum utilization of the
6 United States segment of the International Space Station
7 through at least September 30, 2024.

8 “(b) PLANNING, MANAGEMENT, AND SUPPORT.—
9 Utilization of research facilities and capabilities aboard

11 related research and technology development facilities and
12 capabilities, and associated ground support and logistics)

26 provide initial financial assistance and enter into a

1 cooperative agreement with an appropriate organiza-

21 without any other organizational objectives or re-

1 “(1) DESIGNATION.—The Administrator shall
2 designate an official or employee of the Space Oper-
3 ations Mission Directorate of the Administration to
4 act as liaison between the Administration and the
5 organization with which the Administrator enters
6 into a cooperative agreement under subsection (a)
7 with regard to the management of the International
8 Space Station national laboratory.

9 “(2) CONSULTATION WITH LIAISON.—The coop-
10 erative agreement shall require the organization en-
11 tering into the agreement to carry out its respon-
12 sibilities under the agreement in cooperation and
13 consultation with the official or employee designated
14 under paragraph (1).

15 “(c) PLANNING AND COORDINATION OF NATIONAL
16 LABORATORY RESEARCH ACTIVITIES.—The Adminis-
17 trator shall provide initial financial assistance to the orga-
18 nization with which the Administrator enters into a coop-
19 erative agreement under subsection (a), in order for the
20 organization to initiate the following:

21 “(1) Planning and coordination of the Inter-
22 national Space Station national laboratory research
23 activities.

24 “(2) Development and implementation of guide-
25 lines, selection criteria, and flight support require-

1 ments for non-Administration scientific utilization of
2 International Space Station research capabilities and
3 facilities available in United States-owned modules
4 of the International Space Station or in partner-
5 owned facilities of the International Space Station
6 allocated to United States utilization by inter-
7 national agreement.

8 “(3) Interaction with and integration of the
9 International Space Station National Laboratory
10 Advisory Committee established under section 70906
11 of this title with the governance of the organization,
12 and review of recommendations provided by that
13 Committee regarding agreements with non-Adminis-
14 tration departments and agencies of the United
15 States Government, academic institutions and con-
16 sortia, and commercial entities leading to the utiliza-
17 tion of the International Space Station national lab-
18 oratory facilities.

19 “(4) Coordination of transportation require-
20 ments in support of the International Space Station
21 national laboratory research and development objec-
22 tives, including provision for delivery of instruments,
23 logistics support, and related experiment materials,

2 replacement or upgrade.

3 “(5) Cooperation with the Administration, other

8 support facilities for the International Space Sta-
9 tion, including the Space Life Sciences Laboratory,

12 “(6) Development and implementation of sci-
13 entific outreach and education activities designed to
14 ensure effective utilization of International Space
15 Station research capabilities, including the conduct
16 of scientific assemblies, conferences, and other fora
17 for the presentation of research findings, methods,
18 and mechanisms for the dissemination of non-re-
19 stricted research findings and the development of
20 educational programs, course supplements, and
21 interaction with educational programs at all grade
22 levels, including student-focused research opportuni-
23 ties for conduct of research in the International
24 Space Station national laboratory facilities.

1 “(7) Other matters relating to the utilization of
2 the International Space Station national laboratory
3 facilities for research and development as the Ad-
4 ministrator considers appropriate.

5 “(d) RESEARCH CAPACITY ALLOCATION AND INTE-
6 GRATION OF RESEARCH PAYLOADS.—

7 “(1) ALLOCATION OF INTERNATIONAL SPACE
8 STATION RESEARCH CAPACITY.—International Space
9 Station national laboratory managed experiments
10 shall be guaranteed access to, and utilization of, not
11 less than 50 percent of the United States research
12 capacity allocation, including power, cold stowage,
13 and requisite crew time onboard the International
14 Space Station through at least September 30, 2024.
15 Access to the International Space Station research
16 capacity includes provision for the adequate upmass
17 and downmass capabilities to utilize the Inter-
18 national Space Station research capacity, as avail-
19 able. The Administrator may allocate additional ca-
20 pacity to the International Space Station national
21 laboratory should such capacity be in excess of Ad-
22 ministration research requirements.

23 “(2) ADDITIONAL RESEARCH CAPABILITIES.—If
24 any Administration research plan is determined to
25 require research capacity onboard the International

1 Space Station beyond the percentage allocated under
2 paragraph (1), the research plan shall be prepared
3 in the form of a requested research opportunity to
4 be submitted to the process established under this
5 section for the consideration of proposed research
6 within the capacity allocated to the International
7 Space Station national laboratory. A proposal for
8 such a research plan may include the establishment
9 of partnerships with non-Administration institutions
10 eligible to propose research to be conducted within
11 the International Space Station national laboratory
12 capacity. Until at least September 30, 2024, the of-
13 ficial or employee designated under subsection (b)
14 may grant an exception to this requirement in the
15 case of a proposed experiment considered essential

 11 **PROVISIONS**

12 **“§ 71501. Definitions**

13 “In this chapter:

1 “(1) CIS-LUNAR SPACE.—The term ‘cis-lunar
2 space’ means the region of space from the Earth out
3 to and including the region around the surface of
4 the Moon.

5 “(2) DEEP SPACE.—The term ‘deep space’
6 means the region of space beyond cis-lunar space.

7 “(3) NEAR-EARTH SPACE.—The term ‘near-
8 Earth space’ means the region of space that includes
9 low-Earth orbit and extends out to and includes geo-
10 synchronous orbit.

11 “(4) SPACE LAUNCH SYSTEM.—The term
12 ‘Space Launch System’ means the follow-on Govern-
13 ment-owned civil launch system developed, managed,
14 and operated by the Administration to serve as a
15 key component to expand human presence beyond
16 low-Earth orbit.

17 **“Subchapter II—POLICY, GOALS,** 18 **AND OBJECTIVES**

19 **“§ 71511. Human space flight policy**

20 “(a) USE OF NON-UNITED STATES HUMAN SPACE
21 FLIGHT TRANSPORTATION SERVICES.—

22 “(1) DEFINITIONS.—In this subsection:

23 “(A) COMMERCIAL PROVIDER.—The term
24 ‘commercial provider’ means any person pro-
25 viding human space flight transportation serv-

1 ices, primary control of which is held by persons
2 other than the Federal Government, a State or
3 local government, or a foreign government.

4 “(B) QUALIFIED FOREIGN ENTITY.—The
5 term ‘qualified foreign entity’ means a foreign
6 entity that is in compliance with all applicable
7 safety standards and is not prohibited from
8 providing space transportation services under
9 other law.

10 “(C) UNITED STATES COMMERCIAL PRO-
11 VIDER.—The term ‘United States commercial
12 provider’ means a commercial provider, orga-
13 nized under the laws of the United States or of
14 a State, that is more than 50 percent owned by
15 United States nationals.

16 “(2) IN GENERAL.—The Federal Government
17 may not acquire human space flight transportation
18 services from a foreign entity unless—

19 “(A) no United States Government-oper-
20 ated human space flight capability is available;

21 “(B) no United States commercial provider
22 is available; and

23 “(C) it is a qualified foreign entity.

24 “(3) ARRANGEMENTS WITH FOREIGN ENTI-
25 TIES.—Nothing in this subsection shall prevent the

1 Administrator from negotiating or entering into
2 human space flight transportation arrangements
3 with foreign entities to ensure safety of flight and
4 continued International Space Station operations.

5 “(b) UNITED STATES HUMAN SPACE FLIGHT CAPA-
6 BILITIES.—Congress reaffirms the policy stated in section
7 70501(a) of this title that the United States shall main-
8 tain an uninterrupted capability for human space flight
9 and operations in low-Earth orbit, and beyond, as an es-
10 sential instrument of national security and of the capacity
11 to ensure continued United States participation and lead-
12 ership in the exploration and utilization of space.

13 **“§ 71512. Goals and objectives**

14 “(a) LONG-TERM GOALS.—The long-term goals of
15 the human space flight and exploration efforts of the Ad-
16 ministration shall be—

17 “(1) to expand permanent human presence be-
18 yond low-Earth orbit and to do so, where practical,
19 in a manner involving international, academic, and
20 industry partners;

21 “(2) crewed missions and progress toward
22 achieving the goal in paragraph (1) to enable the po-
23 tential for subsequent human exploration and the ex-
24 tension of human presence throughout the solar sys-
25 tem; and

1 “(3) to enable a capability to extend human
2 presence, including potential human habitation on
3 another celestial body and a thriving space economy
4 in the 21st century.

5 “(b) KEY OBJECTIVES.—The key objectives of the
6 United States for human expansion into space shall be—

7 “(1) to sustain the capability for long-duration
8 presence in low-Earth orbit, initially through con-
9 tinuation of the International Space Station and full
10 utilization of the United States segment of the
11 International Space Station as a national laboratory,
12 and through assisting and enabling an expanded
13 commercial presence in, and access to, low-Earth
14 orbit, as elements of a low-Earth orbit infrastruc-
15 ture;

16 “(2) to determine whether humans can live for
17 extended periods in space with decreasing reliance
18 on Earth, starting with utilization of low-Earth orbit
19 infrastructure, to—

20 “(A) identify potential roles that space re-
21 sources such as energy and materials can play;

22 “(B) meet national and global needs and
23 challenges such as potential cataclysmic threats;
24 and

1 “(C) explore the viability of and lay the
2 foundation for sustainable economic activities in
3 space;

4 “(3) to maximize the role that human explo-
5 ration of space can play in—

6 “(A) advancing overall knowledge of the
7 universe;

8 “(B) supporting United States national
9 and economic security and the United States
10 global competitive posture; and

11 “(C) inspiring young people in their edu-
12 cational pursuits;

13 “(4) to build on the cooperative and mutually
14 beneficial framework established by the International
15 Space Station partnership agreements and experi-
16 ence in developing and undertaking programs and
17 meeting objectives designed to realize the goal of
18 human space flight set forth in subsection (a); and

19 “(5) to achieve human exploration of Mars and
20 beyond through the prioritization of those tech-
21 nologies and capabilities best suited for such a mis-
22 sion in accordance with the stepping stone approach
23 to exploration under section 70504 of this title.

1 **“Subchapter III—EXPANSION OF**
2 **HUMAN SPACE FLIGHT BE-**
3 **YOND THE INTERNATIONAL**
4 **SPACE STATION AND LOW-**
5 **EARTH ORBIT**

6 **“§ 71521. Space Launch System as follow-on launch**
7 **vehicle to the space shuttle**

8 “(a) POLICY.—It is the policy of the United States
9 that the Administration develop a Space Launch System
10 as a follow-on to the space shuttle that can access cis-
11 lunar space and the regions of space beyond low-Earth
12 orbit in order to enable the United States to participate
13 in global efforts to access and develop that increasingly
14 strategic region.

15 “(b) INITIATION OF DEVELOPMENT.—

16 “(1) IN GENERAL.—As soon as practicable
17 after October 11, 2010, the Administrator shall ini-
18 tiate development of a Space Launch System meet-
19 ing the minimum capability requirements specified
20 in subsection (c).

21 “(2) MODIFICATION OF CURRENT CON-
22 TRACTS.—In order to limit the Administration’s ter-
23 mination liability costs and support critical capabili-
24 ties, the Administrator shall, to the extent prac-
25 ticable, extend or modify existing (as of October 11,

1 2010) vehicle development and associated contracts
2 necessary to meet the requirement in paragraph (1),
3 including contracts for ground testing of solid rocket
4 motors, if necessary, to ensure their availability for
5 development of the Space Launch System.

6 “(c) MINIMUM CAPABILITY REQUIREMENTS.—

7 “(1) IN GENERAL.—The Space Launch System
8 developed pursuant to subsection (b) shall be de-
9 signed to have, at a minimum, the following:

10 “(A) The initial capability of the core ele-
11 ments, without an upper stage, of lifting pay-
12 loads weighing between 70 and 100 tons into
13 low-Earth orbit in preparation for transit for
14 missions beyond low-Earth orbit.

15 “(B) The capability to carry an integrated
16 upper Earth departure stage bringing the total
17 lift capability of the Space Launch System to
18 130 tons or more.

19 “(C) The capability to lift the multipur-
20 pose crew vehicle.

21 “(D) The capability to serve as a backup
22 system for supplying and supporting Inter-
23 national Space Station cargo delivery require-
24 ments or crew delivery requirements not other-

1 wise met by available commercial or partner-
2 supplied vehicles.

3 “(E) The capacity for efficient and timely
4 evolution, including the incorporation of new
5 technologies, competition of sub-elements, and
6 commercial operations.

7 “(2) FLEXIBILITY.—The Space Launch System
8 shall be designed from inception as a fully integrated
9 vehicle capable of carrying a total payload of 130
10 tons or more into low-Earth orbit in preparation for
11 transit for missions beyond low-Earth orbit. The
12 Space Launch System shall, to the extent prac-
13 ticable, incorporate capabilities for evolutionary
14 growth to carry heavier payloads. Developmental
15 work and testing of the core elements and the upper
16 stage should proceed in parallel subject to appropria-
17 tions. Priority should be placed on the core elements
18 with the goal for operational capability for the core
19 elements not later than December 31, 2016.

20 “(3) TRANSITION NEEDS.—The Administrator
21 shall ensure that critical skills and capabilities are
22 retained, modified, and developed, as appropriate, in
23 areas relating to solid and liquid engines, large di-
24 ameter fuel tanks, rocket propulsion, and other

1 ground test capabilities for an effective transition to
2 the follow-on Space Launch System.

3 **“§ 71522. Multipurpose crew vehicle**

4 “(a) INITIATION OF DEVELOPMENT.—

5 “(1) IN GENERAL.—The Administrator shall
6 continue the development of a multipurpose crew ve-
7 hicle to be available as soon as practicable, and no
8 later than for use with the Space Launch System.
9 The vehicle shall continue to advance development of
10 the human safety features, designs, and systems in
11 the Orion project.

12 “(2) GOAL FOR OPERATIONAL CAPABILITY.—It
13 shall be the goal to achieve full operational capa-
14 bility for the transportation vehicle developed pursu-
15 ant to this subsection by not later than December
16 31, 2016. For purposes of meeting such goal, the
17 Administrator may undertake a test of the transpor-
18 tation vehicle at the International Space Station be-
19 fore that date.

20 “(b) MINIMUM CAPABILITY REQUIREMENTS.—The
21 multipurpose crew vehicle developed pursuant to sub-
22 section (a) shall be designed to have, at a minimum, the
23 following:

24 “(1) The capability to serve as the primary
25 crew vehicle for missions beyond low-Earth orbit.

1 “(2) The capability to conduct regular in-space
2 operations, such as rendezvous, docking, and extra-
3 vehicular activities, in conjunction with payloads de-
4 livered by the Space Launch System developed pur-
5 suant to section 71521 of this title, or other vehicles,
6 in preparation for missions beyond low-Earth orbit
7 or servicing of assets described in section 71543 of
8 this title, or other assets in cis-lunar space.

9 “(3) The capability to provide an alternative
10 means of delivery of crew and cargo to the Inter-
11 national Space Station, in the event other vehicles,
12 whether commercial vehicles or partner-supplied ve-
13 hicles, are unable to perform that function.

14 “(4) The capacity for efficient and timely evo-
15 lution, including the incorporation of new tech-
16 nologies, competition of sub-elements, and commer-
17 cial operations.

18 **“§ 71523. Utilization of existing workforce and assets**
19 **in development of Space Launch System**
20 **and multipurpose crew vehicle**

21 “(a) IN GENERAL.—In developing the Space Launch
22 System pursuant to section 71521 of this title and the
23 multipurpose crew vehicle pursuant to section 71522 of
24 this title, the Administrator shall, to the extent prac-
25 ticable, utilize—

1 “(1) existing (as of October 11, 2010) con-
2 tracts, investments, workforce, industrial base, and
3 capabilities from the space shuttle and Orion and
4 Ares 1 projects, including—

5 “(A) spacesuit development activities for
6 application to, and coordinated development of,
7 a multipurpose crew vehicle suit and associated
8 life-support requirements with potential devel-
9 opment of standard Administration-certified
10 suit and life support systems for use in alter-
11 native commercially developed crew transpor-
12 tation systems; and

13 “(B) space shuttle-derived components and
14 Ares 1 components that use existing (as of Oc-
15 tober 11, 2010) United States propulsion sys-
16 tems, including liquid fuel engines, external
17 tank or tank-related capability, and solid rocket
18 motor engines; and

19 “(2) associated testing facilities in existence or
20 under construction as of October 11, 2010.

21 “(b) DISCHARGE OF REQUIREMENTS.—In meeting
22 the requirements of subsection (a), the Administrator—

23 “(1) shall, to the extent practicable, utilize
24 ground-based manufacturing capability, ground test-

1 ing activities, launch and operations infrastructure,
2 and workforce expertise;

3 “(2) shall, to the extent practicable, minimize
4 the modification and development of ground infra-
5 structure and maximize the utilization of existing (as
6 of October 11, 2010) software, vehicle, and mission
7 operations processes;

8 “(3) shall complete construction and activation
9 of the A-3 test stand with a completion goal of Sep-
10 tember 30, 2013;

11 “(4) may procure, develop, and flight test appli-
12 cable components; and

13 “(5) shall take appropriate actions to ensure
14 timely and cost-effective development of the Space
15 Launch System and the multipurpose crew vehicle,
16 including the use of a procurement approach that in-
17 corporates adequate and effective oversight, the fa-
18 cilitation of contractor efficiencies, and the stream-
19 lining of contract and procurement requirements.

20 “(c) CONTINUATION OF CONTRACTOR SUPPORT.—

21 The Administrator may not terminate any contract that
22 provides the system transitions necessary for shuttle-de-
23 rived hardware to be used on the Space Launch System
24 described in section 71521 of this title or the multipurpose
25 crew vehicle described in section 71522 of this title.

1 **“§ 71524. Launch support and infrastructure mod-**
2 **ernization program**

3 “(a) IN GENERAL.—The Administrator shall carry
4 out a program the primary purpose of which is to prepare
5 infrastructure at the Kennedy Space Center that is needed
6 to enable processing and launch of the Space Launch Sys-
7 tem. Vehicle interfaces and other ground processing and
8 payload integration areas should be simplified to minimize
9 overall costs, enhance safety, and complement the purpose
10 of this section.

11 “(b) ELEMENTS.—The program required by this sec-
12 tion shall include—

13 “(1) investments to improve civil and national
14 security operations at the Kennedy Space Center, to
15 enhance the overall capabilities of the Center, and to
16 reduce the long-term cost of operations and mainte-
17 nance;

18 “(2) measures to provide multi-vehicle support,
19 improvements in payload processing, and partnering
20 at the Kennedy Space Center; and

21 “(3) other measures that the Administrator
22 considers appropriate, including investments to im-
23 prove launch infrastructure at Administration flight
24 facilities scheduled to launch cargo to the Inter-
25 national Space Station under the program to develop
26 commercial cargo transportation capabilities.

1 **“§ 71525. Development of technologies and in-space**
2 **capabilities for beyond near-Earth space**
3 **missions**

4 “(a) DEVELOPMENT AUTHORIZED.—The Adminis-
5 trator may initiate activities to develop the following:

6 “(1) Technologies identified as necessary ele-
7 ments of missions beyond low-Earth orbit.

8 “(2) In-space capabilities such as refueling and
9 storage technology, orbital transfer stages, innova-
10 tive in-space propulsion technology, communications,
11 and data management that facilitate a broad range
12 of users (including military and commercial).

13 “(3) Applications defining the architecture and
14 design of missions beyond low-Earth orbit.

15 “(4) Spacesuit development and associated life
16 support technology.

17 “(5) Flagship missions.

18 “(b) INVESTMENTS.—In developing technologies and
19 capabilities under subsection (a), the Administrator may
20 make investments in—

21 “(1) space technologies such as advanced pro-
22 pulsion, propellant depots, in situ resource utiliza-
23 tion, and robotic payloads or capabilities that enable
24 human missions beyond low-Earth orbit ultimately
25 leading to Mars;

1 “(2) a space-based transfer vehicle including
2 technologies described in paragraph (1) with an abil-
3 ity to conduct space-based operations that provide
4 capabilities—

5 “(A) to integrate with the Space Launch
6 System and other space-based systems;

7 “(B) to provide opportunities for in-space
8 servicing of and delivery to multiple space-based
9 platforms; and

10 “(C) to facilitate international efforts to
11 expand human presence to deep space destina-
12 tions;

13 “(3) advanced life support technologies and ca-
14 pabilities;

15 “(4) technologies and capabilities relating to in-
16 space power, propulsion, and energy systems;

17 “(5) technologies and capabilities relating to in-
18 space propellant transfer and storage;

19 “(6) technologies and capabilities relating to in
20 situ resource utilization; and

21 “(7) expanded research to understand the
22 greatest biological impediments to human deep space
23 missions, especially the radiation challenge.

24 “(c) UTILIZATION OF INTERNATIONAL SPACE STA-
25 TION AS TESTBED.—The Administrator may utilize the

1 International Space Station as a testbed for any tech-
2 nology or capability developed under subsection (a) in a
3 manner consistent with sections 70908 through 70911 of
4 this title.

5 “(d) COORDINATION.—The Administrator shall co-
6 ordinate development of technologies and capabilities
7 under this section through an overall Administration tech-
8 nology approach consistent with the plan required by sec-
9 tion 905 of the National Aeronautics and Space Adminis-
10 tration Authorization Act of 2010 (Public Law 111–267,
11 124 Stat. 2836), which outlines how the Administration’s
12 space technology program will meet the goal described in
13 section 40903 of this title, including an explanation of how
14 the plan will link to other mission-directorate technology
15 efforts.

16 **“Subchapter IV—SPACE SCIENCE**

17 **“§ 71541. Technology development**

18 “The Administrator shall ensure that the Science
19 Mission Directorate maintains a long-term technology de-
20 velopment program for space and Earth science. That ef-
21 fort should be coordinated with an overall Administration
22 technology investment approach consistent with the plan
23 required by section 905 of the National Aeronautics and
24 Space Administration Authorization Act of 2010 (Public
25 Law 111–267, 124 Stat. 2836), which outlines how the

1 Administration’s space technology program will meet the
2 goal described in section 40903 of this title, including an
3 explanation of how the plan will link to other mission-di-
4 rectorate technology efforts.

5 **“§ 71542. Suborbital research activities**

6 “(a) MANAGEMENT.—The Administrator shall des-
7 ignate an officer or employee of the Science Mission Direc-
8 torate to act as the responsible official for all Suborbital
9 Research in the Science Mission Directorate. The designee
10 shall be responsible for—

11 “(1) the development of short- and long-term
12 strategic plans for maintaining, renewing, and ex-
13 tending suborbital facilities and capabilities;

14 “(2) monitoring progress toward goals in the
15 plans; and

16 “(3) integration of suborbital activities and
17 workforce development within the Administration,
18 thereby ensuring the long-term recognition of their
19 combined value to the Directorate, to the Adminis-
20 tration, and to the Nation.

21 “(b) ESTABLISHMENT OF SUBORBITAL RESEARCH
22 PROGRAM.—The Administrator shall establish a Sub-
23 orbital Research Program within the Science Mission Di-
24 rectorate that shall include the use of sounding rockets,
25 aircraft, high altitude balloons, suborbital reusable launch

1 vehicles, and commercial launch vehicles to advance
2 science and train the next generation of scientists and en-
3 gineers in systems engineering and systems integration,
4 which are vital to maintaining critical skills in the aero-
5 space workforce. The program shall integrate existing (as
6 of October 11, 2010) suborbital research programs with
7 orbital missions at the discretion of the designated officer
8 or employee and shall emphasize the participation of un-
9 dergraduate and graduate students and post-doctoral re-
10 searchers when formulating announcements of oppor-
11 tunity.

12 “(c) ANNUAL REPORT.—The Administrator shall re-
13 port annually to the Committee on Commerce, Science,
14 and Transportation of the Senate and the Committee on
15 Science, Space, and Technology of the House of Rep-
16 resentatives on the number and type of suborbital missions
17 conducted in each fiscal year and the number of under-
18 graduate and graduate students that participated in the
19 missions.

20 **“§ 71543. In-space servicing**

21 “The Administrator shall continue to take all nec-
22 essary steps to ensure that provisions are made for robotic
23 or human in-space servicing and repair of all future ob-
24 servatory-class scientific spacecraft intended to be de-
25 ployed in Earth-orbit or at a Lagrangian point to the ex-

1 tent practicable and appropriate. The Administrator
2 should ensure that Administration investments and future
3 capabilities for space technology, robotics, and human
4 space flight take the ability to service and repair observ-
5 atory-class scientific spacecraft into account, as appro-
6 priate, and incorporate those capabilities into design and
7 operational plans.

8 **“§ 71544. Ongoing restoration of radioisotope thermo-**
9 **electric generator material production**

10 “The Administrator shall, in coordination with the
11 Secretary of Energy, pursue a joint approach beginning
12 in fiscal year 2011 toward restarting and sustaining the
13 domestic production of radioisotope thermoelectric gener-
14 ator material for deep space and other science and explo-
15 ration missions. Funds authorized by the National Aero-
16 nautics and Space Administration Authorization Act of
17 2010 for the Administration shall be made available under
18 a reimbursable agreement with the Department of Energy
19 for the purpose of reestablishing facilities to produce fuel
20 required for radioisotope thermoelectric generators to en-
21 able future missions.

22 **“§ 71545. Coordinated approach for robotic missions**

23 “The Administrator shall ensure that the Exploration
24 Systems Mission Directorate and the Space Operations
25 Mission Directorate coordinate with the Science Mission

1 Directorate on an overall approach and plan for inter-
2 agency and international collaboration on robotic missions
3 that are developed by the Administration or internation-
4 ally developed, including lunar, Lagrangian, near-Earth
5 orbit, and Mars spacecraft, such as the International
6 Lunar Network.

7 **“§ 71546. Near-Earth object survey and policy with**
8 **respect to threats posed**

9 “(a) POLICY REAFFIRMATION.—Congress reaffirms
10 the policy set forth in section 20102(g) of this title relat-
11 ing to surveying near-Earth asteroids and comets.

12 “(b) IMPLEMENTATION.—Consistent with section
13 71103 of this title, the Director of the Office of Science
14 and Technology Policy shall implement, before September
15 30, 2012, a policy for notifying Federal agencies and rel-
16 evant emergency response institutions of an impending
17 near-Earth object threat if near-term public safety is at
18 risk, and assign a Federal agency or agencies to be respon-
19 sible for protecting the United States and working with
20 the international community on such threats.”.

6 “In this chapter:

1 “(1) APPROPRIATE COMMITTEES OF CON-
2 GRESS.—The term ‘appropriate committees of Con-
3 gress’ means—

4 “(A) the Committee on Commerce,
5 Science, and Transportation of the Senate; and

6 “(B) the Committee on Science, Space,
7 and Technology of the House of Representa-
8 tives.

4 **“Part A—ASSURING CORE CAPA-**
5 **BILITIES FOR EXPLORATION**

6 **“§ 71711. Space launch system, Orion, and explo-**
7 **ration ground systems**

8 “(a) REAFFIRMATION.—Congress reaffirms the pol-
9 icy and minimum capability requirements for the Space
10 Launch System under section 71521 of this title.

11 “(b) CONTINUED DEVELOPMENT OF FULLY INTE-
12 GRATED SPACE LAUNCH SYSTEM.—The Administrator
13 shall continue the development of the fully integrated
14 Space Launch System, including an upper stage needed
15 to go beyond low-Earth orbit, in order to safely enable
16 human space exploration of the Moon, Mars, and beyond
17 over the course of the next century as required in section
18 71521(c) of this title.

19 “(c) EXPLORATION MISSIONS.—The Administrator
20 shall continue development of—

21 “(1) an uncrewed exploration mission to dem-
22 onstrate the capability of both the Space Launch
23 System and Orion as an integrated system by 2018;

24 “(2) subject to applicable human rating proc-
25 esses and requirements, a crewed exploration mis-

1 sion to demonstrate the Space Launch System, in-
2 cluding the Core Stage and Exploration Upper
3 Stages, by 2021;

4 “(3) subsequent missions beginning with EM-
5 3 at operational flight rate sufficient to maintain
6 safety and operational readiness using the Space
7 Launch System and Orion to extend into cis-lunar
8 space and eventually to Mars; and

9 “(4) a deep space habitat as a key element in
10 a deep space exploration architecture along with the
11 Space Launch System and Orion.

12 “(d) OTHER USES.—The Administrator shall assess
13 the utility of the Space Launch System for use by the
14 science community and for other Federal Government
15 launch needs, including consideration of overall cost and
16 schedule savings from reduced transit times and increased
17 science returns enabled by the unique capabilities of the
18 Space Launch System.

19 **“Part B—JOURNEY TO MARS**

20 **“§ 71721. Human exploration roadmap**

21 “(a) IN GENERAL.—The Administrator shall develop
22 a human exploration roadmap, including a critical decision
23 plan, to expand human presence beyond low-Earth orbit
24 to the surface of Mars and beyond, considering potential

1 interim destinations such as cis-lunar space and the moons
2 of Mars.

3 “(b) SCOPE.—The human exploration roadmap shall
4 include—

5 “(1) an integrated set of exploration, science,
6 and other goals and objectives of a United States
7 human space exploration program to achieve the
8 long-term goal of human missions near or on the
9 surface of Mars in the 2030s;

10 “(2) opportunities for international, academic,
11 and industry partnerships for exploration-related
12 systems, services, research, and technology if those
13 opportunities provide cost-savings, accelerate pro-
14 gram schedules, or otherwise benefit the goals and
15 objectives developed under paragraph (1);

16 “(3) sets and sequences of precursor missions
17 in cis-lunar space and other missions or activities
18 necessary—

19 “(A) to demonstrate the proficiency of the
20 capabilities and technologies identified under
21 paragraph (4); and

22 “(B) to meet the goals and objectives de-
23 veloped under paragraph (1), including antici-
24 pated timelines and missions for the Space
25 Launch System and Orion;

1 “(4) an identification of the specific capabilities
2 and technologies, including the Space Launch Sys-
3 tem, Orion, a deep space habitat, and other capabili-
4 ties, that facilitate the goals and objectives developed
5 under paragraph (1);

6 “(5) a description of how cis-lunar elements,
7 objectives, and activities advance the human explo-
8 ration of Mars;

9 “(6) an assessment of potential human health
10 and other risks, including radiation exposure;

11 “(7) mitigation plans, whenever possible, to ad-
12 dress the risks identified in paragraph (6);

13 “(8) a description of those technologies already
14 under development across the Federal Government
15 or by other entities that facilitate the goals and ob-
16 jectives developed under paragraph (1);

17 “(9) a specific process for the evolution of the
18 capabilities of the fully integrated Orion with the
19 Space Launch System and a description of how
20 these systems facilitate the goals and objectives de-
21 veloped under paragraph (1) and demonstrate the
22 capabilities and technologies described in paragraph
23 (4);

24 “(10) a description of the capabilities and tech-
25 nologies that need to be demonstrated or research

1 data that could be gained through the utilization of
2 the International Space Station and the status of
3 the development of such capabilities and tech-
4 nologies;

5 “(11) a framework for international cooperation
6 in the development of all capabilities and tech-
7 nologies identified under this section, including an
8 assessment of the risks posed by relying on inter-
9 national partners for capabilities and technologies on
10 the critical path of development;

11 “(12) a process for partnering with nongovern-
12 mental entities using Space Act Agreements or other
13 acquisition instruments for future human space ex-
14 ploration; and

15 “(13) information on the phasing of planned in-
16 termediate destinations, Mars mission risk areas and
17 potential risk mitigation approaches, technology re-
18 quirements and phasing of required technology de-
19 velopment activities, the management strategy to be
20 followed, related International Space Station activi-
21 ties, planned international collaborative activities,
22 potential commercial contributions, and other activi-
23 ties relevant to the achievement of the goal estab-
24 lished in this section.

1 “(c) CONSIDERATIONS.—In developing the human ex-
2 ploration roadmap, the Administrator shall consider—

3 “(1) using key exploration capabilities, namely
4 the Space Launch System and Orion;

5 “(2) using existing commercially available tech-
6 nologies and capabilities or those technologies and
7 capabilities being developed by industry for commer-
8 cial purposes;

9 “(3) establishing an organizational approach to
10 ensure collaboration and coordination among the Ad-
11 ministration’s mission directorates under section
12 71761 of this title, when appropriate, including to
13 collect and return to Earth a sample from the Mar-
14 tian surface;

15 “(4) building upon the initial uncrewed mission,
16 EM–1, and first crewed mission, EM–2, of the
17 Space Launch System and Orion to establish a sus-
18 tainable cadence of missions extending human explo-
19 ration missions into cis-lunar space, including antici-
20 pated timelines and milestones;

21 “(5) developing the robotic and precursor mis-
22 sions and activities that will demonstrate, test, and
23 develop key technologies and capabilities essential
24 for achieving human missions to Mars, including
25 long-duration human operations beyond low-Earth

1 orbit, space suits, solar electric propulsion, deep
2 space habitats, environmental control life support
3 systems, Mars lander and ascent vehicle, entry, de-
4 scent, landing, ascent, Mars surface systems, and in-
5 situ resource utilization;

6 “(6) demonstrating and testing 1 or more habi-
7 tat modules in cis-lunar space to prepare for Mars
8 missions;

9 “(7) using public-private, firm fixed-price part-
10 nerships, where practicable;

11 “(8) collaborating with international, academic,
12 and industry partners, when appropriate;

13 “(9) any risks to human health and sensitive
14 onboard technologies, including radiation exposure;

15 “(10) any risks identified through research out-
16 comes under the Administration Human Research
17 Program’s Behavioral Health Element; and

18 “(11) the recommendations and ideas of several
19 independently developed reports or concepts that de-
20 scribe potential Mars architectures or concepts and
21 identify Mars as the long-term goal for human space
22 exploration, including the reports described under
23 section 431 of the National Aeronautics and Space
24 Administration Transition Authorization Act of
25 2017 (Public Law 115–10, 131 Stat. 38).

1 “(d) CRITICAL DECISION PLAN ON HUMAN SPACE
2 EXPLORATION.—As part of the human exploration road-
3 map, the Administrator shall include a critical decision
4 plan—

5 “(1) identifying and defining key decisions
6 guiding human space exploration priorities and plans
7 that need to be made before June 30, 2020, includ-
8 ing decisions that may guide human space explo-
9 ration capability development, precursor missions,
10 long-term missions, and activities;

11 “(2) defining decisions needed to maximize effi-
12 ciencies and resources for reaching the near-, inter-
13 mediate-, and long-term goals and objectives of
14 human space exploration; and

15 “(3) identifying and defining timelines and
16 milestones for a sustainable cadence of missions be-
17 ginning with EM-3 for the Space Launch System
18 and Orion to extend human exploration from cis-
19 lunar space to the surface of Mars.

20 “(e) REPORTS.—

21 “(1) INITIAL HUMAN EXPLORATION ROAD-
22 MAP.—The Administrator shall submit to the appro-
23 priate committees of Congress—

1 “(A) an initial human exploration road-
2 map, including a critical decision plan, before
3 December 1, 2017; and

4 “(B) an updated human exploration road-
5 map periodically as the Administrator considers
6 necessary but not less than biennially.

7 “(2) CONTENTS.—Each human exploration
8 roadmap under this subsection shall include a de-
9 scription of—

10 “(A) the achievements and goals accom-
11 plished in the process of developing capabilities
12 and technologies described in this section dur-
13 ing the 2-year period prior to the submission of
14 the human exploration roadmap; and

15 “(B) the expected goals and achievements
16 in the following 2-year period.

17 “(3) SUBMISSION WITH BUDGET.—Each human
18 exploration roadmap under this section shall be in-
19 cluded in the budget for that fiscal year transmitted
20 to Congress under section 1105(a) of title 31.

1 **“Subchapter III—ADVANCING**
2 **SPACE SCIENCE**

3 **“§ 71731. Policy on maintaining balanced space**
4 **science portfolio**

5 “It is the policy of the United States to ensure, to
6 the extent practicable, a steady cadence of large, medium,
7 and small science missions.

8 **“§ 71732. Mission priorities for planetary science**

9 “(a) IN GENERAL.—In accordance with the priorities
10 established in the most recent Planetary Science Decadal
11 Survey, the Administrator shall ensure, to the greatest ex-
12 tent practicable, the completion of a balanced set of Dis-
13 covery, New Frontiers, and Flagship missions at the ca-
14 dence recommended by the most recent Planetary Science
15 Decadal Survey.

16 “(b) MISSION PRIORITY ADJUSTMENTS.—Consistent
17 with the set of missions described in subsection (a), and
18 while maintaining the continuity of scientific data and
19 steady development of capabilities and technologies, the
20 Administrator may seek, if necessary, adjustments to mis-
21 sion priorities, schedule, and scope in light of changing
22 budget projections.

23 **“§ 71733. Extrasolar planet exploration strategy**

24 “(a) STRATEGY.—

1 “(1) IN GENERAL.—The Administrator shall
2 enter into an arrangement with the National Acad-
3 emies to develop a science strategy for the study and
4 exploration of extrasolar planets, including the use
5 of the Transiting Exoplanet Survey Satellite, the
6 James Webb Space Telescope, a potential Wide-
7 Field Infrared Survey Telescope mission, or any
8 other telescope, spacecraft, or instrument, as appro-
9 priate.

10 “(2) REQUIREMENTS.—The strategy shall—

11 “(A) outline key scientific questions;

12 “(B) identify the most promising research
13 in the field;

14 “(C) indicate the extent to which the mis-
15 sion priorities in existing decadal surveys ad-
16 dress the key extrasolar planet research and ex-
17 ploration goals;

18 “(D) identify opportunities for coordina-
19 tion with international partners, commercial
20 partners, and not-for-profit partners; and

21 “(E) make recommendations regarding the
22 activities under subparagraphs (A) through
23 (D), as appropriate.

24 “(b) USE OF STRATEGY.—The Administrator shall
25 use the strategy—

1 “(1) to inform roadmaps, strategic plans, and
2 other activities of the Administration as they relate
3 to extrasolar planet research and exploration; and

4 “(2) to provide a foundation for future activi-
5 ties and initiatives related to extrasolar planet re-
6 search and exploration.

7 “(c) REPORT TO CONGRESS.—Not later than 18
8 months after March 21, 2017, the National Academies
9 shall submit to the Administrator and to the appropriate
10 committees of Congress a report containing the strategy
11 developed under subsection (a).

12 **“§ 71734. Astrobiology strategy**

13 “(a) STRATEGY.—

14 “(1) IN GENERAL.—The Administrator shall
15 enter into an arrangement with the National Acad-
16 emies to develop a science strategy for astrobiology
17 that would outline key scientific questions, identify
18 the most promising research in the field, and indi-
19 cate the extent to which the mission priorities in ex-
20 isting decadal surveys address the search for life’s
21 origin, evolution, distribution, and future in the uni-
22 verse.

23 “(2) RECOMMENDATIONS.—The strategy shall
24 include recommendations for coordination with inter-
25 national partners.

1 “(b) USE OF STRATEGY.—The Administrator shall
2 use the strategy developed under subsection (a) in plan-
3 ning and funding research and other activities and initia-
4 tives in the field of astrobiology.

5 “(c) REPORT TO CONGRESS.—Not later than 18
6 months after March 21, 2017, the National Academies
7 shall submit to the Administrator and to the appropriate
8 committees of Congress a report containing the strategy
9 developed under subsection (a).

10 **“§ 71735. Collaboration**

11 “The Administration shall continue to develop first-
12 of-a-kind instruments that, once proved, can be
13 transitioned to other agencies for operations. Whenever re-
14 sponsibilities for the development of sensors or for meas-
15 urements are transferred to the Administration from an-
16 other agency, the Administration shall seek, to the extent
17 possible, to be reimbursed for the assumption of such re-
18 sponsibilities.

19 **“Subchapter IV—SPACE** 20 **TECHNOLOGY**

21 **“§ 71741. Space technology infusion**

22 “(a) POLICY.—It is the policy of the United States
23 that the Administrator shall develop technologies to sup-
24 port the Administration’s core missions, as described in
25 section 2(3) of the National Aeronautics and Space Ad-

1 ministration Authorization Act of 2010 (Public Law 111–
2 267, 124 Stat. 2807), and support sustained investments
3 in early stage innovation, fundamental research, and tech-
4 nologies to expand the boundaries of the national aero-
5 space enterprise.

6 “(b) PROPULSION TECHNOLOGIES.—A goal of pro-
7 pulsion technologies developed under subsection (a) shall
8 be to significantly reduce human travel time to Mars.

9 **“§ 71742. Space technology program**

10 “(a) SPACE TECHNOLOGY PROGRAM AUTHORIZED.—
11 The Administrator shall conduct a space technology pro-
12 gram (referred to in this section as the ‘Program’) to re-
13 search and develop advanced space technologies that could
14 deliver innovative solutions across the Administration’s
15 space exploration and science missions.

16 “(b) CONSIDERATIONS.—In conducting the Program,
17 the Administrator shall consider—

18 “(1) the recommendations of the National
19 Academies’ review of the Administration’s Space
20 Technology roadmaps and priorities; and

21 “(2) the applicable enabling aspects of the step-
22 ping stone approach to exploration under section
23 70504 of this title.

24 “(c) REQUIREMENTS.—In conducting the Program,
25 the Administrator shall—

1 “(1) to the extent practicable, use a competitive
2 process to select research and development projects;

3 “(2) to the extent practicable and appropriate,
4 use small satellites and the Administration’s sub-
5 orbital and ground-based platforms to demonstrate
6 space technology concepts and developments; and

7 “(3) as appropriate, partner with other Federal
8 agencies, universities, private industry, and foreign
9 countries.

10 “(d) SMALL BUSINESS PROGRAMS.—The Adminis-
11 trator shall organize and manage the Administration’s
12 Small Business Innovation Research Program and Small
13 Business Technology Transfer Program within the Pro-
14 gram.

15 “(e) NONDUPLICATION CERTIFICATION.—The Ad-
16 ministrators shall submit a budget for each fiscal year, as
17 transmitted to Congress under section 1105(a) of title 31,
18 that avoids duplication of projects, programs, or missions
19 conducted by the Program with other projects, programs,
20 or missions conducted by another office or directorate of
21 the Administration.

22 “(f) COLLABORATION, COORDINATION, AND ALIGN-
23 MENT.—The Administrator shall—

24 “(1) ensure that the Administration’s projects,
25 programs, and activities in support of technology re-

1 search and development of advanced space tech-
2 nologies are fully coordinated and aligned;

3 “(2) ensure that the results of the projects, pro-
4 grams, and activities under paragraph (1) are
5 shared and leveraged within the Administration; and

6 “(3) ensure that the organizational responsi-
7 bility for research and development activities in sup-
8 port of human space exploration not initiated as of
9 March 21, 2017, is established on the basis of a
10 sound rationale.

11 “(g) ANNUAL REPORT.—The Administrator shall in-
12 clude in the Administration’s annual budget request for
13 each fiscal year the rationale for assigning organizational
14 responsibility for, in the year prior to the budget fiscal
15 year, each initiated project, program, and mission focused
16 on research and development of advanced technologies for
17 human space exploration.

1 **“Subchapter V—MAXIMIZING**
2 **EFFICIENCY**
3 **“Part A—ADMINISTRATION IN-**
4 **FORMATION TECHNOLOGY**
5 **AND CYBERSECURITY**

6 **“§ 71751. Information technology governance**

7 “The Administrator shall, in a manner that reflects
8 the unique nature of the Administration’s mission and ex-
9 pertise—

10 “(1) ensure the Administration Chief Informa-
11 tion Officer, mission directorates, and centers have
12 appropriate roles in the management, governance,
13 and oversight processes related to information tech-
14 nology operations and investments and information
15 security programs for the protection of Administra-
16 tion systems;

17 “(2) ensure the Administration Chief Informa-
18 tion Officer has the appropriate resources and in-
19 sight to oversee Administration information tech-
20 nology and information security operations and in-
21 vestments;

22 “(3) provide an information technology program
23 management framework to increase the efficiency
24 and effectiveness of information technology invest-

1 ments, including relying on metrics for identifying
2 and reducing potential duplication, waste, and cost;

3 “(4) improve the operational linkage between
4 the Administration Chief Information Officer and
5 each Administration mission directorate, center, and
6 mission support office to ensure both Administration
7 and mission needs are considered in Administration-
8 wide information technology and information secu-
9 rity management and oversight;

10 “(5) review the portfolio of information tech-
11 nology investments and spending, including informa-
12 tion technology-related investments included as part
13 of activities within Administration mission direc-
14 torates that may not be considered information tech-
15 nology, to ensure investments are recognized and re-
16 ported appropriately based on guidance from the Of-
17 fice of Management and Budget;

18 “(6) consider appropriate revisions to the char-
19 ters of information technology boards and councils
20 that inform information technology investment and
21 operation decisions; and

22 “(7) consider whether the Administration Chief
23 Information Officer should have a seat on any
24 boards or councils described in paragraph (6).

1 **“§ 71752. Information technology strategic plan**

2 “(a) IN GENERAL.—Subject to subsection (b), the
3 Administrator shall develop an information technology
4 strategic plan to guide Administration information tech-
5 nology management and strategic objectives.

6 “(b) REQUIREMENTS.—In developing the strategic
7 plan, the Administrator shall ensure that the strategic
8 plan addresses—

9 “(1) the deadline under section 306(a) of title
10 5; and

11 “(2) the requirements under section 3506 of
12 title 44.

13 “(c) CONTENTS.—The strategic plan shall address,
14 in a manner that reflects the unique nature of the Admin-
15 istration’s mission and expertise—

16 “(1) near- and long-term goals and objectives
17 for leveraging information technology;

18 “(2) a plan for how the Administration will
19 submit to Congress a list of information technology
20 projects, including completion dates and risk levels
21 in accordance with guidance from the Office of Man-
22 agement and Budget;

23 “(3) an implementation overview for an Admin-
24 istration-wide approach to information technology
25 investments and operations, including reducing bar-
26 riers to cross-center collaboration;

1 “(4) coordination by the Administration Chief
2 Information Officer with centers and mission direc-
3 torates to ensure that information technology poli-
4 cies are effectively and efficiently implemented
5 across the Administration;

6 “(5) a plan to increase the efficiency and effec-
7 tiveness of information technology investments, in-
8 cluding a description of how unnecessarily duplica-
9 tive, wasteful, legacy, or outdated information tech-
10 nology across the Administration will be identified
11 and eliminated, and a schedule for the identification
12 and elimination of such information technology;

13 “(6) a plan for improving the information secu-
14 rity of Administration information and Administra-
15 tion information systems, including improving secu-
16 rity control assessments and role-based security
17 training of employees; and

18 “(7) submission by the Administration to Con-
19 gress of information regarding high risk projects and
20 cybersecurity risks.

21 “(d) CONGRESSIONAL OVERSIGHT.—The Adminis-
22 trator shall submit to the appropriate committees of Con-
23 gress the strategic plan under subsection (a) and any up-
24 dates to the strategic plan.

1 **“§ 71753. Information security plan for cybersecurity**

2 “(a) IN GENERAL.—Not later than 1 year after
3 March 21, 2017, the Administrator shall implement the
4 information security plan developed under subsection (b)
5 and take such further actions as the Administrator con-
6 siders necessary to improve the information security sys-
7 tem in accordance with this section.

8 “(b) INFORMATION SECURITY PLAN.—Subject to
9 subsections (c) and (d), the Administrator shall develop
10 an Administration-wide information security plan to en-
11 hance information security for Administration information
12 and information infrastructure.

13 “(c) REQUIREMENTS.—In developing the plan under
14 subsection (b), the Administrator shall ensure that the
15 plan—

16 “(1) reflects the unique nature of the Adminis-
17 tration’s mission and expertise;

18 “(2) is informed by policies, standards, guide-
19 lines, and directives on information security required
20 for Federal agencies;

21 “(3) is consistent with the standards and guide-
22 lines under section 11331 of title 40; and

23 “(4) meets applicable National Institute of
24 Standards and Technology information security
25 standards and guidelines.

26 “(d) CONTENTS.—The plan shall address—

1 “(1) an overview of the requirements of the in-
2 formation security system;

3 “(2) an Administration-wide risk management
4 framework for information security;

5 “(3) a description of the information security
6 system management controls and common controls
7 that are necessary to ensure compliance with infor-
8 mation security-related requirements;

9 “(4) an identification and assignment of roles,
10 responsibilities, and management commitment for
11 information security at the Administration;

12 “(5) coordination among organizational entities,
13 including between each center, facility, mission di-
14 rectorate, and mission support office, and among
15 Administration entities responsible for different as-
16 pects of information security;

17 “(6) the need to protect the information secu-
18 rity of mission-critical systems and activities and
19 high-impact and moderate-impact information sys-
20 tems; and

21 “(7) a schedule of frequent reviews and up-
22 dates, as necessary, of the plan.

1 **“Part** **B—COLLABORATION**
2 **AMONG** **MISSION** **DIREC-**
3 **TORATES** **AND** **OTHER** **MAT-**
4 **TERS**

5 **“§ 71761. Collaboration among mission directorates**

6 “The Administrator shall encourage an interdiscipli-
7 nary approach among all Administration mission direc-
8 torates and divisions, whenever appropriate, for projects
9 or missions—

10 “(1) to improve coordination, and encourage
11 collaboration and early planning on scope;

12 “(2) to determine areas of overlap or alignment;

13 “(3) to find ways to leverage across divisional
14 perspectives to maximize outcomes; and

15 “(4) to be more efficient with resources and
16 funds.

17 **“§ 71762. Administration launch capabilities collabo-**
18 **ration**

19 “The Administrator shall pursue a strategy for acqui-
20 sition of crewed transportation services and non-crewed
21 launch services that continues to enhance communication,
22 collaboration, and coordination between the Launch Serv-
23 ices Program and the Commercial Crew Program.

1 **“§ 71763. Education and outreach**

2 “The Administrator shall continue engagement with
3 the public and education opportunities for students via all
4 the Administration’s mission directorates to the maximum
5 extent practicable.

6 **“§ 71764. Leveraging commercial satellite servicing**
7 **capabilities across mission directorates**

8 “The Administrator shall—

9 “(1) identify orbital assets in both the Science
10 Mission Directorate and the Human Exploration
11 and Operations Mission Directorate that could ben-
12 efit from satellite servicing-related technologies; and

13 “(2) work across all Administration mission di-
14 rectorates to evaluate opportunities for the private
15 sector to perform such services or advance technical
16 capabilities by leveraging the technologies and tech-
17 niques developed by Administration programs and
18 other industry programs.

19 **“§ 71765. Flight opportunities**

20 “(a) DEVELOPMENT OF PAYLOADS.—

21 “(1) IN GENERAL.—In order to conduct nec-
22 essary research, the Administrator shall continue
23 and, as the Administrator considers appropriate, ex-
24 pand the development of technology payloads for—

25 “(A) scientific research; and

1 “(B) investigating new or improved capa-
2 bilities.

3 “(2) FUNDS.—For the purpose of carrying out
4 paragraph (1), the Administrator shall make funds
5 available for—

6 “(A) flight testing;

7 “(B) payload development; and

8 “(C) hardware related to subparagraphs
9 (A) and (B).

10 “(b) REAFFIRMATION OF POLICY.—Congress reaf-
11 firms that the Administrator should provide flight oppor-
12 tunities for payloads to microgravity environments and
13 suborbital altitudes as authorized by section 40905 of this
14 title.

15 **“§ 71766. Space Act Agreements**

16 “(a) FUNDED SPACE ACT AGREEMENTS.—To the ex-
17 tent appropriate, the Administrator shall seek to maximize
18 the value of contributions provided by other parties under
19 a funded Space Act Agreement in order to advance the
20 Administration’s mission.

21 “(b) NON-EXCLUSIVITY.—

22 “(1) IN GENERAL.—The Administrator shall, to
23 the greatest extent practicable, issue each Space Act
24 Agreement—

1 “(A) except as provided in paragraph (2),
2 on a nonexclusive basis;

3 “(B) in a manner that ensures all non-gov-
4 ernment parties have equal access to Adminis-
5 tration resources; and

6 “(C) exercising reasonable care not to re-
7 veal unique or proprietary information.

8 “(2) EXCLUSIVITY.—If the Administrator de-
9 termines an exclusive arrangement is necessary, the
10 Administrator shall, to the greatest extent prac-
11 ticable, issue the Space Act Agreement—

12 “(A) utilizing a competitive selection proc-
13 ess when exclusive arrangements are necessary;
14 and

15 “(B) pursuant to public announcements
16 when exclusive arrangements are necessary.

17 “(c) TRANSPARENCY.—The Administrator shall pub-
18 licly disclose on the Administration’s website and make
19 available in a searchable format each Space Act Agree-
20 ment, including an estimate of committed Administration
21 resources and the expected benefits to Administration ob-
22 jectives for each agreement, with appropriate redactions
23 for proprietary, sensitive, or classified information, not
24 later than 60 days after such agreement is signed by the
25 parties.

1 “(d) ANNUAL REPORTS.—

2 “(1) REQUIREMENT.—Not later than 90 days
3 after the end of each fiscal year, the Administrator
4 shall submit to the appropriate committees of Con-
5 gress a report on the use of Space Act Agreement
6 authority by the Administration during the previous
7 fiscal year.

8 “(2) CONTENTS.—The report shall include for
9 each Space Act Agreement in effect at the time of
10 the report—

11 “(A) an indication of whether the agree-
12 ment is a reimbursable, non-reimbursable, or
13 funded Space Act Agreement;

14 “(B) a description of—

15 “(i) the subject and terms;

16 “(ii) the parties;

17 “(iii) the responsible—

18 “(I) mission directorate;

19 “(II) center; or

20 “(III) headquarters element;

21 “(iv) the value;

22 “(v) the extent of the cost sharing
23 among Federal Government and non-Fed-
24 eral sources;

25 “(vi) the time period or schedule; and

1 “(vii) all milestones; and

2 “(C) an indication of whether the agree-
3 ment was renewed during the previous fiscal
4 year.

5 “(3) ANTICIPATED AGREEMENTS.—The report
6 shall include a list of all anticipated reimbursable,
7 non-reimbursable, and funded Space Act Agreements
8 for the upcoming fiscal year.

9 “(4) CUMULATIVE PROGRAM BENEFITS.—The
10 report shall include, with respect to each Space Act
11 Agreement covered by the report, a summary of—

12 “(A) the technology areas in which re-
13 search projects were conducted under that
14 agreement;

15 “(B) the extent to which the use of that
16 agreement—

17 “(i) has contributed to a broadening
18 of the technology and industrial base avail-
19 able for meeting Administration needs; and

1 proceedings that were begun before the date of enactment
2 of this Act.
