A BILL

To amend title 31, United States Code, to require the timely production of reports to Congress under the Bank Secrecy Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Timely Delivery of Bank*
 5 *Secrecy Act Reports Act”.*

6 **SEC. 2. TIMELY PRODUCTION OF BANK SECRECY ACT RE-**
 7 **PORTS TO CONGRESS.**

8 *Section 5319 of title 31, United States Code, is amend-*
 9 *ed—*

10 *(1) by striking “The Secretary of the Treasury”*
 11 *and inserting the following:*

12 *“(a) IN GENERAL.—The Secretary of the Treasury”;*
 13 *and*

14 *(2) by adding at the end the following:*

15 *“(b) TIMELY PRODUCTION OF REPORTS TO CON-*
 16 *GRESS.—*

17 *“(1) PRODUCTION BY THE SECRETARY.—Upon*
 18 *the request of the congressional committees or sub-*
 19 *committees of appropriate jurisdiction for any report*
 20 *filed under this subchapter, the Secretary of the*
 21 *Treasury shall deliver the requested report to the com-*
 22 *mittee or subcommittee not later than 30 days after*
 23 *such request is made.*

24 *“(2) PRODUCTION BY A FINANCIAL INSTITUTION*
 25 *PURSUANT TO A SUBPOENA.—Upon subpoena by the*

1 *congressional committees or subcommittees of appro-*
2 *priate jurisdiction, a financial institution shall de-*
3 *liver a report filed under this subchapter by the fi-*
4 *nancial institution, and any information on which*
5 *such report is based, to the committee or subcommittee*
6 *not later than the return date specified for such report*
7 *in the subpoena.”.*
