A BILL

To direct the Secretary of Veterans Affairs and the Comptroller General of the United States to report on certain funding shortfalls in the Department of Veterans Affairs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “VA Budget Shortfall*
5 *Accountability Act”.*

6 **SECTION 2. FUNDING SHORTFALLS IN CERTAIN ADMINIS-**
7 **TRATIONS OF THE DEPARTMENT OF VET-**
8 **ERANS AFFAIRS: REVIEWS; REPORTS.**

9 *(a) FIRST GAO REVIEW.—*

10 *(1) REVIEW REQUIRED.—Not later than 30 days*
11 *after the date of the enactment of this Act, the Comp-*
12 *troller General of the United States shall begin a re-*
13 *view regarding the circumstances surrounding, and*
14 *the causes of—*

15 *(A) the shortfall in the funding of the Vet-*
16 *erans Benefits Administration for fiscal year*
17 *2024; and*

18 *(B) the expected shortfall in the funding of*
19 *the Veterans Health Administration in fiscal*
20 *year 2025.*

21 *(2) ELEMENTS.—The review under this sub-*
22 *section shall include the following elements:*

23 *(A) A comparison of monthly obligations*
24 *and expenditures in relevant accounts against*

1 *the spending plan of the Department of Veterans*
2 *Affairs.*

3 *(B) Any transfers between accounts de-*
4 *scribed in subparagraph (A).*

5 *(C) The reasons for any significant diver-*
6 *sions of obligations or expenditures from such*
7 *spending plan.*

8 *(D) An analysis of the accuracy of any pro-*
9 *jections or estimates relevant to diversions de-*
10 *scribed in subparagraph (C).*

11 *(E) Remedial actions the Secretary of Vet-*
12 *erans Affairs may take—*

13 *(i) to improve the accuracy of sup-*
14 *porting information submitted under sec-*
15 *tion 1105(a) of title 31, United States Code,*
16 *with respect to the Department; and*

17 *(ii) to prevent funding shortfalls for*
18 *the Department.*

19 *(3) REPORT.—Not later than 30 days after com-*
20 *pleting such review, the Comptroller General shall*
21 *submit to the Secretary of Veterans Affairs a written*
22 *report containing the results and findings of such re-*
23 *view.*

24 *(b) SUBSEQUENT GAO REVIEWS.—In each of the five*
25 *calendar years following the date of the enactment of this*

1 *Act, the Comptroller General shall conduct a review includ-*
2 *ing the elements described in subsection (a)(2), and submit*
3 *a report described in subsection (a)(3), regarding the fund-*
4 *ing of the Department of Veterans Affairs for the most re-*
5 *cent fiscal year to end before the date of such review.*

6 *(c) REPORTS OF THE SECRETARY OF VETERANS AF-*
7 *FAIRS.—Not later than 30 days after the Secretary of Vet-*
8 *erans Affairs receives a report of the Comptroller General*
9 *under subsection (a) or (b), the Secretary shall submit such*
10 *report to—*

11 *(1) the Committees on Veterans' Affairs of the*
12 *House of Representatives and the Senate; and*

13 *(2) the Committees on Appropriations of the*
14 *House of Representatives and the Senate.*
