A BILL

To amend title 38, United States Code, to modify the conditions under which the Secretary of Veterans Affairs is required to redevelop the individualized vocational rehabilitation plan for a veteran, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Focused Assistance
 5 and Skills Training for Veterans’ Employment and Tran-
 6 sition Success Act” or the “FAST VETS Act”.

7 **SEC. 2. CONDITIONS UNDER WHICH SECRETARY OF VET-**
 8 **ERANS AFFAIRS SHALL REDEVELOP INDIVID-**
 9 **UALIZED VOCATIONAL REHABILITATION**
 10 **PLAN.**

11 Section 3107 of title 38, United States Code, is
 12 amended in subsection (b)—

13 (1) by striking “The Secretary shall review”
 14 and inserting “(1) The Secretary shall review”;

15 (2) by striking the second sentence; and

16 (3) by adding at the end the following new
 17 paragraph:

18 “(2) On the basis of such review, the Secretary
 19 shall—

20 “(A) redevelop such plan with such veteran if
 21 the Secretary determines the achievement of the
 22 long-range rehabilitation goals for such veteran is—

23 “(i) no longer feasible due to changes in
 24 the employment handicap of the veteran; and

1 “(ii) likelier under a different plan formu-
2 lated under subsection (a); or
3 “(B) disapprove redevelopment of such plan if
4 the Secretary determines such redevelopment is not
5 appropriate.”.
