Enclosed herewith for the Bureau are eight copies and for New Orleans and WFO one copy each of an LHM reflecting proposed travel of captioned subject. (4)

Enclosed LHM is classified "Secret" in view of the sensitive position of [NY 554-S\*], who is the source referred to in the LHM.

It is noted that [NY 554-S\*] also advised that LOSEV contacted the Soviet Consulate, Washington, D. C., and advised that he was travelling by air to New Orleans on 3/13/67, and would return on 3/17/67. He requested a note be sent to the State Department, ASSASSINATION of President

On 3/10/67, [NY 554-S\*] advised that FREEMAN indicated that he and LOSEV would attend the hearings on 3/14 (possibly GARRISON hearing). He indicated that he did not think much of the hearing, but it was an opportunity to see New Orleans inasmuch as he had never been there. (X)
