**Memorandum:**

There was a meeting of the Tampa Branch, National States Rights Party, held at Party headquarters in the Drew Park Section of Tampa on the evening of January 17, 1964. Sixteen persons were in attendance, those known being:

DEWEY TAFT  
ALTON DULLIAN  
MORRIS TAYLOR  
ED PARKER and wife  
Mr. and Mrs. VEASBY  
CHARLES WEAVER  
"CURLY" RAULSON

Two unknown women came with the VEASBYS, and a man and woman (who looked like they were old enough to be his parents) came with WEAVER.

There was a discussion concerning the forthcoming Party meeting to be held at Lakeland on Sunday, the 19th of January, and TAFT indicated that he wanted all who could to attend this meeting.

TAFT also discussed the Party radio program which had been on the air on Monday and Wednesday mornings of the current week. He indicated that, due to lack of funds, the program would have to be discontinued. They way he talked, there would be no more programs in the future, the only two being those on January 13th and 15th. There was a discussion concerning how funds could be raised to keep the program going. VEASBY proposed that each Party member be assessed \$2.00 each week, however TAFT would not agree with
