IMMEDIATELY UPON RECEIPT REBUAIRTEL ALL AGENTS INSTRUCTED TO RECONTACT INFORMANTS ALTHOUGH ON BASIS OF CONTINUOUS CONTACTS WITH ALL INFORMANTS OF OFFICE SUBSEQUENT TO ASSASSINATION, IT APPEARED CERTAIN THEY HAD FURNISHED ALL INFORMATION IN THEIR POSSESSION. MYLET OF APRIL SIX LAST IN INSTANT CASE SET FORTH IDENTITIES OF TWELVE SECURITY INFORMANTS CONTACTED PRIOR TO ASSASSINATION CONCERNING ACTIVITIES OF OSWALD IN MEXICO. BECAUSE OF EXTENSIVE TERRITORIES INVOLVED AND UNAVAILABILITY OF SOME INFORMANTS FOR IMMEDIATE, UNSCHEDULED CONTACT, SURVEY HAS NOT BEEN COMPLETED BUT THREE THREE KEY INFORMANTS CONTACTED HAVE REPORTED THEY HAVE NO INFORMATION NOT PREVIOUSLY REPORTED CONCERNING SUBJECT. INFORMATION ALREADY REPORTED RELATED TO COMMENTS AND REACTIONS TO ASSASSINATION WITHIN ACGM AS REPORTED BY [MEX DASH ONE EIGHT] AND [MEX DASH ONE NINE] AND CONSIDERABLE DATA OBTAINED BY INVESTIGATIVE INFORMANTS IN RESPONSE TO SPECIFIC LEADS.
