In connection with the forthcoming Federal grand jury inquiry at Chicago into the activities of Giancana and other racket figures, our Chicago Office, at the request of the United States Attorney, has served subpoenas on several individuals. Among those served to date is [redacted] a [redacted] the notorious leader of the Chicago underworld. [redacted] is employed in the office of Congressman Frank Annunzio, Seventh District of Illinois, and information has come to light indicating that [redacted] has a close relationship with Giancana and other members of the Chicago racket group.

It has been reported that Tisci claims to have an invitation to the White House on May 27, 1965, and that he intends to express his displeasure at that time because of the fact that he has received a grand jury subpoena in this matter.

Information has also been received indicating Giancana has retained Washington, D. C., Attorney Edward Bennett Williams to represent him in connection with the grand jury proceedings. Information has been developed within the Chicago underworld circles to the effect that Giancana has claimed to his associates that Williams has influence in the Justice Department.

The White House is being furnished with information concerning the matter involving Tisci, and this is being brought to your attention as a matter of interest in connection with developments in Chicago.

SERVED WITH SUBPOENAS THIS DATE. ENGLISH ACCEPTED SERVICE AFTER 14 BLOCK CHASE. [REDACTED] HIGHLY TRATE OVER SERVICE AND STATED "THEY WILL HEAR ABOUT THIS." CLAIMS HIS POSITION AS [REDACTED] TO U.S. CONGRESSMAN DESERVED BETTER TREATMENT. STATED THAT USA HANRAHAN MERELY NEEDED TO MAKE PHONE REQUESTING [REDACTED] APPEARANCE. [REDACTED] ADVISED HE HAS "INVITATION TO THE WHITE HOUSE" ON MAY 27 NEXT AND INTENDS TELLING PRESIDENT HIS THOUGHTS ON THIS SITUATION.

REACTION FROM HIGHLY CONFIDENTIAL SOURCE INDICATES SERVICE OF TODAYS SUBPOENAS ON [REDACTED] AND [REDACTED] FURTHER CONFUSED GIANCANA FACTION AS TO PURPOSE OF GOVERNMENT. UNABLE TO UNDERSTAND WHY PAT MARCY AND JOHN D'ARCO NOT SUBPOENAED. FEELING BEING GENERATED GOVERNMENT MIGHT HAVE SOMETHING WORTH WHILE AND INITIAL REACTION OF BEING "FISHING EXPEDITION" AS THEY WERE ADVISED BY CHICAGO SUN TIMES REPORTER ART BETAQUE WEARING OFF.

INFORMATION RECEIVED MAY 11 LAST GIANCANA RETAINED EDWARD BENNETT WILLIAMS TO REPRESENT HIM THIS MATTER. CG 6792-PC ADVISED GIANCANA PLACED CALL MAY 11 LAST TO WASHINGTON DC TO WILLIAMS FOR PURPOSE OF HAVING SUBPOENA FOR PHYLLIS MC GUIRE "KILLED." INFORMANT NOT CERTAIN WHETHER GIANCANA ACTUALLY KNOWS SUCH SUBPOENA OUTSTANDING OR MERELY SPECULATING.
